

## TIME WELL-SPENT AT ANNUAL MEETING

The National Board was greeted in Joliet with warm sunshine and the absence of snow on March 20th. This was really a joyful preview of spring for those of us from Michigan and Minnesota. I will be impatiently waiting for our three ft. high banks of snow to melt away with the warm temps expected here. I trimmed the house for Easter but we sure couldn't wear our "Spring outfits" as it snowed more than an inch on Sunday morning! It's pleasant to think that we will finally be enjoying our warm weather by the time this (May-June) issue is distributed.

One of the most gratifying hours on our National Board agenda is the one spent with our First Midwest Trust representatives Ronald J. Erjavec and Joy Gruber. The complicated and extensive annual report of our SWU financial portfolio is presented with detailed, professional and yet understandable plain-talk. Many questions were asked by our SWU financial officers and plans set forth for the coming fiscal year. Ron didn't have time to have a cup of coffee with us, but treated the Board to a catered lunch, sent in to the meeting room to save us the time for more important discussions.

A nine hour session on Friday and a twelve hour marathon on Saturday were required to complete our business agenda. Reports from every officer were discussed in detail, and most concerns were solved with democratic fairness. The National Officers were introduced to the two new appointees, Mary Turvey, Scholarship Director and Marion Bowers, Cook-book and Food Column Editor, Corinne Leskovar, Heritage Director Irene Odorizzi and Women's Activities Director Kathleen Emerson will provide interesting reading for all our members. These five officers have displayed remarkable dedication to their appointed positions and will continue to be an invaluable source of inspiration to the whole Board and to all of our SWU members.

According to the State of Illinois Dept. of Insurance, the SWU By-laws and financial records must be audited by their examining officers every three or four years. This job was in progress at the Home Office on March 17–20. Illinois Insurance Regulator, Robert Burke was also in attendance at our Board meeting, along with the two (female) auditors to explain their progress and suggest certain revisions in our bookkeeping procedures along with corrections and suggestions concerning our operations. SWU is required to be in compliance with these directives.

National Secretary Evelyn Majercik reported on the completion of the Direct Billing System. Much also been accomplished since this new procedure was implemented in 1996. The Board is in total agreement with, and 100% supportive of the positive improvements introduced to this point. We were also made aware of the criticism and doubts expressed by a few members. I believe we will look back on this difficult transitional period as being a major improvement in the way our SWU business is conducted.

As your National President I feel that the greatest accomplishment that can be achieved in the next two years would be to strengthen the sisterly ties within the local branches, open up the lines of communication between the Board and all the branch membership and re-affirm our mutual purpose and goals so that our new younger members will seek our guidance, learn from our good example and continue to share in our love of things "Slovenian."

We hope you will read the meeting reports, informative editorials and educational articles written for our ZARJA magazine by the dedicated and capable members of the National Board of Officers who stand ready to be of service in this Grand Accomplishment.

The Department of Insurance, State of Illinois, the organization that is our governing body in respect to what we do with the monies we collect, conducted their audit/examination of the records for the years 1991–1996. This meant gathering together a great deal of information regarding all aspects of Slovenian Women's Union. The process is complete and we will now await their report of findings.

Also in March, the annual meeting of the Board of Directors was held in Joliet. This meant another report that would have to be compiled to advise those present of our financial picture, the status of our membership and how to prepare for the future.

I tell you all this so you will understand why you have not as yet received your invoice for 1997. Hang in there, it will arrive. Look at it this way, it is money you don't have to part with immediately.

We find that there are members in a separate category from the rest of us. These are members who, within themselves, know that they either have not paid any dues for a long period of time, and still receive ZARJA. Or, an aged member of the family did belong, they have now moved on to the better life, and ZARJA is still being delivered--with no SWU member in the household. We need your cooperation to clear up this "driftwood". Please, if someone in your home is not a paying member of SWU, ZARJA should not be delivered to you. We ask that you search your own conscience, own up to the fact that it is a mistake, write to the Editor, Corinne Leskovar at the address inside the cover of the magazine and ask that the name be removed from the mailing list. ZARJA is the most costly venture we have; anyway we can cut down the cost is important to us.

Many items of concern were discussed at the Board Meeting, and shortly you will find all the reports and the minutes of the meeting in an issue of ZARJA. Take time to read each page carefully. This is your organization and discussions and decisions should be important to you.

A statistic that you might be interested in is that we have 431 certificates issued to members over the age of 85. This alone should tell you where we stand with our membership. Likewise, there are 701 members under the age of 20, 126 of whom are under the age of 6. It will be years before that group can be active members, i.e. officers etc., if they in fact remain with SWU. With these thoughts in mind, we should all be aware of what we can do to keep our organization alive. First, new members that can help us, those between the ages of 25-45, to carry the torch, so to speak, into the next century. Next, for those members already in that age group, try to promote interest and participation in the branches. New blood, a shot in the arm, a fresh outlook, call it what you want, we need their efforts, their strength and their new ideas to assist us.

## Slovenski majnik

Pri nas so nekoč za prvi maj poznali podobne šege kot drugod. Nekaj jih je še ostalo. Poleg tega so na majski dan izzvanjali tudi nekateri ostanki šeg, povezanih z jurjevskimi navadami. Prvi maj je nekoč pripadal poleg Florijanu najbrž najpriljubljenejšima kmečkima svetnikoma Filipu in Jakobu (zdaj godujeta 11. maja). V zvezi z njima imamo ohranjenih veliko rekel in šeg, povezanih z vremenom in kmečkimi opravili. Sv. Filip in Jakob sta bila s Florijanom svetniška trojica, ki so jim včasih rekli 'kmečki trjaci'. Ker so poznali kmetove težave, naj bi bili njegovi pomočniki in rešitelji, ki so mu v stiskah in drugače prinašali blagoslov in srečo.

Najpomembnejše pa je bilo splošno razširjeno postavljanje *prvomajskega mlaja*. Na Slovenskem so za prvi maj postavljali smreke, breze, topole in bore. Smrekov mlaj je imel navadno na vrhu bunko in zastavo, pod smrekovino na vrhu pa na deblo pritrjene vence, spletene iz cvetja in zelenja. Deblo je bilo ovito z bršljanom. Na spodnjem koncu pa so pogosto pritrdili veliko cvetno srce, kjer je bil tudi napis, na primer:

Pozdravljena kraljica majnika. Na Primorskem so obesili na mlaj tudi do štiristo kilogramov pomaranč in limon ter pisane trakove. Vasi so med seboj tekmovale, katera bo imela lepši mlaj. Zato so fantje ves mesec maj stražili noč in dan drevo, da ga ne bi ukradli. Ko so ga podrli, so ga prodali, izkupiček pa zajedli in zapili.

Prvi maj je tudi prvi dan šmarnic, globokih verskih čaščeni Marije. Šmarnice so vsakodnevna majniška večerna pobožnost v čast Marije in knjige s potrebnimi premišljevanji. Ime za oboje je ustvaril J. Volčič leta 1855. Vendar so šmarnice obhajali že nekaj prej. Prve so bile v Ljubljani v bogoslovnem semenišču leta 1851. Pobožnost pa se je kmalu razširila po drugih zavodih in župnijah, tudi zunaj Ljubljane. Prvo knjigo šmarničnih beril je izdal že leta 1842 Davorin Trstenjak (Mesec Marije ali častenje presvete Device Marije skozi cel mesec z vsakdanjimi molitvami in zgledi iz življenja svetnikov). Pobožnost, ki so jo začeli imenovati po majniških cvetlicah, šmarnicah, s katerimi so bile vedno okinčene vse naše cerkve in kapelice, so kmalu začeli opravljati tudi zunaj cerkve - na vasi, pri kapelicah in znamenjih. Besede šmarnice, šmarno, šmaren se seveda prepletajo; gre za okrajšavo iz imena sv. Marije.

## Slovenian May


One of the most important traditions on the first day of May is when the boys of the village erect a "mlaj" – as a symbol of the arrival of spring! A mlaj looks like a tall (very tall) pole topped with an evergreen, a poplar, a birch or pine tree. The crown of the mlaj is the original tree from which all bark was stripped, all the way down. The taller the mlaj, the more special it is!

Decorating the top are wreaths of greens, and usually, a flag. Sometimes the tree was also decorated all the way down with winding ivy branches. At the bottom, a large floral piece – perhaps in a heart-shape – could be fastened and the words: Greetings, Queen of May!

In the region of Primorska, they would attach 400 kilograms of fresh oranges and lemons along with colored ribbons at the top. Every village would compete for the most beautiful mlaj – so that it often had to be guarded at night to preserve it from neighboring "thieves"! When the first of May was over, the boys would take it down and enjoy the profit from selling off the fruit – naturally it was spent in boistrous partying.

The first of May is also symbolic of the special prayer hour called "Šmarnice" in honor of St. Mary (Marija) begun in the year 1851 by seminarians in Ljubljana and later, in 1855, named by J. Volcic as a diminutive way of saying the Blessed Mother's name. Smarnice are also the tiny, fragrant flowers of May, the lillies of the valley, and since all the fields are usually covered with them by May 1st, and they are used to decorate altars of the Blessed Mother in church and outside at little wayside chapels, it became a popular tradition in churches and schools all over Slovenia, to refer to the prayer hour as Smarnice! In other countries where Slovenians live, it is a beloved practice to spend an hour in church on Sunday afternoons in May, at Smarnice!

Lillies of the Valley are popular flowers symbolizing May in other countries, too. For instance, in France it's the Parisian thing give bouquets of them. It wasn't until the 18th century that Italy became a follower of this tradition, connecting it to May devotions.

## Slovenian Potpourri

The idea of making potpourri was the result of our Mother's Day celebration last year in Washington, D.C. when I brought various plants to sell to boost our Br. 103 Treasury. The following Slovenian favorites were offered for sale: red carnation plants (nagelji rdeče), rosemary (rožmarin), scented geraniums (roženkraut) tarragon (pehtan), and elderberry (bezek). Then as fall apporoached I decided to make potpourri from my "Slovenian garden" plants. I called my potpourri "Slovenian" because many of the ingredients were of special significance to Slovenians.

The prime ingredient was roženkraut (scented geranium) since I had 3 plants. After carefully drying everything I combined blossoms from my (red) carnation bouquet from our Mother of the Year party, also rose petals from birthday bouquets, rosemary and, on and on. My imagination soared. Dried strawflowers from a bouquet that cousin Tončka gave me when I left Ljubljana was added as well as a bit of dried tarragon that my friend Nika Kovačič said was one of her favorite Slovenian herbs from early childhood. A neighbor contributed wonderful "filler flowers" and dried berries as well as the rose geranium oil. It was both a pleasurable and sentimental undertaking that culminated when I gave the potpourri as surprise gifts to SWU Branch members at our Christmas meeting.

Hopefully you can imagine how this could be the focus of a Branch project. Gardeners could contribute their dried bounty, while others could add items from commemorative bouquets. Attractive glass or crystal containers could be collected, muslin or lace bags or fabric squares could be made, assembled, filled, then tied with fancy ribbons for sachets. This is definitely a project that could involve everyone. We are always looking for items to sell at our various functions. This would be a good one to try.

If you would like to try your hand at making potpourri, here are some tips:

Gathering: Leaves and flowers should be fresh and unblemished. Preferably, flowers should be cut just after opening. Remove any blemished or browned petals and avoid flowers that have been sprayed with chemicals.

Drying: Hang long-stemmed herbs and flowers tied in small bunches upside down in a dimly lit area with enough space between bunches for ample air circulation. To dry flower heads, buds, petals, or leaves individually, use a flatly set window screen, or netting spread over a wooden frame, or a drying rack. Drying time varies depending on moisture within the plant and the humidity. Silica gel can

also be used to speed the drying process. Use gel for flowers and leaves you wish to add for color. Some, like blue bachelor buttons, blue veronica, and zinnias tend to lose their color when air dried. Follow instructions noted on the packaging. Silica gel is reusable.

**Fixatives:** These are the stabilizing ingredients in potpourri. The most popular one used today is orris root, a derivative of the florentine iris. Others include oakmoss, benzoin and vetiver. Sources listed below sell and ship fixatives and many will also send free catalogues.

Essential oil: "The flowers, spices, herbs, and fixatives may all contribute to the blend but ... essential oil is what dominates ... Oils are often available in natural or synthetic form. All vary in quality and strength. When buying synthetics buy the best quality, also be aware that some of the natural oils are not overly priced" (\$2.95 for many of the common types). Eau de colognes are not recommended since the alcohol they contain evaporates quickly and with it, the scent. Try just a few of the natural oils and soon you'll know what most appeals to you. Check the sources listed below to purchase oils." (Quote from "The Scented Room" by Barbara Milo

**Experiment and Personalize:** If you're making potpourri as a Branch project, involving enthusiastic members will surely follow. Collecting appropriate items from SWU and family celebrations such as flowers from your Mother of the Year celebration can serve as a starting point. Roses, other flowers, buds, and herbs can be harvested from members' gardens. Others can collect attractive containers, sew or cut fabric for sachets, and etc. Some may choose to donate ribbons for jars and sachets.

**Recipes:** Here are two a suggested recipes to get you started. I've highlighted the "Slovenian plants" that our mothers and grandmothers found so indispensable in making their own potpourris. Try these or create your own. Good luck and have fun.

## #1 BEGINNERS LUCK POTPOURRI:

Collect the following botanicals: Leaves from the roženkraut plant called pelargonium graveolens/old fashioned rose scented geranium, red clove scented carnations, called nagelji rdeče in Slovenian, yellow yarrow flowers, tiger lilies, black-eyed Susans, strawflowers, calendulas and tansy blossoms, rose buds, etc. Dry each group separately in a dimly lit protected area. When dry store separately in glass or ceramic containers until ready to combine.

Combine and mix by hand in a large ceramic or glass bowl all of the above in proportions that you find are pleasing to the eye. Stabilize and enhance the aroma by adding a few drops of your favorite essential oils (rose, rose geranium, lemon, or etc.). Add 1 teaspoon of fragrance fixative such as ground orris root for every 2 cups of dried materials. Gently mix by hand, cover for 4 to 6 weeks while fragrances blend. Stir intermittently with a wooded spoon or by hand. After potpourri matures, carefully tip potpourri into glass or ceramic containers that have lids so potpourri can be preserved until ready for use.

## #II IN REMEMBRANCE OF SLOVENIA

Collect plant materials at their peak. Dry them separately in groups according to species in a shaded protected area. Store in glass or ceramic containers. Allow about 1/3

shrinkage loss from drying. All of the items below should be completely dried before you begin. If items are not thoroughly dried mold will form in the potpourri! Place the following in a large glass punch bowl or a ceramic container:

- 6 cups scented rose geranium leaves pelargonium graveolens (roženkraut)
- 5 cups of rose petals
- 2 cups of red clove scented carnation petals (nagelji rdeče)
- 2 cups of lemon verbena leaves or lemon scented pelargonium (roženkraut)
- 2 cups lavender flowers
- 1-1/4 cups rosemary flowers & leaves (rožmarin)
- 1-1/4 cups sweet marjoram flowers & leaves
- 1/2 cup peppermint scented pelargonium leaves (roženkraut)
- 2 or 3 cups mixed flowers for filler such as rose buds, hyssop, violets, salvia, etc.

Mix gently with your hands then add:

- 2 oz. chopped orris root
- 2 tablespoons powdered orris root

1/2 vanilla pod chopped in the thirds

- 1 oz. dried tangerine peel
- 2 broken bay leaves
- 8 cloves
- 1 tablespoon chopped dried ginger
- 1 teaspoon grated nutmeg
- 3 in. stick of cinnamon broken into sections
- 1 teaspoon crushed allspice berries
- 1 teaspoon crushed corriander
  - a few drops of oil or rosemary

Store covered in a dark place for 6 weeeks stirring every few days with a wooden spoon or by hand. After potpourri has cured, tip into potpourri jars and top with tight fitting lids. \* Faded potpourri can be refreshed by adding a few drops of oil, then stirried, and covered to blend fragrances.

## Bicentennial of the Birth of Bishop Baraga

St. Elizabeth Ghurch, Duluth, Minnesota Sunday, June 29, at 11 a.m. — Diocesan Mass

With this letter I wish to inform your organization in advance that on Sunday, June 29, 1997, we will be celebrating the bicentennial of the birth of Bishop Baraga. He was born on June 29, 1797 in Carniola, Austria, (Slovenia) and arrived in this country as a missionary priest on the last day of the year 1830. While most of his missionary endeavor was involved in the State of Michigan, the states of Wisconsin and Minnesota were also fortunate to be recipients of his missionary spirit. While Catholic dioceses in Michigan and Wisconsin will be celebrating the bicentennial, the Diocese of Duluth has set Sunday, June 29, for the celebration with a Mass scheduled at 11:00 a.m. at St. Elizabeth's Church, 160 99th Avenue W., Duluth. The Mass will be followed by an outdoor picnic. The committee in charge of the event is in the process of involving as many people as possible of Slovenian and Croatian extraction from the parishes of the diocese as well as Native Americans to whose ancestors he ministered.

On the afternoon of the Mass there will also be the opening of a Baraga display at the Duluth Depot to which all who attend the Mass are invited with free admission.

The Diocese of Duluth is celebrating the bicentennial because of the presence of Baraga as a missionary in the diocese at Fond-du-lac (then located within the confines of St. Elizabeth Parish, Duluth); his presence at Grand Portage; and the memorial cross at Schroeder, Minnesota, recalling the rescue of himself and his guide from a Lake Superior storm in 1846. The cross at Schroeder was erected in September, 1932, under the sponsorship of the Diocesan Council of Catholic Women.

While these are all compelling reasons to celebrate, it must be further noted that he left his imprint on the Duluth Diocese with the presence of Fr. Francis Pierz (Fond-du-lac and Grand Portage), Fr. Otto Skolla (Fond-du-lac), Fr. John Chebul (city of Duluth), and Monsignor Buh (diocesanwise). Monsignor Buh's name is a household word in many parts of the diocese since he founded many of the parishes in the diocese. These priests were brought to America through the influence of Bishop Baraga.

I hope that through your efforts an awareness of Bishop Baraga will be brought to many and that through your efforts many from your local parishes will attend the diocesan celebration.

Thank you for bringing this matter to the attention of your group, and you will later have the opportunity to cooperate with your local parish in promoting the diocesan celebration.

In recent years, it has become ubiquitous on restaurant menus in Slovenia. Cevapcici can be made with lamb or a combination of 1/2 lamb and 1/2 pork, beef or veal. Onions, garlic and sweet paprika can be added. Some people add an egg as "glue". For help with this recipe, a thanks to Janie Armstrong, former Vice-president of Consumer Affairs for Jewel Food Stores, who headed up a 1981 food tour in Europe which included Slovenia.

### CEVAPCICI

2# lamb (or a combination listed above), finely ground twice
1 cup very finely minced onions, 1 beaten egg, both optional
2 cloves minced garlic, 1 Tbsp. sweet paprika, both optional
2 tsp. salt + 1 tsp. coarse freshly milled pepper, or both to taste
2 Tbsp. olive oil or salad oil

Mix all except oil very well. Roll into sausages 3/4" in diameter and 1/2" long. Place on a large dish and brush with oil so they won't stick to the grill. Grill as for hamburgers, turning often until done. Note: The meat is ground twice and all is mixed very well so they won't fall apart. Accompaniments: Minced raw sweet onions, sliced garden ripe tomatoes, green, red and yellow pepper strips, grilled corn or other grilled vegetables, good crusty bread and lemonade, beer or Zinfandel wine - and, of course, a nice prayer. Serves 6 regular or 4 hungry.

Pat Shusterich, Branch #20, writes, "It occurred to me that your Zarja readers might like to have a really good recipe for pot roast. As simple as it is, I've been serving it for years and it's always a delicious winner!"

### SIMPLE POT ROAST

3# bottom round or rump roast 1 large onion, chopped Whole clove of garlic 1 bay leaf 12 oz. can V-8 vegetable juice 3 to 5 whole peppercorns 2 1/2 tsp. salt, or to taste Cornstarch and cold water, see below

Brown meat well in its own fat. Remove meat and discard fat from pan. Return meat to pan with the rest of ingredients, except cornstarch. Simmer slowly until meat is tender. Remove bay leaf and garlic. If desired, thicken resulting gravy with 1 Tbsp. cornstarch mixed with 2 Tbsp. cold water for each cup of gravy. Best (tastier) if refrigerated overnight and served the following day. Serves 6-8.

This cookie recipe (with a fun name!) is from Jerry Lawton, Colfax, Washington

## **BUFFALO CHIP COOKIES**

1 C. butter or oleo 2 C. flour 1 C. oatmeal
1 C. brown sugar 1 tsp. salt 1 C. peanut butter chips
1 C. sugar 1 tsp. baking soda 11/4 C. chocolate chips
2 eggs 1 tsp baking powder 3/4 C. shredded coconut
1 tsp. vanilla 1 C. cornflakes 1 C. chopped walnuts

Preheat oven to 350°. Cream butter until light. Add sugars slowly and cream further. Blend in eggs and vanilla. Combine flour, salt, baking soda, baking powder. Mix well with butter mixture. Combine other 6 ingredients (cornflakes etc.), then mix thoroughly with dough. Make 18 medium hamburger-sized patties 3/4 inch thick. Space 6 on 3 14"x16" cookie sheets. They enlarge to 5" diameter. Bake 12 to 15 minutes until light golden brown. Makes 18 cookies. Option: Instead of large, small cookies can be made. Makes about 6 dozen.



There were many ladies from Branch 2 that served on the SWU National Board.

Julia Gottlieb was the first National Secretary and served one term from 1929 to 1933.

**Josephine Racic** served as National Secretary from 1933 – 39.

Matilda Duller served as first National Treasurer from 1929 – 33.

Katie Triller was a National Auditor from 1952–56. She later organized Branch 16 in So. Chicago, IL.

Pauline Ozbolt served as National Auditor from 1943–46. She actively enrolled 164 members until 1983; 135 were adults and 29 juniors.

Fanika Humar, National Secretary from 1970–76. Her name is on the Membership Honor Roll of 1983 having enrolled 156 members: 97 adults and 59 juniors.

Fani Jazbec was the first president of Br. 2 and the first auditor of Slovenian Women's Union, a book entitled, "Ameriška Slovenka", the precursor of ZARJA—The Dawn.

Helen Zakrajsek was the first Youth Committee member in 1929, and thru her efforts 10 young girls were enrolled as members of the newly formed Juvenile Department of SWU.

Agnes (Nežka) Gaber was Vice President from 1976–1979.

Ann Vucko was State President of Illinois-Indiana 1976–1979.

**Lillian Kozek** served as the chairman of the Youth Committee from 1939–1943 and again in 1952. During her tenure she enrolled 46 adult members and 28 juniors.

Very active member who cannot be forgotten in this history is **Helen Yurcich** who was a member in the earlier years before she transferred to Minnesota Branch 31. She enrolled 79 members.

Other national Board members are found under the title "notable members."

## Mary Papesh Tomazin (1901 - 1985)

Mary Papesh Tomazin served as National Treasurer from 1933-39 and National Auditor from 1939-43. She was also very active from the early years of the branch, serving as Branch 2 Treasurer for 55 years from 1930 to 1985, when she became ill and felt that she could no longer perform the duties of that office.

The membership Honor Roll of 1976, indicates that Mary enrolled 180 members into the SWU up to that year; 149 were adults and 31 were juniors. She won the Branch 2 membership award many times since she secured the most members.

Mary and her husband, Tony, were business people and operated Tomazin's Tavern and Grill on Cermak Road. Many of the early dinner-dances were held at Tomazin's Tavern and she was famous for her "chicken dinners."



On one occasion, many years ago, the Branch ordered 50 chicken dinners for the branch members who worked in the hat industry. (Many of our Chicago members immigrated from Domžale, a town in Slovenia known for their straw hat industry. In Chicago they went right into the factories where they worked for years and years.) So, Mary prepared the dinners and waited for the guests to arrive; was she sur-

prised when everyone showed up and shouted surprise! It was actually a tribute to her in appreciation for her work for others. ally a tribute to her in appreciation for her work for others.

After dinner, Mary Kovacic and her bakers came in with potica, strudel and flancati. A band arrived and the bowlers and young men enjoyed the dancing which followed.

Mary had a lovely family of which she was very proud. Her son, Edward, was in service during the WW II years and this prompted her to take action. As chairman, she enlisted people to work for the Red Cross and collected needed items for the poor people of Slovenia. A Jugoslav Relief Fund dinner-dance was also sponsored and held at Tomazin's Tayern.

The Tomazin's had five sons and a daughter. Their 25th Wedding Anniversary was held on Oct. 25, 1948 at St. Stephen's Hall with members, the Choral Group, friends and family in attendance. Everyone had such a good time that the party lasted until 3 a.m.

It is because of the dedication of Mary Tomazin and many ladies like her, that Branch 2 became one of the largest branches in the Union.

## Josephine Gregorich Zeleznikar (1900 – 1970)

Josephine Zeleznikar served as National Auditor from 1946 to 1952 and then was elected National Treasurer from 1952 to 70. She was elected President of Branch 2 from 1941–1970 and was instrumental in starting the Choral Club in 1941.



Like many, many other dedicated officers, Josephine encouraged all the members of her family to participate in Zveza events. Husband, John, was helpful in setting up all the picnics and transporting members back and forth – later, in 1952, his invaluable assistance was needed to establish the "new" home office in Chicago on Cermak Road. J-Z's daughter, Sophie Bogolin was a marvelous recorder of finances

and events for the branch and SWU.

The Membership Honor Roll of 1983 shows that "J–Z" enrolled 92 adults and 105 juniors for a total of 197 members.

## Elizabeth Škrjanc Zefran (1912 - 1987)

Liz served as National Treasurer from 1970-74 and also as National Director of Women's Activities. She was the organizer of the Sports' Club and served as Treasurer for many years.

Branch 2 was very fortunate to have such a dedicated and generous member as Elizabeth "Liz" Zefran. She was not only dedicated to the Slovenian Women's Union but also to St. Stephen's Church, the Altar Society and the Ladies' Guild.



Liz was the promoter and hardworking supporter of the bowling league among other activities. She was very involved in the penny social to raise funds for the children's Christmas party and did all the purchasing of gifts. Liz was the backbone of the Sports Club and was instrumental in fund-raising for the bowlers to attend the bowling tournaments.

No matter what the cause, Liz was always there to suipport it both in time and financially. Her

home was always open for meetings and projects. The entire Zefran family was generous to St. Stephen's and to the organizations connected with the parish. The children and grandchildren follow in the footsteps of Liz and Louis Zefran both of whom were held in highest esteem by the Slovenian community.

Shirley Melissa, former president of Branch 2, states, "I became a member in 1952, when Liz signed me up, and then had me join the bowling league. I know there were many dedicated people who formed the branch and were hard-working, but they were before my time. I am proud to have been asked to write about Liz because I was closely associated with her not only in the SWU, but in other organizations. I can say that her dedication was outstanding. It was because of Liz that I took the presidency of the branch and tried to uphold the precepts of the SWU."

Many people speak highly of Liz Zefran and she will be remembered for her dedication to the Slovenian Women's Union and to the Slovenian community in Chicago.

## Lillian (Pavlin) Putzell (1920 - 1993)

Her mother, Julia Pavlin was a member of Br. 2 for many years. Lil was very active with Zveza – she was the National Women's Activity Director, Treasurer of Br. 2, Sec. of the Sports Club, Sec. of Br. 2 Bowling League, Sec. of the Midwest Bowling Tournaments. She worked with Liz Zefran for the children's activity at the Zveza picnic. During her years as a member she was very energetic and helped in all projects of the branch.

## Mary Tomažič Muller

served two terms as National President from 1979 when the SWU Home Office moved into their new home in Joliet, Illinois, until 1987. She was also an officer of Branch 2 for many years and worked in the Chicago Home Office.

Mary was asked about her participation as officer of the SWU and she wrote, "Many happy thoughts go through my mind as I recall incidents as an officer and active member. I was fortunate to met many of our members far and wide across the USA. They were happy times because we all worked for the same good sisterhood.

"Our world is changing, as are the people in it; but we still have the same ambitions to gain togetherness. My children are



living in distant areas, as are yours, but we have taught them the basics of our culture and hope there is a spark still there. It is good that we have young women at the helm of some of our branches, a good sign for the future."

Mary has suffered through two surgeries and has slowed down but her faith as kept her on an even keel, where she enjoys her friends at a retirement complex at Mayslake, Illinois.

## Frances (Fale) Zibert (1901 - 1993)

Fanny Zibert was a fun-loving, happy and religious woman who had two great loves in her life, besides her family, and they were St. Stephen's Church and her place of birth, Slovenia. As everyone knew, if there was anything to be done either in her church or any Slovenian organization, Fanny was there.

There were many things she did for the SWU but among them are bowling and as a member of the Choral Club. She

had a beautiful voice, loved to sing and was quite the "Sarah Bernhardt," in the Choral productions.

Fanny and Stephanie (Pintar) Osterman wrote and acted in many "Half in Pol," skits which meant "Half and Half." The two ladies composed skits which sounded just like two immigrant ladies speaking, half in Slovenian and half in English. One of skits which Fanny and Stephanie performed is still remembered even after these many years.



Fanny was also an excellent cook and strudel maker and spent a lot of time in the kitchen. She had many strudel demonstrations at St. Stephen's and the strudels were sold to benefit the SWU.

In 1978, Branch 20 sponsored the first Heritage Festival and Fanny Zibert along with Ann Zorko, Millie Paisoli, Mary Muller and Theresa Muhich, made thirty strudels. They demonstrated their expertise to enthusiastic viewers who waited for the apple strudels to be baked and sold. The long tiring hours were truly appreciated and the demonstration was a highlight of the Heritage Festival.

Fanny participated in all the Branch 2 activities during her active years and one could always see her working in Lemont for Zveza Day.

Fanny's daughter, Frances Schultz, wrote that after moving to Michigan in her later years, all that her daughter had to say was, "Let's go to the SWU for a certain function and there she was with her purse on her arm and ready to go."

Fanny and Stephanie were buried on the same day, Dec. 6, 1993, only one hour apart; Fanny from St. Stephen's Church in Chicago and Stephanie from St. Linus in Oak Lawn. We hope they're breaking them up with their clever antics up there in heaven!

## Albina Krizman Novak (1900 - 1971)

Editor of ZARJA from 1933-52 during Zveza's most formative years. Her daughter, Corinne, took over the Editorship in 1952.

National President from 1946 to 52. During this time she also continued as Editor.

National Secretary from 1952-70.

Editor of the SWU cookbook, "Woman's Glory--The Kitchen."

During her presidency the music book, "Slovenske Melodije" (Slovenian Melodies), 1950, was published.

Albina was born in Ribnica na Dolenjskem in 1900 and emigrated with her parents at the age of 9 to Cleveland where she continued her education, worked in the family business, married Rudy Novak in 1923, and eventually became very active in the newly-formed Slovenian Women's Union.

Having initially enrolled as a member of Cleveland's Branch 25, then No. 50 which she organized as the first English-speaking SWU branch, Albina moved to Chicago in 1952. It was the year of major change for Zveza with the new Home Office location under her direction as National Secretary. She then transferred her membership to Branch 2. During her remaining years in Chicago, she enrolled 214 members; 143 adults and 71 juniors.

Albina was a dynamic woman of great leadership abilities, magnetism, energy and ideas. Her friendly personality allowed her to meet people easily and she was conversant in both Slovenian and English. As the organization developed, Albina and Mrs. Prisland worked as a team in promoting, and developing the goals of the SWU. The names heard most frequently throughout the branches were "Mrs. Prisland" and "Albina Novak." Both were very influential women and much of the success and progress of the organization was due to Mrs. Novak as well as the founder Marie Prisland.

Her love for the immigrant Slovenian women and appreciation of their characteristics, so well embodied in the members of Zveza made Albina a life-long friend of all those who worked for its welfare. Long after her death these old friends told stories of Albina's kindness, devotion and all the many little ways she nurtured friendships.

One of her hobbies was sewing Slovenian dolls, dressed beautifully in the costumes of her homeland which she loved to her dying day. There are still many of those little dolls in collections across the country.

## Corinne Novak Leskovar

Zarjar Editor from 1952 to the present time.

In 1939, Corinne's mother, Albina Novak, enrolled her in the SWU Juvenile Department, during the national convention held in Chisholm, MN giving her the distinction of being the very first juvenile member of the SWU.

Corinne became engaged in SWU activities from early

youth, participating as mascot for the Marie Prisland Cadets of Br. 50 in Cleveland. As she grew older, she became her "mother's helper" at all the national conventions and traveled with her mother as Mrs. Novak visited the states where SWU established branches. Mrs. Novak served as National Secretary, National President and Editor of ZARJA during her lifetime and Corinne became a very willing student to a proficient teacher -- her mother.

After moving from Cleveland to Chicago in 1952, Corinne became active in Branch 2 organizing the Junior Christmas Party, and the Midwest Debutante Cotillion Ball.

In 1955 she married Lud Leskovar the director of the Chicagoland Slovenian Radio Hour and from then until his death in 1983, they broadcast weekly to a large audience. This also encouraged her to begin spreading the heritage of her Slovenian background in folkdance – three groups were formed, the most successful of them from 1975 to 1985. The youngsters and teens performed authentic Slovenian folkdances dressed in the perfect costumes of each Slovenian region, and gained a tremendous amount of enthusiastic praise. Following Lud's death, Corinne continued directing the radio program until retiring in 1995.

The SWU Calendar and Carnation Gift cards were both Corinne's brainchild and a project well-received by the members. She also worked closely with Hermine Dicke in printing of the four revisions of "Pots and Pans" cookbook.

The organization is fortunate to have at its helm a woman with so many talents, wisdom, vision and genuine love of her Slovenian heritage. Through the years she has established herself on par with other SWU leaders namely Marie Prisland and Albina Novak.

## **Frances Puchreiter Morison**

Fran served as National Women's and Youth Director from 1987–91 and as National Women's Director from 1991–95. She has served as President of Branch 2 from 1982 to 1996.

When Pope John Paul visited Chicago in 1979, Fran



was downtown where she met a group of our members standing at the gate of Cardinal Cody's residence, waiting for a glimpse of the Holy Father. This group comprised of Ann Mladic, Lil Seibert and Mary Muller, then National President of the SWU. They became friendly and during their conversation, they spoke of the SWU, St. Stephen's Church and Slovenia. Fran was surprised to hear that Slovenians were living so near to her as she herself was the daughter of Slovenian

immigrants!

Fran was the daughter of the late Charles Puchreiter and Frances Zakrajsek who emigrated to the Iron Range of Minnesota where she grew up. She still has many relatives in Slovenia and hopes to visit them in the coming years.

The ladies invited Fran to attend Branch 2 meetings and soon she was a member. Three years later, she was voted President of the Branch in 1982, and had proven herself to be quite a treasure during her 14-year presidency.

Fran, a very creative person, likes to try new things. Her husband Percy and two sons, Michael and Terrance, also are very talented individuals, who became associate members of the SWU. Fran could always count on them to attend the monthly meetings as well as help at the Zveza Picnic in Lemont. They worked together as a family and brought so many new ideas to the meetings and other activities which ultimately increased membership.

During Fran's presidency, the branch has gained a sense of purpose about itself by initiating a monthly cheer basket to help the poor of the neighborhood, contribute to the Heritage Museum, promote research for Bishop Baraga's canonization, assist the SWU Scholarship Fund for young members, help St. Stephen's Parish and St. Mary's Seminary in Lemont when needed and replaced the statue of St. Francis when it was destroyed by vandalism.

Frances Puchreiter Morison is very loyal to her Slovenian heritage, to her family, her church and the SWU. The branch has been very fortunate to have her and they hope that she will remain an officer for many more years.

## **Mary Foys Lauretig**

"She's such a talented lady and so generous with the things that she makes," mentioned one SWU member and I'm sure that there are others that will confirm that phrase and add many other nice comments about Mary Foys Lauretig.



Mary's mother Clara Foys, was enrolled in the organization and was an officer of Br. 2 in the early years. It was natural that as a young woman Mary should join as well. She served as Vice President of Branch 2 for a number of years and has held positions as delegate to conventions.

This creative artist has been a treasure to Branch 2 as she has made many table decorations for events and presented numerous beautifully dressed dolls to the Mother/Woman of the Year.

Each hand-made doll was treasured by each recipient. She has made gorgeous plates and pictures depicting many movie characters. Mary has donated her pictures and plates for raffles and her paintings have appeared on the SWU Calendar and the Carnation note cards. Whenever asked, Mary is always obliging to share her artistic talents.

She is especially known for her doll exhibits, one of which was held at the Heritage Museum in Joliet and others in the Chicago area. Every doll was hand-made and a work of art whether it reflected a region in Slovenia or a popular American character.

Mary's daughter, Verdean Adelman, describes her mother this way: "Throughout my youth and into adulthood, my mother has always been a source of pride. She has instilled in me a love for my Slovenian heritage thru her arts and crafts, her involvement in numerous Slovenian clubs and choral groups, her love of Slovenian music, dance, culinary arts but mostly with our 1984 trip to Slovenija. It was then I was finally able to enjoy the wonderful family and country and heritage I had heard about all my life from my wonderful Slovenian mother."

## Sharon Naudziunas

Sharon was our Mother of the Year 1992. She was also the IL/IN Regional President, Treasurer of Br. 2, organized our Children's Christmas Party, was hostess of our Adults Christmas Party, in Charge of our Penny Socials, worked at the Zveza Day Picnic/Lemont, she has volunteered and participated in every function of Br. 2. Sharon is a very talented lady. She is a single mother, with the help of her parents Dorothy and Fussy Foral she is raising her son, Paul who is a teen now.

## Gloria Jean Novak Nusko (1944-1991)

Gloria Jean was born in Cleveland on October 14, 1944. She attended elementary school in Cleveland until moving to Chicago and then enrolled at St. Stephen Elementary School. She graduated from St. Anne High School and began working for her mother, Albina Novak, as a clerk in the National Office of the SWU. She is the sister of Editor, Corinne Leskovar.

In 1964, Gloria and Ray Nusko were married and during their 27 years together the couple raised 7 boys and 6 girls, a baker's dozen of 13 children! Our Br. 73 secretary for many years, Alouise Epley is doing what many of us fail to do, give of ourselves for the poor and homeless. She is one of just a few ladies at St. Jude's parish in Warrensville Hts., Ohio who dedicate their spare time and talents to making warm covers for the homeless, covers that are simple gifts to people who have nothing.

"People don't realize just how important something like this can be to a homeless person," said Pat Wehner of the Bishop William Cosgrove hunger center which distributes the covers at various shelters in the area. "The homeless have nothing and these covers give them something they can keep and use every day," she added.

Alouise's part in the project is to take used materials such as drapes, blankets, etc. and sew them into large 84" x 84" squares, envelope style. Other ladies meet at St. Jude's to stuff them, tack strips of yarn thru to hold the stuffing, and loops to close up one

end. Parishioners are asked to donate small gifts that are practical for a homeless person, such as soap, hats, gloves, toothbrushes, and things that can be put into an "ugly quilt" before it is given out. Just last month the group completed their 160th ugly quilt!

We are so proud that our own Alouise is involved in this project as she has so much warmth and love in her it is surely finding its way into the quilts she sews for others!

Mary thoughtfully says it is a story reminiscent of many of our immigrant mothers' and grandmothers' lives. Too bad we only tell it when the member is gone.

Thank you, Mary, for thinking of it. And thank you for your kind words about enjoying ZARJA with your family. We, too, offer you best wishes for success and happiness in the future.

† Albena B. Kasmoch 1908 - 1997

My name is Toni Steedman. I am the eldest of Albena's grandchildren and I'd like to say a few words about my grandmother.

She was born on February 18, 1908. This month she would have celebrated her eighty-ninth birthday. Grandma Al was the oldest of seven children: Albena, Mary, who passed away recently, Charles, Juel, George, Florence and John. Her parents were John Sheffler and Gertrude Previc, who we called "Grammie." John and Gertrude were born in Slovenia, but met here. Grandma was born in Center and lived most of her life a few miles from where she was born.

At sixteen she started work at Westinghouse. She was one of the first women to drive a car in the county and, probably, the first woman to own one.

At a dance in the area, she met my grandfather, Johnny Kasmoch. They married in 1930 and had their first son, my father, David, in 1931. His brother, Ray, was born in 1935.

During this period, my Grandmother learned to sew. She walked to Universal, several miles away, for sewing lessons. She became an excellent seamstress and made clothes for her family and friends. Her sister-in-law, Dorothy, recalled that Grandma made her first real slip with straps, eliminating the need for a scratchy petticoat. I have a picture of my father and Uncle Ray in blue velvet shorts with large blue satin bows that Grandma made. They looked really cute, even though the bows might have looked better on daughters.

In 1937, my grandparents bought Twin Gables, a local nightclub in Renton. It was apparently very popular and helped a lot of people get through the war years. Grandma did everything from cooking to bookkeeping. She also fed the miners getting off the midnight shift - meat and potatoes for twentyfive cents.

When my dad was about ten, Grandma broke her collarbone and fractured her skull in a fall. She went to live in Florida with her sons for several months while she recuperated. She and Grandpap Johnny stayed in touch with letters that showed a warm affection during those years. In 1945, they sold Twin Gables to pursue their growing beer distribution business aptly called Johnny's Beer Distributing.

Also about this time. Uncle Ray brought home a friend who had lost his parents. His friend, Dick Hilke, was about thirteen years old when Grandma took him in. Dick worked with Grandma for many years until he started a family of his own.

On July 18, 1960, my Uncle Ray, who was also my godfather, died in an accident. He was a very special man and this was a low point in Grandma's life. A few years later, in 1963, my Grandpap Johnny died after a stroke. Grandma continued to run the business on her own until she sold it to basketball player, Moe Barr, in the 1970's. She continued to dabble in business and rental property after that.

One of her proudest accomplishments was winning a pollution lawsuit against Consolidation Coal Co. She had involved everyone from senators to EPA officials and became a local folk heroine featured in articles in the Pittsburgh Press.

Grandma experienced two wonderful trips in her lifetime; one, a cruise to the Caribbean with my Grandmother Helen and, the other, a trip to Slovenia.

In later years, she enjoyed her four grandchildren, me, my sister, Diane, and brothers, David and Tim. She also had five great grandchildren, Alison, Katie, David Jason, Lydia and Nicholas. She also spent many hours in her dahlia garden and kept a full inventory of bulbs in her basement.

She loved to spend time at my dad and mom's farm in Emlenton, Pennsylvania. On one holiday trip with Aunt Juel and Aunt Mary, Grandma snuck along extra nightgowns for her sisters so they couldn't insist on driving home after dinner. They left in a snowstorm and it was one of few arguments I ever saw my Grandmother lose! Grandma was very close to her family, especially Aunt Juel, who had visited the hospital daily and was at her bedside when she died.

Grandma Al was, in many ways, a woman before her time. She passed on to all of us gifts of self-confidence and self-sufficiency.

about 20 miles long circling Shagawa Lake. I attended the Ely Public Schools graduating from Memorial High School in June, 1936 as an honor student. I continued my education at Ely Junior College (my father being a firm believer in education). A friend and I decided to go to Milwaukee where I had a lot of relatives, and would make my fortune. However, these were depression (1938) years and I found employment in various jobs for short periods of time. I was a waitress working in a nurse's dormitory serving breakfast at 5 a.m.; sold Watkins products out in the country, door-to-door, and also worked at a factory on a riveting machine, making foot dimmer pads for automobiles. I was laid off before Christmas and returned to Ely.

That summer I got a job with the recreation department keeping children interested in story telling, crafts and games. On many days I walked the four miles to my home past the Rock Crusher. I enrolled in Ely Junior College for my second year the fall of 1938, and graduated in June 1939. While attending Junior College I was inspired by my business teacher, Miss Michaelson, who had worked as a secretary in Washington, D.C. before becoming a teacher. Because of her interest in me, I received excellent training and the business foundation I needed for my vocation.

The depression was still with us and no employment was available, so I made up my mind to enlist in the WACS! I accepted the job with the Welfare Board and remained in Ely. My job classification changed shortly after I began to work for the Welfare Board and I became a field worker. In this capacity I made home visits to those employed by WPA, those receiving Old Age

Assistance (as it was called back then) and those receiving general relief and commodities. My area included Ely, Tower-Soudan, Embarrass, Babbitt and the Indian Reservation. Twice a month I held office hours at the County Garage on Tower's main street. In the spring of 1942, at the height of World War II I was employed by the Oliver Mining Company in Ely as secretary to Peter Handberg, Personnel Supervisor. Another opportunity presented itself in December 1942 when I became employed as secretary to the superintendent of schools in Ely, a position I held for 32 years resigning in 1974. I thoroughly enjoyed this position working as secretary to Stanley Adkins, Donald G. Stubbins, W.J. Murphy, substitutes M.W. Van Putten and George A. Moe, and Stanley Vetjasa. I also substituted for the secretary to Dr. Reginald Nolin in the Tower School District.

on April 21, 1951. Bob died suddenly in October, 1993, shortly after a CT scan revealed an inoperable brain tumor and a lung tumor. It will always be remembered that Angie attended the 1993 State Convention just one week after Bob's funeral, a true example of her loyalty to SWU.

The young couple resided with his parents for a year or so, then moved into a small apartment until their home on Brainard Road was completed. They moved into the residence in 1956 and Angie still lives there, a rather rural location with a large front yard, and even larger backyard, where family gatherings are held.

times, the honest sweat of the big people outside and the cooks and bakers inside. The little people were the runners for eggs, water, firewood, etc. The old pot-belly and wood stoves also had to be "fed." Beans, pickles, and berry picking were very common.

Memorable times in this Slovenian community were the various church events with the Old Country cutoms, the ringing of the bells at Christmas Midnight Mass, Easter festivities, May Crownings, singing in the choirs, church picnics with all those special Slovenian goodies (potica, strudel, krapi, flancati, klobase), weddings, dances, concerts. The old Slovenan songs were so impressive and beautiful. And to be sure, the Woman's Glory, Pots & Pans, and Kuharica iz Willarda contain those goodies recipes. Coming from a very musical family, the family band played at many events.

Education was important, from hiking to the little country schoolhouses to being bused a 50-mile zig-zag trip to the local parochial and high schools. Post-graduation took her to the big cities in search of jobs. Employment at Allis-Chalmers, a large manufacturing company, December 4,

1950 started an office career. Evening advanced classes were taken at MATC. A variety of clerical/secretarial positions were held as the job openings became available throughout the Divisions. Siemens Energy (German) and Svedala (Swedish) Divisions included some interesting International Contacts. Enjoyed the Word Processor, but will leave the new Computers and Internet to others. February 28, 1989, Betty's working career ended on a snow-covered icy sidewalk between home and office with a severely comminuted leg fracture.

Začetki Katoliške Cerkve v Ameriki

FRANC JAKLIČ

### IX. BARAGA REDNI ŠKOF SAULTSKI LETO 1861

2. februarja 1861 je pisal Čebulj v Kranj: "S škofom Barago sva se zmenila, da si bova pustila brado rasti, ker se z britjem izgubi preveč časa. Na prihodnjem zboru severnoameriških škofov v Cincinnatiju bo škof Baraga sprožil tudi vprašanje zastran brade. Upam na ugoden uspeh." Čebulja res vidimo na sliki, ki je najbolj običajna, z brado; ohranile so se pa tudi take, na katerih je nima. Ali je Baraga po tistem zmenku s Čebuljem res nosil brado, ne vemo.

Dne 7. februarja se je vrnil z nekega potovanja. Šel je bil peš, na krpljah, a ne vemo. kam; najbrž na kanadsko stran. Na potu bi bil skoro zmrznil. Ko se je vrnil, se je po devetih dneh kljub vsemu spet odpravil proti Detouru (Detoru), ki leži južno od Saulta ob izlivu Reke svete Marije v Huronsko jezero. "Mnogo sem trpel od mraza," piše spet sestri, "in bi bil nekoč kmalu zmrznil, a sem vendarle prišel do neke hiše in se ogrel." Ko se je vrnil, je bil bogat: celih 4875 frankov mu je iz Lyona poslala Družba za širjenje vere. Takoj je za razne cerkve v škofiji naročil 8 železnih zvonov, težkih od 80 do 460 funtov, to je od 36 do 200 kg.

Duhovnikom je pisal, naj za cerkvene sedeže pobirajo prispevke, sicer ne bodo imele cerkve prav nobenih dohodkov.

V Saultu je odslovil neuporabnega učitelja. Terhorst je moral upravljati župnijo in indijanska sela na kanadski strani, zraven vsega tega pa še učiti vse predmete v deški in dekliški šoli. V priznanje mu je Baraga daroval nove indijanske čevlje (mokasíne).

Za dneve od 28. aprila do 5. maja je nadškof Purcell spet sklical svoje škofe v Cincinnati na cerkveni zbor, tretji po številu. Ker ni bilo upati, da bi se tudi severni del Huronskega jezera pravočasno odtajal za ladijski promet, je Baraga odpotoval iz Saulta takoj na velikonočni ponedeljek po prazniški maši. V Cincinnatiju je hotel zbirati darove za svojo ubožno škofijo in dati nekaj indijanskih knjig v ponatis. Svoje nenavadno težavno potovanje na ta cerkveni zbor je v svojem dnevniku precej natančno opisal:

"Potoval sem do Sobrersa deloma na krpljah, deloma brez njih. Napravil sem pota 12 milj (19 km) in potem prenočil na prostem. Bila je lepa noč, ne preveč mrzla." Drugo jutro – po večurni molitvi, kakor jo je vsako jutro opravljal – je odpotoval ob šestih in ves dan, do petih popoldne, hodil s krpljami. Tisto noč je spal pod streho, v Frichettovi (Fričétovi) lovski koči. Naslednje jutro se je odpravil ob pol šestih naprej, a brez krpelj, ker so ga bili prejšnji dan njihovi jermeni preveč ožulili. Počasi je gazil debeli sneg in ob eni popoldne prišel do Huronskega jezera, ki je bilo trdo zamrznjeno. Šel je po njem proti Belangerjevemu (Belanžerjevemu) gostišču, kjer je navadno prenočeval. Po jezeru se je pa s konji in sanmi pripeljal lastnik gostišča in ga vzel s seboi.

Ponoči se je dobro odpočil in je ob šestih zjutraj odšel po zamrzlem jezeru proti Mackinacu. Dve uri in pol je hodil. Tam mu je misijonar Murray pripovedoval o svojih vernikih zelo žalostne stvari.

Naslednji, peti dan potovanja, se je ob osmih odpeljal preko jezerske ožine s trgovcem Wendellom. Opoldne je prispel v Cheboygan in se ustavil pri družini Allair.

Drugi dan je jahal 22 km daleč. Potem je spet prenočil na prostem; dobro se je počutil. Sedmi dan je bila nedelja, a ni mogel maševati. Hodil je in hodil, po dobrih in slabih potih. Zvečer se je nastanil v zapuščeni gozdni koči. Zakuril je ogenj in opravil brevir.

Čim bolj je šel proti jugu, tem slabša je bila pot. V pomladanskem soncu in odjugi se je sneg mehčal, tajal in zalival doline z vodo.

Prispel je do majhnega jezera na severu Dolenjega Michigana in tam prenočil. Deveti dan je "z božjo pomočjo ob devetih zvečer" prišel v mesto Alpena ob Huronskem jezeru. Potovanje ga je tako zdelalo, da je moral ostati tri dni v postelji. Prvi dan je samo nekaj zajtrkoval; kósiti in večerjati ni mogel.

Na tem potovanju do Alpene se je preutrudil. Od takrat naprej je čutil tesnobo v prsih in naduho, ki ga je pri hoji zmerom bolj mučila.

Alpena prvotno ni bila med kraji, ki mu jih je detroitski škof izročil v dušno oskrbo. Pozneje ga je pa prosil in Baraga jo je sprejel, čeprav mu je bila zelo od rok. Stalnega duhovnika jim pa ni mogel dati. Murray je moral z daljnega Mackinaca in Bobrovega otoka hoditi k njim, v čolnu ali peš.

Zdaj je Baraga v Alpeni slišal in videl tako žalostne stvari, da je zapisal v dnevnik: "Eden najbolj žalostnih dni mojega življenja. Naj me Bog váruje takih dni! Mračen dan, strahovit metež in vihar." – Ko je vstal iz postelje, je šel z ljudmi izbirat prostor, kjer naj postavijo cerkev. Na nabiralni poli so se podpisali s precej lepimi zneski; plačali jih pa niso.

Potem je moral še pet dni čakati, da se odpelje po jezeru, ki je bilo od tukaj že odtajano. Ribiška ladja jih je pa mogla peljati samo 50 km, do Harrisvilla; zaradi prehudega vetra ni mogla naprej.

Spet en dan čakanja. Potem je z nekaterimi drugimi potniki najel ribiško ladjico. Šel je kakšne četrt ure proti kraju, odkoder bi morala odriniti. Pa se je vrnil, ker je spet pihal nasproten veter in je vedel, da ladjica ne bo mogla odpluti. Tudi je čutil veliko tesnobo v prsih. Ob treh popoldne je pa priplul parnik "City of Cleveland" in z njim se je odpeljal.

Vsa pot do Detroita mu je vzela 22 dni. Od tam

se je z vlakom odpeljal v Cincinnati.

Tam je pri običajni slovesni zadušnici za umrlimi duhovniki nadškofije on imel v stolnici pridigo. V imenu škofov je poslal Ludovikovemu društvu v München poročilo o zborovanju.

V Cincinnatiju se je spet zadržal dva meseca. Mnogo časa mu je vzelo pregledovanje tiska nekaterih njegovih indijanskih knjig, ki jih je dal ponatisniti. Ob prostem času je pa moral pritiskati kljuke po hišah premožnejših katoličanov in prositi za svojo škofijo.

Druga leta se je najprej peljal pregledat južne, otavske misijone, ker se je Michigansko jezero prej znebilo leda. To leto ga pa vidimo naprej ob Gorenjem jezeru. S seboj je vzel Terhorsta.

Najprej je izstopil v Marquettu, kjer so bili verniki posebno dobri. Imel je sv. birmo pri njih. Potem je potoval štiri ure v novo rudarsko mestece Negaunee, kjer je bil nastavljen Francoz Duroc (Dirók). Cerkev je že postavil. Zdaj mu je Baraga kupil za stanovanje precej oddaljeno leseno hišico in jo dal razdreti in prenesti k cerkvi.

V L'Ansu ga je pozdravil Jacker. Zdaj ga je prestavil na Keweenawski polotok v Houghton, kamor je že prej hodil iz L'Ansa. V Houghton je prišel kakor berač, v oguljeni in zašiti obleki, brez dolarja v žepu. Tudi tukaj je imel ogromnega dela. Hišni zvonec je neprenehoma pel, tudi ponoči, ko ga je klical k bolnikom, včasi zelo daleč. Katoličani in protestantje so ga kmalu zelo vzljubili. Tudi v Houghtonu je vse sproti razdal.

Iz Houghtona je postavil tisto leto 1861 tudi v Hancocku cerkev. Vsako nedeljo je tudi v njej imel službo božjo.

V L'Ansu je Baraga pustil Terhorsta.

Tu se mu je primeril dogodek, ki nazorno kaže njegovo neporušljivo dobroto, zlasti še do Indijancev: Prišel ga je obiskat star Indijanec, njegov dober znanec, in mu je rekel, da lahkomiselne Indijance s svojo preveliko darežljivostjo samo razvaja. Baraga se je zavedal, da je to res; vzel si je opozorilo k srcu in je tudi novodošlemu Terhorstu strogo zabičal, da naj Indijancem ne daje darov, tudi če ga bodo zelo prosili. Ko je Terhorstu to naročal, se je ozrl skozi okno. Obraz se mu je v hipu omilil in razjasnil. zagledal je staro, siromašno indijansko ženico, ki jo je poznal že skoro dve desetletj. Zasmilila se mu je. Pozabil je na svoj sklep in opomin in pri priči prosil Terhorsta, naj mu posodi tri dolarje, da jih bo dal Indijanki.

Terhorstu je bilo med Indijanci v L'Ansu skraja zelo dolgčas. Baraga mu je svetoval, naj se pridno uči indijanščine in oprime ročnega dela, kakor je tudi on sam ob prostem času mizaril in opravljal podobna dela. Tudi mu je zagotavljal, da se bo v L'Ansu počutil srečnega, kakor se je vseh deset let tudi on. Res se je Terhorst kmalu privadil. Ostal je v L'Ansu dolga desetletja, do svoje pozne smrti leta 1901.

V Cliff Mine je Baraga z veseljem gledal pridno pastirovanje Ribničana Andreja Andolška, ki je vsako drugo nedeljo imel službo božjo tudi v Eagle Harborju. – V Bayfieldu se je za Čebulja, ki je upravljal tudi La

Póinte, Superior in Fond du Lac, resno bal, da ne zboli od prehudih naporov. Nemški časopis je zapisal, misleč na Čebulja: "Prečastitemu škofu Baragi moremo samo častitati, da je dobil take duhovnike, ki z apostolsko ljubeznijo do svojih vernikov darujejo Bogu vse svoje uboštvo, svoj trud in svoje delo." Minulo zimo je Čebulj potoval k bolnemu Indijancu 90 milj (150 km) daleč, najbrž v Lac du Flambeau (di Flambó), taj in nazaj peš, skoraj brez hrane, s težkimi krpljami na nogah. – Krplje so ga večkrat do krvi odrgnile skozi mehke indijanske čevlje in Indijanci so po krvavi sledi vedeli, kam je šel. On se pa za to ni zmenil; ostal je pogumen in vesel.

Za poznanje Baragove škofije in Baragovega delovanja je zelo važno poročilo, ki ga je 18. julija 1861 iz Saulta poslal v Rim. Sestavljeno je v obliki odgovorov na vprašanja, ki mu jih je 24. aprila poslala Kongregacija za širjenje vere. – Ima 15 misijonskih postaj. Pri vsaki pristavi oddaljenost v angleških miljah od Saulta. Mi jo podamo v kilometrih. So pa te: Sault Ste. Marie; Marquette (272 km); L'Anse (368 km); na

Ignacij (153 km). - Vsako leto obišče, če more, vso škofijo, kakor določajo cerkveni predpisi. Skofijskih sinód (zborovanj) ne more imeti, ker so duhovniki preveč oddaljeni in jih ne more trgati od njihovega nujnega dela. Ker nima duhovnikov, je v vsakem misijonu en sam. Semenišča nima; trije bogoslovci študirajo v drugih semeniščih. - Nima župnij, ampak samo misijone; v cerkvah se hrani sv. Rešnje Telo. Nekateri misijoni imajo dve ali tri podružnice. – Vseh vernikov ima okoli 10.000, "skoraj iz vseh narodov in ljudstev in jezikov." Posamezne misijonske postaje jih imajo: Sault 1000, Marquette 5000, L'Anse 420, Portage Lake 300, Eagle Harbor 400, Cliff Mine 300, Ontonagon in Minnesota Mine 1200, La Póinte 400, Superior 200, Mackinac 400, Križna vas 300, Little Traverse 500, Grand Traverse 600, Bobrov otok 300, Sv. Ignacij 280. Število katoličanov se vsako leto veča s priseljenci iz Evrope. Skoraj vsak misijon ima svojo šolo, angleško. Povsod so tudi nekatoliške šole, ki jih obiskujejo nekateri katoliški dečki, tudi proti prepovedi dušnih pastirjev. -Vsi njegovi misijonarji so Evropejci, "pobožno izvršujejo duhovniška opravila in so Cerkvi božji zelo koristni." Kar jih je pri Indijancih, jih mora sam zdrževati, ker so Indijanci preveč revni. Drugi zdržujejo verniki. Redovnikov in redovnic nima; Weikampovih

Ko je pisal imena svojih misijonov in cerkva v njih, so se mu gotovo budili spomini na delo in trud, pa tudi na duhovno tolažbo in veselje, ki ga je imel v vsakem izmed njih. Skoraj vse je sam ustanovil, skoraj vsakega od njih nekaj časa sam oskrboval. Večino cerkva je sam dal postaviti. Sprva je pa moral maševati v zasebnih hišah.
