TEMPORARY PROTECTION OF INVENTIONS PRESENTED AT THE FAIR OF TRIESTE

WHEREAS it is n cessary to provide for temporary protection of inventions, models, shop drawings and trade-marks not covered by patents or by legally deposited applications therefor, which will be presented to the Fair of Trieste for the year 1948, which will take place between 15th and 30th September 1948,

NOW, THEREFORE, I, RIDGELY GAITHER, Brigadier General U. S. Army, Director General, Civil Affairs,

ORDER:

ARTICLE I

Inventions, models shop drawings and trade-marks not covered by patents or by a legally deposited application therefor and presented to the Fair of Trieste for the year 1948 in accordance with the relevant regulations shall have by virtue of their presentation the temporary protection prescribed under the Patent Laws in force.

ARTICLE II

This Order shall come into effect on the date of its publication in the Official Gazette.

AUTHORITY GRANTED TO "SEMINARIO DIOCESANO" OF TRIESTE TO ACCEPT A LEGACY

ARTICLE I

AUTHORITY TO ACCEPT LEGACY

Authority is hereby granted to the "Seminario Diocesano" of Trieste to accept, subject to the terms and conditions specified in the Will hereinafter mentioned, the legacy left to it by Countess Anna SEGRE' SARTORIO in her Will dated April 1st, 1944, opened and published on April 9th, 1946, according to Notary Dr. Silvio QUARANTOTTO's deed, R. No. 5863, in Trieste.

ARTICLE II

EFFECTIVE DATE

This Order shall come into effect on the date it is signed by me.

FACILITIES CONCERNING PAYMENT OF TAX-ARREARS

In order to ease the financial position of tax-payers in the Zone and in agreement with the Italian Government, as the party most interested in the collection of taxes relating to the period preceding the 16th of September 1947, the following facilities concerning payment of tax-arrears will be granted:

1. - Income tax (Cat. B and Cat C 1) and Super tax

- a) Payment in six four-monthly instalments (commencing from the April instalment) of all taxes entered in additional ("integrativi") rolls for 1947 and in 1st series 1948 supplementary rolls for 1947 and previous years.
- b) Payment in five four-monthly instalments commencing from the August instalment of all taxes entered in IInd series 1948 supplementary rolls for 1947 and previous years.

2. - Turnover Tax

Payment in six quarterly instalments of all tax-arrears relating to 1947 and previous years.

The Tax Offices concerned will provide "ex officio" for the practical and immediate enforcement of the above payment facilities.

EXTENSION OF LEGAL AND CONVENTIONAL TIME-LIMITS IN CONSEQUENCE OF THE CLOSURE OF THE BANK OF ITALY DUE TO EXCEPTIONAL EVENTS

In accordance with Article II of Order No. 256 dated 24 June 1948 the undersigned acting Director of Finance of the Allied Military Government

NOTIFIES:

- 1. The closing down of the Bank of Italy in the British-United States Zone of the Free Territory of Trieste from 8 hours of 28 July to 12 hours of 28 July 1948 is considered to have been due to exceptional events.
- The legal and conventional terms which expired during the period of said closure are extended until 12 August 1948, the fifteenth day as from the re-opening of the Bank.
