TEMPORARY AMENDMENT TO THE REGULATIONS FOR THE IMPLEMENTATION OF THE CODE OF NAVIGATION (MARITIME NAVIGATION)

WHEREAS it is deemed advisable to amend temporarily the Regulations for the implementation of the Code of Navigation (Maritime Navigation) enacted by Order No. 1, dated 5 January 1953, in that part of the Free Territory of Trieste administered by the British-United States Forces,

NOW, THEREFORE, I, SIR JOHN WINTERTON, KOMG, CB, CBE, Major General, Zone Commander,

ORDER:

ARTICLE I

Limited to the next competition for inscription in the Trieste Roll of port-workers, the maximum age admissible for such inscription shall be fortythree years. However, there shall be no prejudice to special privileges provided for by special laws.

ARTICLE II

This Order shall become effective on the date of its publication in the Official Gazette.
