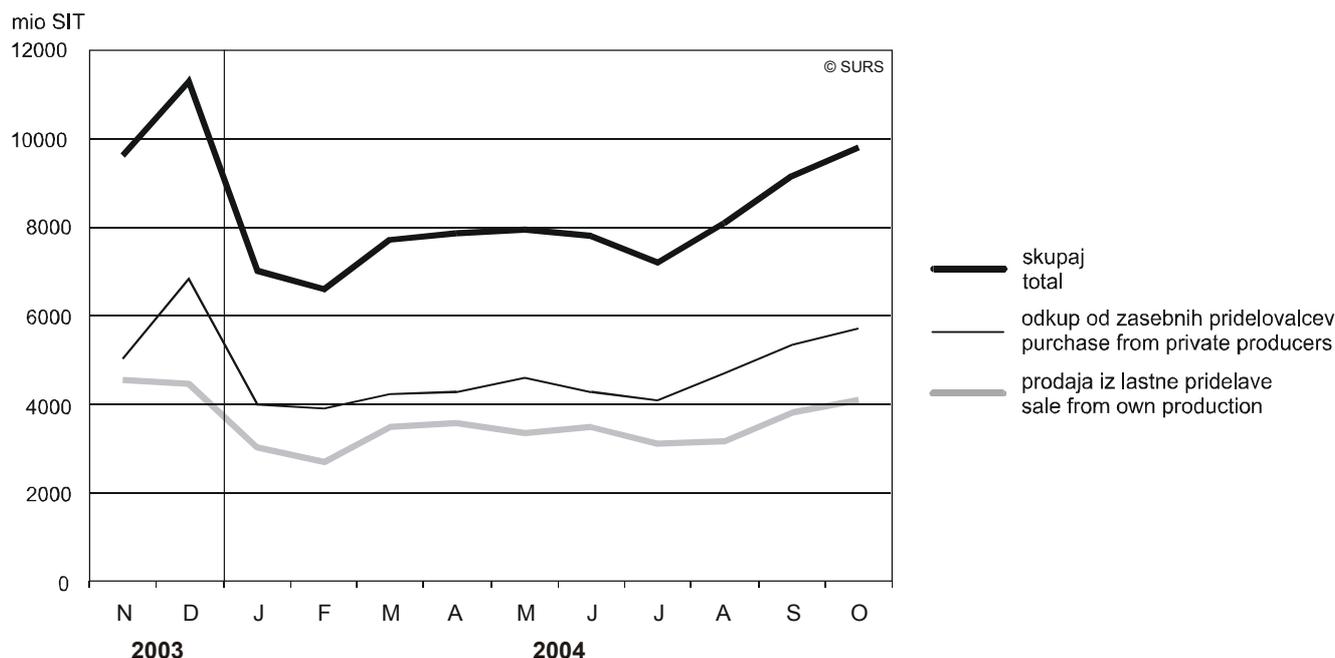
ODKUP KMETIJSKIH PRIDELKOV, SLOVENIJA, OKTOBER 2004

PURCHASE OF AGRICULTURAL PRODUCTS, SLOVENIA, OCTOBER 2004

- ▶ Celoten odkup kmetijskih pridelkov je bil oktobra 2004 v primerjavi s septembrom 2004 vrednostno večji povprečno za 7,0 % (vrednost odkupa od zasebnih pridelovalcev je bila večja za 7,3 %, vrednost prodaje iz lastne pridelave organizacij pa za 6,5 %).
- ▶ Vrednost odkupa je bila oktobra večja v skupinah: žita, industrijske rastline, krmne rastline, sadike sadnega drevja, grozdje, alkoholne pijače, perutnina in jajca, mleko in mlečni izdelki, kože in volna, med in vosek ter drugi pridelki, manjša pa v skupinah vrtnine, sadje, živina, ribe in les.
- ▶ Med pomembnejšimi kmetijskimi pridelki je bil količinsko večji odkup težkih prašičev in perutnine za zakol, jajc, jabolk, vina in drv, količinsko manjši pa odkup pitanih prašičev in prašičkov ter goveda in telet za zakol, krompirja in tehničnega lesa; odkup mleka je ostal na ravni preteklega meseca.
- ▶ In comparison with September 2004, in October 2004 the value of purchase increased on average by 7.0% (the value of purchase of agricultural products from private producers increased by 7.3% and the value of sold agricultural products from own production increased by 6.5%).
- ▶ In October the value of purchase increased in the following groups: cereals, industrial plants, fodder plants, fruits plants, grapes, alcoholic drinks, poultry and eggs, milk and milk products, hides and wool, honey and wax and other products. The value of purchase decreased in the following groups: vegetables, fruits, livestock, fishes and wood.
- ▶ Of main agricultural products, the quantities of purchased fat pigs and poultry for slaughter, eggs, apples, wine and fuelwood increased, while the quantities of purchased porkers and sucking pigs, cattle and calves for slaughter, potato and pitprops and logs decreased. The quantities of purchased milk were nearly the same as in the previous month.

METODOLOŠKA POJASNILA

Namen statističnega raziskovanja

Na podlagi podatkov, ki jih zberemo s poročili (obrazca KME-ODK/M in KME-PRO/M), želimo prikazati mesečno gibanje odkupa in prodaje kmetijskih pridelkov. V poročilih je zajetih okoli sto pomembnejših pridelkov, ki so jih pridelovalci prodali; prikazane so količine prodanega blaga in zneski, ki so jih dobili za oddano (odkupljeno oz. prodano) blago, ter povprečne odkupne oz. prodajne cene; te so osnova za izračunavanje indeksov cen za kmetijske pridelke.

Enote statističnega opazovanja

so podjetja, zadruge in druge organizacije, ki prodajajo pridelke iz lastne pridelave ali kmetijske pridelke odkupujejo neposredno od zasebnih pridelovalcev.

Zajetje

O odkupu kmetijskih pridelkov od zasebnih pridelovalcev poročajo podjetja, zadruge, gozdna gospodarstva in organizacije, ki te pridelke odkupujejo za nadaljnjo prodajo.

O prodaji kmetijskih pridelkov iz lastne pridelave poročajo kmetijska podjetja, šole, zavodi in druge organizacije (nezasebni pridelovalci).

Količine kmetijskih pridelkov, ki jih zasebni pridelovalci sami prodajo neposredno večjim potrošnikom ali na prostem trgu (prodaja na domu, sejnih ali na živilskih trgih), tu niso upoštevane.

Definicije

Skupni odkup kmetijskih pridelkov in proizvodov zajema podatke o odkupu od zasebnih pridelovalcev ter o prodaji kmetijskih pridelkov iz lastne pridelave podjetij, zadrug in drugih organizacij.

Odkup od kmetov je odkup kmetijskih pridelkov neposredno od zasebnih pridelovalcev prek pooblaščenih organizacij, ki odkupljene pridelke prodajo naprej, lahko jih prej tudi predelajo.

Prodaja zajema prodajo kmetijskih pridelkov iz lastne pridelave zadrug, kmetijskih podjetij in drugih organizacij. K prodaji pa ne štejemo pridelkov, ki so bili kot surovine dani za predelavo lastnim enotam. V tem primeru štejemo kot prodajo izdelke teh enot (mlečne izdelke, alkoholne pijače, suho sadje itd.), ki so bili prodani.

Vrednost odkupa je znesek, ki ga zasebni pridelovalec prejme za oddane pridelke. Stroški organizacije v zvezi s prevzemanjem kmetijskih pridelkov od zasebnih pridelovalcev, s prevozom do skladišč, hrambo ali z uskladičenjem se ne štejejo v vrednost odkupa.

METHODOLOGICAL EXPLANATIONS

Purpose of the survey

Data on the purchase and sale are taken from monthly reports (KME-ODK/M and KME-PRO/M). The purpose of the survey is to show monthly changes of purchase of agricultural products. Data on volume, value and average purchase prices for about one hundred main agricultural products are collected. Data are used to observe the volume and value of purchase as well as for calculating the price indices of agricultural products.

Observation units

are companies, co-operatives and other organisations selling products from their own production or purchase agricultural products directly from the farmers.

Coverage

Reports on the purchase of agricultural products from private producers are submitted by companies, co-operatives, forestry and other organisations that purchase agricultural products directly from private producers.

Reports on the sale of agricultural products are submitted by agricultural companies, schools, institutions and other organisations (not private producers).

These reports do not contain the quantities of agricultural products sold directly to larger consumers and also not the quantities sold on the free market (on the farm, on stock fairs or markets).

Definitions

Total purchase of agricultural products contains data on purchase from private producers and data on sale from own production of companies, co-operatives and other organisations.

Purchase from private producers is the purchase of agricultural products from farmers through authorised organisations for processing or further direct sale of purchased products.

Sale covers data on the sale of agricultural products from ones own production (agricultural companies, schools, institutions and other organisations). Not considered as sale is the giving of raw materials to own units for processing. In this case only the products of these units are considered as sale (dairy products, alcoholic drinks, dried fruit, etc.).

Value of purchase is the value that private producers get for sold agricultural products. Manipulation costs related to the delivery of agricultural products from farmers, with transport to the storage are not included in the value of purchased products.



Vrednost prodaje je znesek, ki ga nezasebni pridelovalci dobijo od prodaje kmetijskih pridelkov iz lastne pridelave; ta zajema tudi stroške, ki nastanejo v zvezi s pripravo pridelkov za dobavo do nakladalnega kraja (sortiranje, pakiranje ipd.). V vrednosti prodaje niso zajeti vračljiva embalaža, transportni stroški od nakladalne do razkladalne postaje in olajšave, ki jih organizacije odobrijo kupcem.

Premije, regresi, kompenzacije ipd., ki jih pridelovalci dobijo za določene pridelke, v vrednosti odkupa in prodaje niso zajeti.

Odkupne oziroma prodajne cene izračunamo tako, da vrednost posameznega pridelka delimo z njegovo količino. To so pravzaprav povprečne vrednosti na mersko enoto. Poročevalske enote nam sporočijo celotno količino in vrednost za posamezne odkupljene in prodane pridelke, ne glede na kakovost, sorto ali tip pridelkov. Cene ne vključujejo DDV.

KOMENTAR

Oktober 2004 je vrednost odkupa kmetijskih pridelkov znašala 9 milijard 801 milijon tolarjev in je bila v primerjavi z vrednostjo odkupa v septembru 2004 za 7,0 % višja, glede na lanski oktober pa za 1,3 % nižja.

Vrednost odkupa v živinoreji kot najpomembnejši skupini je bila oktobra 2004 glede na september 2004 manjša povprečno za 0,9 %; od pomembnejših skupin v skupini živinoreja je bila manjša vrednost odkupljene živine (za 9,3 %), večji pa je bila vrednosti odkupljenih perutnine in jajc (za 3,3 %) ter mleka (za 2,0 %). Na spremembe v vrednosti odkupa v skupini živinoreja so vplivale večje oz. manjše odkupljene količine. Tako je bilo pitanih prašičev, goveda in telet za zakol odkupljenih manj, težkih prašičev, perutnine za zakol ter jajc več, količinski odkup mleka pa je ostal približno enak kot septembra. Cene živali in živalskih proizvodov pa so oktobra glede na september v povprečju porasle za 1,0 %.

V drugih pomembnejših skupinah se je vrednost povečala v skupinah: žita (večji odkup pšenice in koruze), industrijske rastline (večji odkup sladkorne pese, hmelja in buč za olje); sadjarstvo in vinogradništvo (večji odkup grozdja za predelavo, jabolk in hrušk ter vina; cene sadja so porasle za 3,2 % cene vina pa za 0,9 %).

Value of sold agricultural products is the value that nonprivate producers get for sold agricultural products from own production; it includes costs of preparation of products for delivery and transport to the loading place (sorting, packing, etc.). The price of packaging, which is returned, and the costs of transport to the loading and unloading station and other facilities of payment granted to the buyer are also not included.

Bonuses, reimbursements, compensations, etc., which producers obtain for certain products, are not included in the value of purchase or sale.

The prices of purchase and sale are calculated by dividing the value of the agricultural product by its quantity. The prices are in fact average values per unit of measure. Enterprises report all quantities and volume of purchased and sold agricultural products irrespective of the quality or type. Prices do not include VAT.

COMMENT

In October 2004 the value of purchase of agricultural products was SIT 9.801 billion. In comparison with September it increased by 7.0%, but decreased by 1.3% in comparison with October 2003.

In comparison with September 2004, in October 2004 the value of purchase in the most important group – livestock breeding – decreased by 0.9%; the value of most important groups in the group livestock breeding - livestock decreased by 9.3%, but the value increased in the groups poultry and eggs (by 3.3%) and milk (by 2.0%). In fact, the value increased or decreased in line with purchased quantities; the purchase of porkers and sucking pigs, cattle and calves for slaughter decreased, the quantities of purchased fat pigs, poultry for slaughter and eggs increased; the quantities of purchased milk were almost the same as in September. On average, the prices of animals and animal products in October in comparison with September increased by 1.0%.

In other important groups the value of purchase increased in the groups: cereals (higher purchase of wheat and corn), industrial plants (higher purchase of sugar beet, hops and pumpkins for oil); fruit and wine growing (higher purchase of wine grapes, apples, pears and wine; the prices of fruits increased by 3.2% and the prices of wine increased by 0.9%).
