POLNOLETNE IN MLADOLETNE OSEBE, ZOPER KATERE JE BIL KAZENSKI POSTOPEK PRED SENATOM PRAVNOMOČNO KONČAN, SLOVENIJA, 2006


ADULTS AND JUVENILES AGAINST WHOM CRIMINAL PROCEEDINGS THROUGH A SENATE HAVE BEEN LEGALLY CONCLUDED, SLOVENIA, 2006

- ▶ V letu 2006 so pri okrožnih in okrajnih sodiščih končali kazenske postopke zoper 14 545 polnoletnih oseb, kar je za slab odstotek manj polnoletnih obtožencev kot leto prej. Kazenske postopke proti mladoletnikom so na sodiščih končali v 796 primerih, kar pomeni 4,5 % več kot v letu 2005.
- ▶ V letu 2006 je bilo obsojenih 8 119 polnoletnih oseb ali za 5,2 % več kot v letu 2005. Izrečene so jim bile različne glavne kazenske sankcije, najpogosteje zaporna kazen (88,6 %); med temi je bilo 82,2 % pogojnih obsodb. Denarne kazni so bile izrečene 577 osebam; med temi je bilo 2,1 % pogojnih obsodb.
- ▶ Vzgojni ukrep ali kazen sta bila v letu 2006 izrečena 511 mladoletnim osebam; to je za 2,6 % več kot v predhodnem letu. Zoper mladoletne osebe sta bila najpogosteje izrečena vzgojna ukrepa nadzorstvo organa socialnega varstva (56,0 %) in ukor (20,0 %). Mladoletnički zapor je bil izrečen enajstim, denarne kazni pa sedmim mladoletnim osebam.
- ▶ In 2006, criminal proceedings against 14,545 adults were concluded at regional and district courts, which is almost 1% less than a year before. In the same year criminal proceedings were concluded against 796 juveniles, which is 4.5% more than in 2005.
- ▶ In 2006, 8,119 adults were convicted, which is 5.2% more than in 2005. They were imposed various main penal sanctions. The most frequent penal sanction was imprisonment – 88.6%, of those 82.2% suspended sentences. Fines were imposed on 577 persons, of those 2.1% suspended sentences.
- ▶ In 2006, 511 juveniles were imposed an educational measure or a sentence, which is 2.6 % more than in the previous year. The most frequent sanctions for juveniles were supervision by social assistance authority (56.0%) and reprimand (20.0%). Eleven juveniles were put in prison for juveniles and seven juveniles were fined.

METODOLOŠKA POJASNILA

Podatki o storilcih kaznivih dejanj so rezultat rednih letnih statističnih raziskovanj s področja statistike kriminalitete. V tej številki Statističnih informacij objavljamo le rezultate raziskovanj o obtoženih polnoletnih in mladoletnih osebah, zoper katere je bil kazenski postopek pred senatom pravnomočno končan.

Namen statističnih raziskovanj

Kriminalitete je ugotavljanje obsega, teritorialne razpršenosti in drugih značilnosti tega družbeno negativnega pojava.

Enote opazovanja

so storilci kaznivih dejanj. Kadar je pri storitvi enega kaznivega dejanja udeleženih več oseb, je enota opazovanja vsak udeleženec posebej. Če stori ena oseba več kaznivih dejanj, spremjamamo kot lastnost storilca samo glavno kaznivo dejanje.

Viri

Podatke zbiramo z individualnimi statističnimi vprašalniki, ki jih izpolnjujejo okrožna državna tožilstva ter okrožna in okrajna sodišča.

Zajetje

Kriminalitete kot družbeno negativnega pojava je popolno, saj so v statističnih raziskovanjih upoštevani vsi storilci kaznivih dejanj ter tudi kazniva dejanja neznanih storilcev.

Način zbiranja podatkov

Statistični vprašalnik izpolni poročevalska enota, ki je po zakonskih predpisih pristojna za vodenje postopka, takoj ko je postopek pravnomočno končan. To pomeni, da se enota opazovanja ugotavlja s trenutkom pravnomočnosti, število teh enot pa ugotavljamo z obdelavo podatkov. Ta poteka letno za vsako koledarsko leto.

METHODOLOGICAL EXPLANATIONS

Data on perpetrators of criminal offences are the result of regular annual statistical surveys in the field of crime statistics. This issue of Rapid Reports brings only results of surveys of accused adults and juveniles against whom criminal proceedings through a senate have been legally concluded.

The purpose of the statistical survey

is to establish the extent, territorial dispersion and other characteristics of this negative social phenomenon.

Observation units

are perpetrators of criminal offences. When more than one perpetrator participated in committing one criminal offence, each participant is a separate observation unit. If one perpetrator committed several criminal offences, the attribute of the perpetrator is only the main criminal offence.

Sources

Data are collected by individual statistical questionnaires filled in by regional public prosecutor's offices and by regional and district courts.

Coverage

Crime as a negative social phenomenon is fully covered since statistical surveys encompass all perpetrators of criminal offences as well as criminal offences committed by unknown perpetrators.

Method of data collection

Statistical questionnaires are filled in by reporting units legally authorised for conducting the proceedings as soon as they are legally concluded. Data collection at the moment of legal conclusion means that this moment defines the observation unit. The number of these units is determined by data processing, which is performed once a year.



Definicije

Kriminaliteta je v zvezi s statističnimi raziskovanji skupen izraz za pojav od vložitve ovadbe za storjeno kaznivo dejanje do pravnomočnega dokončanja postopka pri pristojnem organu.

Kaznivo dejanje je protipravno dejanje, ki ga zakon zaradi njegove nevarnosti določa kot kaznivo dejanje in hkrati določa njegove znake (Kazenki zakonik, 7. člen). V tabelah 3 in 6 so prikazana po ožji klasifikaciji (skupina kaznivih dejanj), ki se nanaša na Kazenski zakonik (Ur. I. RS 40/2004). V primerih, ko so bile osebe obravnavane za storjena kazniva dejanja, ki sta jih določala Kazenski zakon SRS (Ur. I SRS 12/77) in Kazenski zakon SFRJ (Ur. I. SFRJ 44/76), so bili podatki po skupinah kaznivih dejanj preurejeni v skladu s Kazenskim zakonikom.

Polnoletni storilci kaznivih dejanj so osebe, ki so ob storitvi kaznivega dejanja že dopolnile 18 let. **Mladoletni storilci** pa so osebe, ki so ob storitvi kaznivega dejanja že dopolnile 14, ne pa še 18 let.

Pri polnoletnih storilcih kaznivih dejanj se kot **prejšnje obsodbe** upoštevajo vse prejšnje obsodbe po dopolnjeni polnoletnosti, od obsodb iz časa mladoletnosti pa le obsodbe na mladoletniški zapor ali na denarno kazen. Pri mladoletnih storilcih pa se kot **prejšnje obravnave** upoštevajo tiste, po katerih sta bila mladoletniku izrečena vzgojni ukrep ali kazen.

KOMENTAR

V letu 2006 je bilo največ obsodb izrečenih polnoletnim storilcem kaznivih dejanj, in sicer za storjena dejanja iz naslednjih skupin kaznivih dejanj:

- zoper premoženje (43,0 %), med katerimi so prevladovale tativne (33,7 %), velike tativne (21,9 %), goljufije (19,7 %) in poškodovanja tujih stvari (6,5 %);
- zoper življenje in telo (10,3 %), med katerimi sta prevladovali lahka in huda telesna poškodba (74,2 % in 16,0 %);
- zoper človekove pravice in svoboščine (9,0 %), med katerimi sta prevladovali ogrožanje varnosti (67,0 %) in grdo ravnanje (23,8 %).

305 polnoletnim obsojenim osebam je bila vzporedno z glavno kazensko sankcijo izrečena še stranska kazen, in sicer 148 osebam izgon tuja iz države, 58 osebam prepoved vožnje motornega vozila in 99 osebam denarna kazen.

Varnostni ukrep je bil izrečen 447 polnoletnim obsojencem (brez samostojnega varnostnega ukrepa), najpogosteje je šlo za odvzem predmetov (78,0 %).

Mladoletniki, ki sta jim bila v letu 2006 izrečena vzgojni ukrep ali kazen, so najpogosteje storili kazniva dejanja zoper premoženje (65,7 %); med temi so prevladovala kazniva dejanja velike tativne (43,1 %), tativne (26,2 %), ropi (7,4 %) in poškodovanja tujih stvari (8,0 %).

Mladoletniki, ki sta jim bila v letu 2006 izrečena vzgojni ukrep ali kazen, so kar v 58,5 % primerov storili kazniva dejanje v soudeležbi, in sicer

Definitions

Statistical research of **crime** ranges from the filing of the charge for a criminal offence to the conclusion of the legal proceedings at the competent body.

Criminal offence is an unlawful activity, which is because of its danger defined and described by the law as a crime (Penal Code, Article 7). Criminal offences in Tables 3 and 6 are shown by a narrower classification (group of criminal offences), which refers to the Penal Code (Official Journal of the RS, No. 40/2004). In cases when persons were tried for committing criminal offences as defined by the Penal Code of the RS (OJ of the Socialist Republic of Slovenia, No. 12/77) and Penal Code of the Socialist Federal Republic of Yugoslavia (OJ of the Socialist Federal Republic of Yugoslavia, No. 44/76), the offences were treated in accordance with the Penal Code.

Adult perpetrators are persons who had completed 18 years of age before the criminal offence was committed. **Juvenile perpetrators** are persons who had completed 14 years of age before the criminal offence was committed but had not completed 18 years of age.

For adult perpetrators **previous convictions** are all previous convictions after they completed 18 years of age and for the time prior to their completing 18 years of age only convictions to a prison for juveniles or a fine. For juvenile perpetrators **previous convictions** are all convictions to an educational measure or a sentence.

COMMENT

In 2006 most sentences for criminal offences that were imposed on adult perpetrators were from the following groups of criminal offences:

- against property (43.0%), where thefts (33.7%), grand thefts (21.9%), frauds (19.7%) and damages of property of another (6.5%) predominated,
- against life and body (10.3%), where causing light and severe bodily harm (74.2% and 16.0% respectively) predominated,
- against human and civil freedoms and rights (9.0%), where security threat (67.0%) and maltreatment (23.8%) predominated.

Parallel to the main penal sanction 305 adults were imposed secondary sanctions; of those 148 foreigners were deported from Slovenia, 58 persons were forbidden to drive a motor vehicle and 99 persons were fined.

Security measures were imposed on 447 adults, in most cases this meant dispossession of objects (78.0%).

Juveniles against whom an educational measure or a sentence was imposed in 2006 were in most cases guilty of criminal offences against property (67.7%), where grand thefts (43.1%), thefts (26.2%), robberies (7.4%) and damage of property of another (8.0%) predominated.

In 2006, juveniles against whom an educational measure or a sentence was imposed were in 58.5% of cases participants, in most cases the
