



BRUTO DOMAČI PROIZVOD, TEMELJNI AGREGATI NACIONALNIH RAČUNOV IN ZAPOSLENOST, 2000–2004
GROSS DOMESTIC PRODUCT, MAIN AGGREGATES OF NATIONAL ACCOUNTS AND EMPLOYMENT, 2000–2004

- ▶ Zaradi razporeditve posredno merjenih storitev finančnega posredništva po uporabnikih teh storitev sta BDP in BND v povprečju nominalno za okoli 1% večja.
- ▶ Zaradi uvedbe obračuna v stalnih cenah preteklega leta in razporeditve posredno merjenih storitev finančnega posredništva se nove stopnje realne rasti BDP v obdobju 2000-2003 po posameznih letih razlikujejo od doslej objavljenih za največ 0,2 odstotne točke.
- ▶ Nove ocene stopnje gospodarske rasti oziroma BDP so: za leto 2000 4,1 % (prej 3,9 %), za leto 2001 2,7 % (prej 2,7 %), za leto 2002 3,5 % (prej 3,3 %) in za leto 2003 2,7 % (prej 2,5 %).
- ▶ V letu 2004 je BDP v tekočih cenah znašal 6 251 244 mio SIT, v cenah preteklega leta pa 6 055 773 mio, kar je realno za 4,2 % več kot leto prej.
- ▶ V EUR je BDP v tekočih cenah leta 2004 po novi oceni znašal 26 171 mio (prej 25 919 mio) in na prebivalca 13 103 EUR (prej 12 977 EUR).
- ▶ V letu 2004 je bruto nacionalni dohodek ocenjen na 6 193 539 mio SIT oziroma 99,1 % BDP in v letu 2003 na 5 777 403 mio SIT oziroma 99,4 % BDP.
- ▶ V letu 2004 se je skupno domače trošenje realno povečalo za 4,6 % (leto prej za 4,7 %), od tega najbolj bruto investicije, za 9,2 % (leto prej za 10,1 %) in bistveno manj končna potrošnja, za 3,1 % (leto prej za 3,0 %).
- ▶ Trošenje gospodinjstev se je leta 2004 realno povečalo za 3,3 %, kar je za 0,2 odstotne točke manj kot leto prej (3,5 %).
- ▶ Skupni izvoz proizvodov in storitev se je v letu 2004 realno povečal za 12,5 % (leto prej za 3,1 %) in uvoz za 13,2 % (leto prej za 6,7 %).
- ▶ Prispevek salda menjave proizvodov in storitev s tujino k realni rasti BDP je bil leta 2003 in 2004 negativen: leta 2003 dve odstotni točki, leta 2004 pa le še 0,4 odstotne točke.
- ▶ Zaloge so se v zadnjih dveh letih po obsegu bistveno povečale, saj je bil prispevek k realni rasti BDP velik, leta 2003 0,8 odstotne točke in lani 0,9 odstotne točke.
- ▶ V letu 2004 je znašal skupni tekoči primanjkljaj v transakcijah s tujino (B.9 Neto izposojanje) 119 773 mio SIT oziroma 1,9 % BDP, kar je bistveno več kot leto prej (17 662 mio SIT oziroma 0,3 % BDP).
- ▶ Pogoji menjave s tujino so bili leta 2003 pozitivni (indeks 100,8), v letu 2004 pa zaradi rasti uvoznih cen naftnih derivatov in cen nekaterih surovin negativni (indeks 98,8).
- ▶ Implicitni BDP deflator je za leto 2004 ocenjen z indeksom 103,2 (za skupno domače trošenje 104,0), kar je precej manj kot leto prej, ko je bil za implicitni BDP deflator indeks 105,8 (za skupno domače trošenje 105,2).
- ▶ Z letom 2002 so zaposleni, ki delujejo na podlagi pogodbenega dela in dela po avtorskih pogodbah, vključeni v oceno zaposlenosti po nacionalnih računih; leta 2004 je bilo tako skupno zaposlenih 914,3 tisoč, kar je za 0,4 % več kot leto prej (910,5 tisoč).
- ▶ The allocation of financial intermediation services indirectly measured by user sectors increases GDP and GNI level in nominal terms by approximately 1%.
- ▶ Due to the introduction of the calculation at constant previous year prices and allocation of financial intermediation services indirectly measured by user sectors, new GDP volume growth rates in the 2000-2003 period differ from the rates published so far by 0.2 percentage point at the most.
- ▶ New estimates for the GDP volume growth rates are: in 2000 4.1% (before 3.9 %), in 2001 2.7% (before 2.7%), in 2002 3.5% (before 3.3%) and in 2003 2.7% (before 2.5%).
- ▶ In 2004 GDP at current prices is estimated at SIT 6 251 244 mio and at constant previous year prices at SIT 6 055 773 mio and the aggregate is in real terms 4.2% bigger than a year ago.
- ▶ Valued at EUR, 2004 GDP at current prices by new estimates equals to mio 26 171 (before mio 25 919) and per capita to EUR 13 103 (before EUR 12 977).
- ▶ In 2004 gross national income is estimated at SIT 6 193 539 mio or 99.1% of GDP and in 2003 at SIT 5 777 403 mio or 99.4% of GDP.
- ▶ In 2004 the total domestic uses in volume increased by 4.6% (a year before by 4.7%), of which the most gross capital formation by 9.2% (a year before by 10.1%) and final consumption significantly less, by 3.1% (a year before by 3.0%).
- ▶ Household consumption in 2004 increased in volume terms by 3.3% and 0.2 percentage point less than a year ago (3.5%).
- ▶ Total exports of goods and services in real terms in 2004 increased by 12.5% (a year before by 3.1%) and imports by 13.2% (a year before by 6.7%).
- ▶ Contribution of surplus on goods and services transaction with the rest of the world to real GDP growth was in 2003 and 2004 negative: in 2003 two percentage points and in 2004 only 0.4 percentage point.
- ▶ In volume terms changes in inventories increased in the last two years significantly and their contribution to real GDP growth was relatively important: in 2003 0.8 percentage point and in 2004 0.9 percentage point.
- ▶ In 2004 the total deficit in transaction with the rest of the world (B.9 Net borrowing) amounted to SIT 119 773 mio or 1.9% of GDP and significantly above the values in 2003 (SIT 17 662 mio or 0.3% of GDP).
- ▶ Terms of trade with the rest of the world were in 2003 positive (index 100.8) and in 2004 negative (index 98.8) due to the increase of import prices of oil derivatives and some raw materials and supplies.
- ▶ Implicit GDP deflator in 2004 is estimated at index 103.2 (for total domestic consumption 104.0) and this is significant less than a year ago, 105.8 for GDP (for total domestic consumption 105.2).
- ▶ Employment according to part-time contract work is in national accounts aggregate included in 2002; total employment in 2004 is estimated at 914 300 or 0.4% more than a year ago (910 500).

METODOLOŠKA POJASNILA

Viri in metode zbiranja podatkov

Glavni viri podatkov so letni zaključni računi in bilance gospodarskih družb ter organizacij, letni podatki davčnih služb o poslovanju fizičnih oseb, statistična raziskovanja, davčne evidence, finančna statistika, plačilna bilanca Banke Slovenije ter drugi viri.

Zajetje

V obračun so zajete vse dejavnosti v skladu s konceptom proizvodnje po Sistemu nacionalnih računov iz leta 1993 (SNR 93) in Evropskega sistema nacionalnih in regionalnih računov iz leta 1995 (ESR 95).

Definicije

Proizvodnja je enaka vrednosti dokončanih proizvodov in opravljenih storitev od začetka do konca leta in je vrednotena v osnovnih cenah. Iz vrednosti proizvodnje v osnovnih cenah so izločeni vsi davki na proizvode in storitve, vanjo pa so vključene vse subvencije po proizvodih in storitvah. Proizvodnjo sestavljajo proizvodnja za trg, proizvodnja za lastno končno porabo in druga netržna proizvodnja (proizvodnja individualnih storitev države in neprofitnih institucij storitev gospodinjstvom in proizvodnja kolektivnih storitev države). Proizvodnja in hkrati vmesna potrošnja po dejavnostih v nacionalnih računih vključujeta vrednost inputov v dodelavnih poslih in sta po dejavnostih prikazani po dejavnosti obrata. Vsi sektorji so po dejavnostih prikazani na ravni dejavnosti enote, vključno z neprofitnimi institucijami storitev za gospodinjstva (NPISG), ki so bile doslej kot ena dejavnost prikazane v okviru področja O Druge javne, skupne in osebne storitve.

Vmesna potrošnja je vrednotena v cenah kupcev kot vrednost proizvodov in storitev, ki jih posamezni proizvajalec nabavi zato, da proizvede druge proizvode in storitve. Vključeni so vsi proizvodi, katerih življenjska doba je manj kot eno leto, in proizvodi vredni do 500 evrov, in z daljšo življenjsko dobo ter storitve tekočih popravil in vzdrževanja, ki ne povečujejo osnovne vrednosti in življenjske dobe osnovnih sredstev.

Dodana vrednost v osnovnih cenah je enaka proizvodnji v osnovnih cenah, zmanjšani za vmesno potrošnjo v cenah kupcev. Dodana vrednost v osnovnih cenah je tudi enaka vsoti sredstev za zaposlene, plačanim drugim davkom na proizvodnjo, zmanjšanim za prejete druge subvencije na proizvodnjo ter vsoti bruto poslovnega presežka in bruto raznovrstnega dohodka.

Med davke na proizvode in storitve so vključene vse carine in uvozne dajatve, davek na dodano vrednost, posebni prometni davki po proizvodih in storitvah, trošarinske dajatve na naftne derivate, cigarete, alkohol, davki na igre na srečo in igralne avtomate ter davki na transakcije nepremičnin. Davek na dodano vrednost kot obračunska kategorija je enak vrednosti davka, ki se obračunava pri uvozu po carinskih deklaracijah, in neto obveznosti oziroma plačilu davčnih zavezancev v sistemu davka na dodano vrednost v obračunskem obdobju. Obračunska vrednost davka na dodano vrednost je zmanjšana za negativno kompenzacijo, ki se obračuna za kmete v sistemu pavšalnega nadomestila (4 %). Negativna kompenzacija je enaka vrednosti 4 odstotnega pavšalnega nadomestila v obračunskem obdobju, pomnoženem z razliko med pavšalno davčno stopnjo (4 %) in izvedeno davčno stopnjo. Izvedena davčna stopnja je enaka davku na dodano vrednost, ki ga kmetje plačujejo na inpute proizvodnje (vmesno potrošnjo in bruto investitije v osnovna sredstva) glede na vrednost prodaj, za katere kmetje v sistemu pavšalnega nadomestila ne obračunavajo davka na dodano vrednost (prodaje v okviru 4 % pavšalnega nadomestila in vrednost proizvodnje za lastno končno potrošnjo in neposredne prodaje gospodinjstvom).

METHODOLOGICAL EXPLANATIONS

Sources and methods of data collection

The main sources of data are annual final accounts and balances of companies and organisations, annual data of tax authorities on operation of unincorporated enterprises and self-employed persons, basic statistical surveys, tax records, financial statistics, balance of payments of the Bank of Slovenia and other sources.

Coverage

The calculation covers all activities following the concept of production by the 1993 System of National Accounts (SNA 93) and the 1995 European System of Accounts (ESA 95).

Definitions

Output equals the value of finished products and performed services from the beginning to the end of the year and valued at basic prices. Output at basic prices includes subsidies on products without any taxes on products. Output includes market output, output for own final use and other non-market output (output of individual non-market services produced by government and non-profit institutions serving households and output of collective services produced by government). Output as well as intermediate consumption by activities in national accounts includes all inputs for processing work. In national accounts output by activities is shown according to the activity of establishments. All sectors are shown by activity at unit level including NPISH's, which used to be shown as one activity within section O Other community, social and personal services.

Intermediate consumption is given at purchaser's prices as the value of goods and services which are purchased by an individual producer in order to produce other goods and services. These comprise all products with the life time up to one year and value up to ECU 500 if the life time is over one year, and services of current repair and maintenance which do not increase the value and life time of fixed assets.

Value added at basic prices equals the output at basic prices, reduced by intermediate consumption at purchaser's prices. Value added at basic prices also equals the sum of compensation of employees, other taxes on production, less other subsidies on production, and the sum of gross operating surplus and gross mixed income.

Taxes on products are all taxes and import duties, value added tax, special taxes by goods and services, special duties on petrol, cigarettes, alcohol, gambling and slot machines, and taxes on real estate transactions. Value added tax as an accrual category equals to the tax due at imports according to custom declarations and net payments due in the period by units in the system of value added tax. Accrual value added tax is reduced by negative compensation, which is estimated for farmers within the 4% flat-rate system. Negative compensation equals the value of 4% flat-rate compensation in the accounting period multiplied by the difference between the 4% flat-rate and the derived rate. The derived rate equals value added tax collected on inputs of flat-rate farmers (intermediate consumption and gross fixed capital formation) according to the value of all sales for which flat-rate farmers do not collect value added tax (sales within the 4% flat-rate system and the value of own-account production for final consumption of farmers and direct sales to households final consumption).

Drugi davki na proizvodnjo so davki, ki jih podjetja plačujejo za uporabo določenih osnovnih sredstev, in davki na delovno silo kot dejavnik proizvodnje. Med drugimi davki na proizvodnjo je tudi negativna kompenzacija kmetov, ki so v sistemu pavšalnega nadomestila.

Subvencije po proizvodih in storitvah so nepreklicna plačila tržnim proizvajalcem s strani državnih institucij. Subvencije po proizvodih in storitvah vključujejo subvencije v kmetijstvu in proizvodnji hrane ter subvencije cen potniškega prometa v železniškem prometu.

Bruto domači proizvod je enak dodani vrednosti v osnovnih cenah po dejavnostih, povečani za davke na proizvode in storitve in zmanjšani za subvencije po proizvodih in storitvah. Bruto domači proizvod je tako enak vsoti dodane vrednosti v osnovnih cenah vseh domačih (rezidenčnih) proizvodnih enot in neto davkov na proizvode in storitve (davki na proizvode in storitve, zmanjšani za subvencije po proizvodih in storitvah). Bruto domači proizvod po izdatkovni metodi je enak skupni domači potrošnji in saldu menjave blaga s tujino. Domačo potrošnjo sestavljajo izdatki rezidenčnih gospodinjstev za potrošnjo (nacionalni koncept), izdatki neprofitnih institucij storitev gospodinjstvom in države za končno potrošnjo ter bruto investicije. Bruto domači proizvod po dohodkovni metodi je enak vsoti sredstev za zaposlene, neto davkov na proizvodnjo (davki na proizvodnjo minus subvencije na proizvodnjo) in bruto poslovnega presežka in raznovrstnega dohodka.

Potrošnja stalnega kapitala je v oceni BDP upoštevana po podatkih zaključnih računov in bilanc podjetij in organizacij. V stanovanjski dejavnosti gospodinjstev in za sektor skupne države je potrošnja stalnega kapitala ocenjena z metodo stalne inventarizacije. Potrošnja stalnega kapitala za sektor države vključuje tudi ceste, mostove in drugo cestno javno infrastrukturo, razen avtocest. Potrošnja stalnega kapitala za avtoceste in pripadajočo infrastrukturo je po metodi stalne inventarizacije obračunana posebej in prikazana v sektorju nefinančnih družb (Družba za avtoceste Republike Slovenije, d. o. o. - 75.1 Dejavnost javne uprave ter ekonomska in socialna politika).

Sredstva za zaposlene so bruto plače in osebni prejemki zaposlenih ter prispevek delodajalcev za socialno varnost zaposlenih. Prispevek delodajalcev za socialno varnost vključujejo dejanske prispevke delodajalcev (obvezne in prostovoljne) in pripisane prispevke delodajalcev. Pripisani prispevki vključujejo vsa nadomestila plač za čas odsotnosti z dela zaradi bolezni, nesreč ipd., ki jih izplačuje delodajalec. Osebne prejemke sestavljajo denarna nadomestila zaposlenim za hrano, prevoz na delo in z dela in regresi za letni dopust. Vsa bruto plačila delodajalcev za pogodbene, začasne in enkratne zaposlitve so od vključno leta 2002 dalje prikazana v vmesni potrošnji. V obrambnih storitvah so vsi izdatki za prehrano vojakov sestavni del sredstev za zaposlene. Osebni prejemki vključujejo oceno napitnin v gostinskih in osebnih storitvenih dejavnostih ter oceno zasebne rabe službenih vozil. Zasebna raba službenih vozil je ocenjena v obsegu 30 % vrednosti nabav novih vozil, stroškov goriv ter tekočega vzdrževanja in popravil ter stroškov najema vozil t. i. poslovnega sektorja (brez vozil v lasti skupne države, NPISH, javnega sektorja in iz sistema davka na dodano vrednost izvetih sektorjev). Iz stroškov podjetij po administrativnih virih so izločena vsa denarna nadomestila za službena potovanja (dnevnice in kilometrine), ki po ESR 95 predstavljajo »hrano in pijače« na službenem potovanju kot kategorijo sredstev za zaposlene.

Poslovni presežek je rezidualna kategorija dodane vrednosti v finančnih in nefinančnih gospodarskih družbah ter v stanovanjski dejavnosti v okviru gospodinjstev. V stanovanjski dejavnosti gospodinjstev, ki živijo v lastnih stanovanjih (pripisana najemina), je neto poslovni presežek ocenjen v višini 2,5 % neto vrednosti stanovanj (po stroških gradnje) in vrednosti pripadajočega zemljišča (v povprečju 18 % vrednosti stanovanj). Poslovni presežek je lahko prikazan kot neto ali bruto vrednost skupaj s potrošnjo stalnega kapitala. V netržnih dejavnostih je bruto poslovni presežek enak obračunani potrošnji stalnega kapitala.

Other taxes on production are taxes which are paid by enterprises for the use of certain fixed assets, and taxes on labour force as production input. Other taxes on production include negative compensation of flat-rate farmers.

Subsidies on products are irrevocable payments to market producers, made by government institutions. The category includes subsidies on products in agriculture and food manufacturing and price subsidies of passenger transport by railway.

Gross domestic product equals value added at basic prices by activities, increased by taxes on products, and reduced by subsidies on products. Gross domestic product thus equals the sum of value added at basic prices of all domestic (resident) production units and net taxes on products (taxes less subsidies on products). By expenditure approach, gross domestic products equals total domestic consumption and surplus of exports and imports of goods and services with the rest of the world. Domestic consumption includes resident households expenditures (national concept), expenditures of non-profit institutions serving households and general government and gross capital formation. Gross domestic product by income approach equals the sum of compensation of employees, net taxes on production (taxes on production less subsidies on production) and gross operating surplus and mixed income.

Consumption of fixed capital is in the estimation of gross domestic product taken from the data in final accounts and balances of enterprises and organisations. In households' housing activity and for general government consumption of fixed capital it is estimated by the perpetual inventory method. Consumption of fixed capital in general government includes roads, bridges and other public road transport infrastructure, except motorways. Consumption of fixed capital for motorways and similar infrastructure is estimated by the perpetual inventory method separately and is included in the sector of non-financial corporations (Motorway Company of the Republic of Slovenia LTD. - 75.1 Administration of the State, economic and social policy).

Compensation of employees is gross wages and salaries and employers' social contributions. Employers' social contributions include actual (compulsory and voluntary) and imputed social contributions. Imputed social contributions comprise payments by employer to employees during the absence from work due to sickness, accidents, etc. Personal allowances comprise expenses for food, transport to and from work and reimbursement for annual vacation. All gross payments of employers for contract, temporary or part-time employment are from 2002 on included in intermediate consumption. In defence services all expenditure on soldiers' food is part of compensation of employees. Gross wages and salaries include tips in restaurants and personal services as well as estimation of private use of business cars. Private use of business cars as wages and salaries in kind is estimated at 30% of total purchases of new personal cars, fuel costs and current maintenance expenses together with all rental payments for personal cars of the so called business sector (without personal cars of general government, NPISH's, other public sectors and value added tax exempt sectors). All cash payments and allowances to employees for business travel are excluded from data on enterprise costs in administrative sources and as "food and beverages" on travel according to ESA 1995 included in compensation of employees.

Operating surplus is the residual category of value added in financial and non-financial corporations and in housing activities of households. In households' housing activity of owner-occupiers (imputed rent) net operating surplus is estimated at 2.5% of total net value of dwellings together with value of relevant land value (on average 18% of total dwellings value). The category operating surplus can be shown either as net or gross, together with consumption of fixed capital. In non-market activities, gross operating surplus equals the consumption of fixed capital.

Raznovrstni dohodek je rezidualna kategorija v obračunu dodane vrednosti samozaposlenih oseb in nekorporativnih podjetij. Kategorija je lahko prikazana kot neto ali bruto vrednost skupaj s potrošnjo stalnega kapitala.

Izdatke za končno potrošnjo sestavljata agregata **individualni izdatki za potrošnjo** in **kolektivni izdatki države za potrošnjo**. **Individualno potrošnjo** sestavljajo **izdatki za končno potrošnjo gospodinjstev, izdatki neprofitnih institucij storitev gospodinjstvom (NPISG) in individualni izdatki države**. Individualne izdatke države sestavljajo izdatki za netržne storitve države (izobraževanje, zdravstvo, socialno skrbstvo, kultura, šport itd.) in transferji tržnih proizvodov in storitev v naravi preko tržnih proizvajalcev za gospodinjstva (zdravila, ortopedski pripomočki, koncesijske pravice zasebnemu in javnemu tržnemu sektorju, storitve zdravilišč ipd.). **Kolektivni izdatki države** so izdatki za upravne, administrativne, obrambne, ekonomske, razvojno-raziskovalne in druge skupne netržne storitve države. Državni izdatki za netržne storitve in izdatki NPISG za končno potrošnjo so enaki razliki med vrednostjo proizvodnje po stroškovni metodi in vrednostjo prodaj.

Bruto investicije so sestavljene iz **bruto investicij v osnovna sredstva, sprememb v zalogah ter neto nabav vrednostnih predmetov in umetnin**. Bruto investicije v osnovna sredstva so sestavljene iz investicij v nova osnovna sredstva, stroškov transakcij rabljenih osnovnih sredstev, iz nabav nematerialnih osnovnih sredstev in povečanja vrednosti neproizvedenih nefinančnih sredstev.

Spremembe v zalogah so obračunane za nedokončano proizvodnjo in dokončane proizvode pri proizvajalcih, zaloge trgovskega blaga v trgovini in zaloge surovin, materiala, rezervnih delov ipd. pri vseh proizvajalcih.

Kategoriji **izvoz in uvoz** proizvodov zajemata izvoz in uvoz proizvodov v zvezi z oplemenitvenjem po bruto načelu. Izvozna vrednost proizvodov je obračunana po pariteti FOB, uvozna vrednost je po podatkih Banke Slovenije iz paritete CIF, zmanjšana na pariteto FOB. Podatki o izvozu in uvozu storitev so povzeti iz plačilne bilance po podatkih in metodologiji Banke Slovenije.

Zaposleni zajemajo vse stalno zaposlene osebe po domačem konceptu ter samozaposlene osebe in pomagajoče družinske člane v zasebnem kmetijstvu in samozaposlene v drugih dejavnostih gospodinjstev. Zaposlitev po nacionalnih računih vključuje študentsko delo in druge oblike začasne zaposlenosti, zaposlenost v pomorskem transportu na naših ladjah in zaposlenost v naših diplomatskih in konzularnih predstavništvih v tujini, podjetja brez zaposlenih ipd. Osnovni vir za oceno zaposlenosti je Statistični register delovno aktivnega prebivalstva, ki je na ravni enote povezan z administrativnimi viri za oceno dodane vrednosti po dejavnostih.

Fiskalne obremenitve sestavljajo **davki in socialni prispevki** po podatkih finančne statistike (Letnega poročila o vplačilih in razporeditvah javnih prihodkov ter drugih statističnih virov Agencije Republike Slovenije za plačilni promet, Statistike javnih financ Ministrstva za finance in letnih poročil o davku na dodano vrednost Davčne uprave RS ter podatkov po carinskih deklaracijah), pri čemer so na podlagi virov davki in socialni prispevki ocenjeni kot obračunske kategorije. Vse fiskalne kategorije, razen davkov na proizvode in storitve ter socialnih prispevkov, vključujejo zamudne obresti pri vplačilih. V kategorijo **davkov** so poleg **davkov na proizvodnjo in uvoz** vključeni **tekoči davki na dohodke in premoženje ter davki na kapital**. V okviru tekočih davkov na dohodke in premoženje so ključne kategorije **davki na dohodke gospodinjstev in na dobičke gospodarskih družb ter drugi tekoči davki**. **Prispevki za socialno varnost kot fiskalni prihodki države** vključujejo dejanske (obvezni in prostovoljni prispevki delodajalcev, zaposlenih, samozaposlenih in nezaposlenih) in pripisane prispevke delodajalcev. Pripisani prispevki vključujejo vsa plačila državnih institucij kot delodajalca zaposlenim v času odsotnosti z dela zaradi bolezni, nesreč ipd.

Mixed income is the residual category in the calculation of value added of self-employed persons and unincorporated enterprises of households. The category can be shown either as net or gross, together with consumption of fixed capital.

Final consumption expenditure is composed of the aggregates **individual consumption expenditure** and **collective government consumption expenditure**. **Individual consumption** is composed of **expenditure of households, non-profit institutions serving households (NPISHs) and individual government expenditure**. Individual government expenditure comprises payments for non-market government services (education, health, social care, culture, sport, etc.) and transfers in kind by general government to households via market producers of market goods and services (pharmaceutical and therapeutical products, concessions to private and market public sector, health resort services, etc.). **Collective government expenditure** consists of expenditure on administrative, defence, economic, R&D and other non-market government services. Government and NPISHs final consumption expenditures are calculated as the difference between the output value by the cost method and sales.

Gross capital formation is composed of **gross fixed capital formation, increase in stocks and acquisitions less disposals of valuables**. Gross fixed capital formation consists of investments into new fixed assets, costs of transactions of existing fixed assets and additions to the value of non-produced assets.

Increase in stocks is calculated for work-in-progress and finished goods at producers, stocks of trade goods in stores, and stocks of raw material, spare parts, etc., at all producers.

Exports and imports of goods cover exports and imports of goods in connection with processing by gross principle. The export value of goods is calculated by FOB and the import value of goods has been reduced from CIF to FOB according to the data supplied by the Bank of Slovenia. Exports and imports of services are taken from the balance of payments according to the data and methodology of the Bank of Slovenia.

Employment covers all permanently employed persons according to the domestic concept, and self-employed persons together with unpaid family workers in agriculture and self-employed persons in other household activities. Employment in national accounts also covers student work and other forms of part-time employment, employment in transport by sea on our ships, diplomatic and consular representatives abroad, enterprises without employment, etc. Basic source is the Statistical Register of Employment, which is at unit level linked with administrative sources for estimation of value added by activities.

The fiscal burden comprises **taxes and social contributions** according to financial statistics data (Annual Report on Public Revenues and other statistical sources of the Agency for Payments, Government Finance Statistics of the Ministry of Finance and data on annual reports of units within the value added tax system of the Tax Administration of RS). Taxes and social contributions are estimated on accrual basis. Except taxes on products and social contributions, all values of other categories of taxes and social contributions include also interest for delay payments. The category of **taxes** includes **taxes on production and imports, current taxes on income and wealth** and **capital taxes**. Current taxes on income and wealth are further divided into **taxes on income of households and on profits of corporations** and **other current taxes**. **Social contributions as fiscal income of general government** include actual (compulsory and voluntary social contributions of employers, employees, self-employed and un-employed) and imputed employers' social contributions. Imputed employers' social contributions comprise all payments of general government institutions as employer to employees during the absence from work due to sickness, accidents, etc.

KOMENTAR

Podatki o bruto domačem proizvodu (BDP) in bruto nacionalnem dohodku (BND) v tej publikaciji so revidirani in se od doslej objavljenih razlikujejo predvsem za posredno merjene storitve finančnega posredništva (PMSFP); te so zdaj razporejene končnim uporabnikom teh storitev. Gre za metodološko novost, ki jo morajo statistični uradi v skladu z Evropskim sistemom računov 1995 uvesti v letošnjem letu. Učinek t.i. razporeditve PMSFP končnim uporabnikom je v povprečju nominalno za okoli 1 % večji BDP in BND.

Z razporeditvijo PMSFP je BDP leta 2004 v tekočih cenah ocenjen na 6 251 244 mio SIT (prej 6 191 161 mio SIT), od tega je vrednost PMSFP ocenjena 60 079 mio SIT oziroma 1 % BDP. Učinek razporeditve PMSFP neposrednim uporabnikom finančnih storitev je v obdobju največji leta 2000 (za 1,1 % večji BDP) in najmanjši v letih 2001 in 2002 (za 0,8 % večji BDP). Leta 2003 je zaradi razporeditve PMSFP BDP večji za 0,9 %. V EUR je BDP v tekočih cenah leta 2004 po novi oceni 26 171 mio (prej 25 919 mio), na prebivalca pa 13 103 EUR (prej 12 977 EUR).

Drugi denarni finančni posredniki (S.122) zaračunavajo strankam storitve neposredno, hkrati pa stranke oskrbujejo tudi s storitvami, za katere ustvarjajo dohodek posredno, in sicer z različnimi obrestnimi merami na depozite na eni in na posojila na drugi strani. Dohodek od razlik v obrestnih merah je v nacionalnih računih prikazan kot PMSFP. Razporeditev PMSFP po uporabnikih je bila v Statističnem uradu RS pripravljena v sodelovanju z Banko Slovenije; ta je posredovala vse potrebne podatke za obdobje od leta 1995 dalje. Obračun PMSFP po uporabnikih temelji na podatkih o stanjih depozitov in posojil po ročnosti ter po sektorjih konec posameznega obdobja ter ustreznih obrestnih merah in obračunanih obrestih. Obračun PMSFP temelji na t.i. referenčni obrestni meri za medbančna posojila. PMSFP za posojila računamo kot razliko med dejanskimi obrestmi in obrestmi, obračunanimi po referenčni obrestni meri, PMSFP na depozite pa kot razliko med obrestmi po referenčni obrestni meri in dejanskimi obrestmi na depozite. Obračun v stalnih cenah preteklega leta je za PMSFP narejen v dveh korakih. V prvem koraku so PMSFP tekočega leta preračunane na obresti (obrestne marže) preteklega leta. V drugem koraku so tako dobljene vrednosti deflacirane z indeksom cen domače končne potrošnje.

V tabelah 17 in 18 spodaj je prikazan učinek razporeditve PMSFP po uporabnikih finančnih storitev na BDP in njegove kategorije po proizvodni, dohodkovni in izdatkovni metodi v obdobju 2000-2004. Razporeditev PMSFP po proizvodni metodi povečuje proizvodnjo in bruto dodano vrednost v sektorju S.122 Drugi denarni finančni posredniki kot proizvajalca finančnih posrednih storitev, v preostalih tržnih sektorjih kot uporabnikih teh storitev pa se bruto dodana vrednost zmanjša za PMSFP; pri tem so PMSFP v vmesno potrošnjo po dejavnostih razporejene sorazmerno glede na bruto dodano vrednost. V končni potrošnji so PMSFP razporejene gospodinjstvom, državi in NPSIG. PMSFP, razporejene v končni potrošnji, povečane za izvoz in zmanjšane za uvoz PMSFP, so enake skupnemu učinku razporeditve PMSFP po sektorjih na BDP. PMSFP, razporejene netržnim sektorjem (S.13 Država in S.15 NPISG), hkrati povečujejo vmesno potrošnjo in izdatke sektorja za končno potrošnjo ob nespremenjeni bruto dodani vrednosti. Enak učinek razporeditve PMSFP je tudi v lastnih stanovanjskih storitvah lastnikov stanovanj oziroma v pripisani bruto stanarini. Ker je proizvodnja lastnih stanovanjskih storitev gospodinjstev ocenjena po stroškovnem načelu, razporeditev PMSFP (na posojila za nakupe in stanovanjsko gradnjo gospodinjstev) hkrati povečuje vmesno potrošnjo in proizvodnjo na eni ter izdatke gospodinjstev za končno potrošnjo na drugi strani.

Zaradi razporeditve PMSFP po uporabnikih bančnih storitev v proizvodnih računih je treba v računu primarnih dohodkov prihodke in odhodke iz obresti (D.41) ustrezno popraviti pri sektorju proizvajalcu (S.122 Drugi denarni finančni posredniki) in pri vseh drugih sektorjih kot

COMMENT

Data on gross domestic product (GDP) and gross national income (GNI) in this publication are revised. They differ from the data published so far mainly due to the financial intermediation services indirectly measured (FISIM), which are now allocated to the final users of these services. According to the European System of Accounts 1995, this methodological approach should be introduced in national accounts this year. The effect of FISIM being allocated to the final users is on average 1% higher GDP and GNI.

With FISIM being allocated GDP for 2004 is estimated at SIT 6 251 244 mio (before SIT 6 191 161 mio), of which FISIM SIT 60 079 mio or 1% of GDP. The effect of FISIM being allocated to the direct users of financial services is the highest in 2000 (1.1% higher GDP) and the smallest in 2001 and 2002 (0.8% of GDP). In 2003 this effect increased GDP by 0.9%. Valued at EUR and according to the new estimate, GDP at current prices in 2004 amounted to EUR 26 171 mio (before EUR 25 919 mio) and per capita EUR 13 103 (before EUR 12 977).

Other monetary financial institutions (S.122) charge customers for services directly and at the same time provide services for which they charge customers indirectly on the basis of differences in interest rates between loans and deposits. Revenue from the differences in interest rates is in national accounts shown as FISIM. FISIM allocation to user sectors has been in the Statistical Office prepared in cooperation with the Bank of Slovenia which collected all relevant data for the period since 1995. FISIM calculation by user sectors is based on data of deposits and loans by maturity and sectors with relevant interest rates and interest values. FISIM calculation is based on so called reference interest rate for intra bank loans. FISIM on loans is calculated as the difference between actual interest on loans and interest according to reference interest rate. FISIM on deposits equals the difference between interest according to the reference rates and actual interest on deposits. Calculation at constant previous year prices is done in two steps. In the first step current year FISIM is calculated in previous year interest rates (interest margins). In the second step values from the first step are deflated by implicit deflator for domestic final uses.

Tables 17 and 18 below show the effect of FISIM allocation to the users of financial services to the GDP and its output, expenditure and income components in the 2000-2004 period. On the output side, FISIM allocation increases output and gross value added of the sector S.122 Other monetary financial institutions as the producer of indirectly charged financial services. For other market sectors as users of these services, gross value added is decreased by FISIM where FISIM is being allocated to the intermediate consumption proportionally to the gross value added. In final consumption, FISIM is allocated to households, general government and NPISH. FISIM allocated to the final consumption plus exports of FISIM minus imports of FISIM equals total effect of FISIM allocation by sectors to the GDP. FISIM allocated to non-market sectors (S.13 General government and S.15 NPISH) increases intermediate consumption and final consumption expenditure of the sector at the same time while gross value added remains the same. FISIM allocation to the own-account housing services of households (imputed gross rent) has the same effect. Since the production of own-account housing services of households is estimated by the cost approach, allocation of FISIM (for loans for purchases and dwellings construction by households) increases intermediate consumption and output as well as the households' final consumption expenditure.

Following the FISIM allocation to the users of the financial services in the production accounts, appropriate corrections must be made for payments and receivables of interests (D.41) in the primary income account of producing sector (S.122 Other monetary financial institutions) and in the

primary income account of the users sectors. By FISIM on loans, actual interest payables by debtors must be reduced for the value of FISIM. By FISIM on deposits, actual interest receivables by creditors must be increased for the value of FISIM. Due to the imports and exports of FISIM, corrections must also be made in the rest of the world account for interest within property income flows (table 13).

V tej publikaciji prvič objavljamo tudi novost pri obračunu v stalnih cenah. Ta zdaj temelji na cenah preteklega leta. Tako opuščamo obračun v stalnih cenah na podlagi stalne letne baze cen (doslej 1995 in 2000) in uvajamo t.i. verižno ocenjevanje BDP v stalnih cenah. Ta metoda je bolj kakovostnejša, saj upošteva tekoče spremembe in relativna razmerja cen.

Podatki v cenah preteklega leta izražajo spremembe v obsegu, ki jih lahko prikazemo na tri načine, in sicer kot:

- stopnje rasti;
- verižne indekse (na podlagi referenčnega leta);
- verižne vrednosti (na podlagi referenčnega leta).

V tej publikaciji objavljamo stopnje rasti in v tabelah 3 in 6 tudi verižne vrednosti (referenčno leto 2000). Pri tem morajo uporabniki nacionalnih računov vedeti, da z uvedbo verižnega računanja BDP v stalnih cenah preteklega leta pri prikazovanju dolgoročnih serij vrednosti podatkov na podlagi referenčnega leta izgubimo seštevnost agregatov (razen pri podatkih za referenčno leto in za leto, ki sledi referenčnemu letu). To pomeni, da pri prikazovanju dolgoročnih verižnih serij vrednostnih podatkov o obsegu vsota posameznih komponent ni enaka skupnemu agregatu.

Zaradi razporeditve PMSFP po uporabnikih teh storitve in uvedbe obračuna v stalnih cenah preteklega leta se nove stopnje realne rasti BDP v obdobju 2000-2003 po posameznih letih razlikujejo od doslej objavljenih za največ 0,2 odstotne točke. Nove ocene stopnje gospodarske rasti oziroma BDP za posamezna leta tako znašajo: za leto 2000 4,1 % (prej 3,9 %), za leto 2001 2,7 % (prej 2,7 %), za leto 2002 3,5 % (prej 3,3 %) in za leto 2003 2,7 % (prej 2,5 %). Sedanja ocena realne rasti BDP za leto 2004 je 4,2 % in je za 0,4 odstotne točke nižja od doslej objavljenih (4,6 %). Glavni razlog nižje ocene realne stopnje rasti BDP v lanskem letu je v večji nominalni vrednosti revidirane ocene BDP za leto 2003 (za 0,3 %), pri čemer je sedanja ocena nominalne vrednosti BDP v letu 2004 glede na prejšnjo nespremenjena (brez PMSFP).

V okviru rednih letnih revizij BDP sta vrednost BDP v tekočih cenah leta 2002 in prva letna ocena vrednosti BDP za leto 2004 glede na doslejšnje ocene nespremenjeni. BDP v tekočih cenah za leto 2003 pa je po redni letni reviziji večji za okoli 0,3 %.

In this publication also constant previous year prices are being introduced. With this new approach, the practice of using fixed year base (so far 1995 and 2000) is abandoned. The quality of the new method is higher since it uses current changes and relative prices.

Data at the previous year prices reflect volume changes which can be presented in three ways:

- as the growth rates;
- as the chain indices (on the reference year basis);
- as the chained values (on the reference year basis).

In this issue of Rapid Reports growth rates and also referenced values (reference year 2000) are being published in Tables 3 and 6. In using these national accounts data, users must bear in mind that in constructing long time series on the reference year basis additivity is lost (except in the reference year and year following the reference year) and the sum of the components does not add up to the total.

Due to the FISIM allocation to the users of these services and to the introduction of the previous year as a base year for constant price estimates, new GDP volume growth rates in the 2000-2003 period differ from the rates published so far by 0.2 percentage points at the most. New estimates for the GDP volume growth rates are: in 2000 4.1% (before 3.9%), in 2001 2.7% (before 2.7%), in 2002 3.5% (before 3.3%) and in 2003 2.7% (before 2.5%). New estimate for 2004 is 4.2% and is lower from the previous estimate by 0.4 percentage point (4.6%). The main reason for lower estimate for 2004 is higher new GDP estimate for 2003 (0.3%), while the new GDP estimate for 2004 is the same as the previous one (without FISIM effect).

By routine annual revision work values of GDP at current prices for 2002 and the first estimate for 2004 are unchanged, but GDP for 2003 is increased by approximately 0.3%.

V okviru rednih letnih revizij je pri ocenjevanju posameznih kategorij izdatkovne strukture BDP več popravkov. V celotnem obdobju (od leta 1995) je del vmesne potrošnje države (pri neposrednih proračunskih uporabnikih na centralni in lokalni ravni) prenesen v investicije v osnovna sredstva (investicijsko tekoče vzdrževanje v povprečju med 0,3 do 0,4 % BDP). Prav tako se samogradnja stanovanj gospodinjstev ne deli več na dokončana stanovanja (investicije v osnovna sredstva) in nedokončana stanovanja (sprememba zalog), ampak je celotna proizvodnja sedaj prikazana kot investicije gospodinjstev v stanovanja. Obe spremembi ne vplivata na raven BDP, ampak samo spreminjata izdatkovno strukturo BDP po posameznih kategorijah. Na podlagi tabel ponudbe in porabe za leto 2002 je v izdatkovni strukturi BDP v tem letu in pozneje glede na doslej objavljene vrednosti več popravkov, predvsem pa je povečana vrednost izdatkov gospodinjstev ob hkratnem zmanjšanju bruto investicij v osnovna sredstva (za 0,4-0,5 % BDP).

V letu 2002 je v oceno števila zaposlenih po nacionalnih računih prvič vključena tudi ocena števila zaposlenosti na podlagi pogodbenega dela in dela po avtorskih pogodbah. V letu 2002 je ocenjena skupna zaposlenost 912,5 tisoč, od tega 16,4 tisoč na podlagi pogodbenega dela in dela po avtorskih pogodbah. Zaposlenost na podlagi pogodbenega dela je prikazana med zaposlenimi osebami (11,0 tisoč), na podlagi dela po avtorskih pogodbah pa med samozaposlenimi (5,4 tisoč).

Podatki o transakcijah s tujino v letih 2002-2004 temeljijo na redni letni reviziji plačilne bilance, ki jo je Banka Slovenije dokončala sredi septembra. Spremembe postavk plačilne bilance zaradi revizije so za leta 2002 in 2003 minimalne. Zaradi novih ocen menjave blaga s tujino, zaradi nove ocene koeficienta cif/fob pri uvozu blaga ter zaradi osvežene ocene prilivov in odlivov iz lastnine s tujino (predvsem pri reinvestiranih dobičkih neposrednih tujih naložb in zaradi prehoda na ocenjevanje prilivov in odlivov obresti s tujino po obračunskem načelu) pa so te korekcije v letu 2004 večje in je po reviziji skupni primanjkljaj v tekočih in kapitalnih transakcijah s tujino po oceni nacionalnih računov 119 773 mio SIT. Primanjkljaj po nacionalnih računih v letu 2004 se razlikuje od primanjkljaja po plačilni bilanci (126 519 mio). Po vstopu Slovenije v EU 1. maja 2004 so bili pri oceni primarnih dohodkov in odhodkov z institucijami EU (prilivi kmetijskih subvencij iz institucij EU in odlivi dela davkov na proizvodnjo in uvoz kot lastnih virov EU) narejeni obračunski popravki: pri prilivu subvencij za 7 297 mio SIT, pri odlivu lastnih virov iz naslova carin in uvoznih dajatev pa za neto 551 mio SIT, tako da je primanjkljaj po nacionalnih računih za 6 746 mio SIT manjši od primanjkljaja po podatkih plačilne bilance. Vplačila carin in uvoznih dajatev kot lastnega vira EU se v nacionalnih računih knjižijo po bruto načelu, pri čemer se 25 % bruto plačil prikaže kot izvoz državnih storitev (glej tabelo 12 pri izvozu storitev).

V publikaciji objavljamo BDP in BND na podlagi PMSFP, razporejenih po uporabnikih. Za določene administrativne namene pa bo Komisija EU še naprej uporabljala nacionalne agregate brez PMSFP. Tako moramo pri oceni tekočega primanjkljaja in dolga sektorja država glede na BDP iz BDP posredno merjene storitve finančnega posredništva izločiti. Enako velja za BND kot podlage za izračun t.i. 4. BND prispevka države članice v EU proračun: BND za leto 2004, kot je objavljen v tej publikaciji (tabela 13: 6 193 539 mio SIT), moramo zmanjšati za oceno PMSFP v končni potrošnji (tabela 18: 59 650 mio SIT); vrednost BND brez PMSFP torej znaša 6 133 889 mio SIT.

Within regular revision work, several changes have been introduced in the expenditure GDP estimates. In the whole period (from 1995 on) part of intermediate consumption of general government (at so-called direct budgetary users at central and local level) has been transferred to the gross fixed capital formation (current investment maintenance costs at the amount of 0.3-0.4% of GDP). Also output of own-account construction activities of households is now shown as gross fixed capital formation and is no longer divided between finished dwellings (gross fixed capital formation) and unfinished dwellings (changes in inventories). Both changes do not have any effect on the GDP level; they just change the GDP expenditure structure. On the basis of the supply-use table for 2002, several improvements were made in the GDP expenditure structure from 2002 on, where the main effect is the increase of the final consumption expenditure of households and the decrease of gross fixed capital formation at the same time (by 0.4-0.5% of GDP).

In 2002, employment according to the national accounts includes also employment from two types of contract work for the first time. Total employment in 2002 is estimated at 912 000, of which 16 000 on the basis of these types of contract work. Employment from one type of contract work is shown within employees (11 000) and from the other one within self-employed (5 400).

Data on transactions with the rest-of-the-world (ROW) for the 2002-2004 period are based on the revised balance of payments which was prepared by the Bank of Slovenia in September. Changes in the balance of payments due to revision are for 2002 and 2003 negligible. For 2004 the changes are bigger due to three main reasons: new estimates for exports and imports of goods, new estimate of the cif/fob coefficient and changes in the estimates of the property income flows with the ROW (mainly reinvested earning on foreign direct investments and estimates of the interest flows which are now based on accrual principle of recording). Total deficit in current and capital transactions with the ROW is thus after the revision estimated at SIT 119 773 mio. Deficit according to the national accounts differs from deficit according to the balance of payments. After entering the EU on 1 May 2004, accrual adjustments are necessary at the estimates of the primary income flows with the EU (agricultural subsidies received from the EU and payments of taxes on production and imports to the EU): at the subsidies in the amount of SIT 7 297 mio and at the payments of customs duties and other import duties in the net amount of SIT 551 mio. Deficit according to the national accounts is thus by SIT 6 746 mio smaller than deficit according to the balance of payments. Payments of customs duties and other import duties are in national accounts recorded gross on accrual basis; at the same time 25% of the gross amount is shown as the exports of government services (see exports of services in Table 12).

GDP and GNI published in this publication are shown with FISIM being allocated to the users of these services. However, the EU Commission will continue to use national accounts aggregates without FISIM for certain administrative purposes. In calculating general government deficit and debt as a percent of GDP, FISIM must be excluded from GDP. The same holds for GNI which is used as a basis for the 4th own resource determination: GNI for 2004, as published in this Rapid Reports (SIT 6 193 539 mio, see Table 13), must be reduced by FISIM in final consumption (SIT 59 650 mio, see Table 18) yielding GNI without FISIM in the amount of SIT 6 133 889 mio.
