Babies enrolled enrolled at birth receive 1 year assessment free, then after 1 year pay only 10c a month and are insured for \$100.00 At the age of 21, when they transfer into the adult class, they receive a \$50.00 rider. Then they can transfer into class B and will be insured for \$300.00 for the small sum of 70c plus 5c for branch expenses or they can transfer into class A and be insured for \$100.00 and pay 45c plus 5c for branch expenses.

Juniors who join pay 10c a month assessment for \$100.00 Burial Benefit. After they are members 10 years they receive one year assessment free when they transfer into the adult class.

July 4th, I attended the first picnic held by all the nine Slovenian National Homes of Cleveland. I met Senator Frank Lausche of Ohio and the first thing he mentioned was that what a beautiful Convention Banquet we had in Washington, D. C. and that he enjoyed it very much. 1967 SCHOLARSHIPS





"The following recipe," Mrs. Misiewicz writes, "has been served often by members at our meeting with cream cheese or just plain buttered."

CARROT BREAD

34 cup Mazola Oil

1 cup sugar

1/2 teaspoon salt

2 eggs

11/2 cups flour

1 teaspoon baking soda

1 teaspoon cinnamon

1 teaspoon baking powder

1 cup grated carrot

1/2 cup nuts

Mix all ingredients together. Bake in greased loaf pan, in 350 degree oven for about 45 minutes. Submitted by member, Mrs. Wm. DelZotto.

CORN BEEF HOT DISH

Another good family dish from this cookbook is as follows:

1/8 oz. package wide noodles

4 oz. American cheese (grated)

2 cans cream of mushroom or cream of chicken soup

1 can whole kernel corn or peas

1 can corned beef

2 cups milk

1/2 cup chopped onion

34 cup buttered bread crumbs

Cook noodles in salted water. Drain, add all the ingredients except bread crumbs. Sprinkle bread crumbs on top, bake in greased baking dish at 350 degree oven for 1 hour. Submitted by member, Mrs. Rose Kresky.

Mrs. Alvina Sreboth, No. 16, So. Chicago, Ill, was kind enough to mail me two delicious recipes featuring shrimp and broccoli.

SHRIMP CURRY

4 green onions, sliced

1 tablespoon butter

1 can condensed cream of mushroom soup

1/4 cup milk

1/4 tablespoon curry powder

½ pound cleaned shrimp

1 avocado pared and diced

Cook onions in butter 5 minutes. Add soup; blend in milk. Stir in powder and shrimp. Heat through, add avocado and heat 1 minute more. Do not overcook. Serve with hot rice.

BAKED BROCCOLI

2 tablespoons minced onion

2 tablespoons butter

2 tablespoons flour

1 teaspoon salt

2 packages (10 oz. each) thawed, frozen broccoli

3 eggs, well beaten

1 cup sharp cheese, cut in ½ inch squares

½ cup buttered bread crumbs

¼ cup slivered almonds

Cook onion in butter 5 minutes. Blend in flour and salt. Mix eggs and cheese with broccoli. Add the cooked onion. Turn into buttered casserole. Top with bread crumbs and almonds. Bake at 250 degrees about 50 minutes or until custard is set. (Serves 8)

The Washington Post recently featured on article on Mrs. Mark Hatfield in the column "For and About Women". The former Antoinette Kuzmanich, daughter of a Yugoslav-born Portland longshoreman is of Creation nationality. The article reads, "Mrs. Hatfield, wife of the junior senator from Oregon, never flinched at giving receptions and teas for as many as 5000 when Mr. Hatfield was governor of Oregon. Now, in Washington, D. C. she prefers to give small dinners for six. An excellent cook and author of a cookbook, ReMARKable Recipes," now in its fifth printing, she prepares the dinners herself. Her favorite menu is boned leg of lamb with minted pears. corn souffle, and, for dessert, "Something strawberry" or her husband's favorite lime pie.

The recipe for the latter, taken from her cookbook, follows:

KEY LIME CHIFFON CAKE

1 tablespoon (1 envelope unflavored gelatin)

% cup sugar

¼ teaspoon salt

4 egg yolks ¼ cup water

½ cup lime juice

2 teaspoons grated lime peel

3 drops green food coloring

4 egg whites

½ cup sugar

Line pie pan with pastry, bake and set aside on cooling rack to cool completely.

Mix gelatin, % cup sugar, and salt in top of double boiler. Beat egg yolks, water and lime juice together; stir into gelatin mixture. Set over boiling water. Thoroughly heat mixture, stirring constantly, and continue cooking five minutes to cook egg yolks and dissolve gelatin. Remove from heat and stir in the lime peel and food coloring until blended.

Cool. Chill in refrigerator or over ice and water until mixture begins to jell (becomes slightly thicker). Stir occasionally.

Beat egg whites until frothy. Add the ½ cup sugar gradually, beating well after each addition. Beat until stiff peaks are formed. Fold in the chilled gelatin mixture until thoroughly blended. Turn filling into pastry shell. Chill until firm. Makes one 9-inch pie.

We appreciate very much using recipes from Mrs. Wm. DelZotto and and Mrs. Rose Kresky. Thank you, too, Mrs. Sreboth, for your favorite shrimp and broccoli recipes. Best wishes,

No. 103, Washington, D. C. An interesting historical experience awaited those members who toured the Gettysburg battlefield in conjuction with our meeting the second Sunday in June at the Antolin home in Emmitsburg, Maryland.

The 1½ hr. drive proved to be a relaxing one and when we arrived at the Antolin home we were greeted by their 12 excited youngsters and refreshing beverages. After everyone had gathered together, a tasty potluck picnic lunch, which was ultra special and ever so tasty was served.

The members, their families and friends sampled everything from fried chicken and salads to homemade cake and jelly roll. There must have been enough food and beverages left to supply even a few more meals.

Following the lunch, a short meeting was held under a shady walnut tree. It was agreed to eliminate meetings during the months of July and August and then resume again in September. Possibilities of a late September picnic and a second annivesary celebration in November were mentioned as projects for the coming year. Pictures, large SWU buttons and souveniers from the convention were also passed out to those in attendance. One hundred and four years have passed since that great dramatic episode known as the "Civil War" or "The War between the States." Although the battle at Gettysburg did not end the war it remains the greatest battle of the Civil War. On July 3, 1863, the final battle decided the turn of events and guaranteed the preservation of the Union.

Here can be seen hundreds of monments honoring those that fought and died in this three-day confrontation. One can re-trace the steps those brave soldiers must have taken as they founght in wheat fields, woods and behind rocky hills. It is apparent why Abraham Lincoln was so moved by this area that he delivered the immortal Gettysburg Address, on this hallowed spot, in commemoration of the northern and southern forces that consecrated the ground by their blood.

Following the tour the group returned to the Antolin residence driving past the former President Eisenhower's farm. When we returned, cooling refreshments under the shady trees, were enjoyed along with singing to the accompaniment of Mr. B. Chokel and his magic guitar.

It was indeed a Sunday afternoon to remember and we are grateful for the opportunity to visit with the Antolin Family. Once again our host and hostess have extended an invitation to return. They have another historical spot in mind for the next June meeting in 1968.

MINUTES OF THE 14TH NATIONAL TRI-ENNIAL CONVENTION MAY 24-28, 1967 - WASHINGTON, D. C.

(Continued from last month.)

FRIDAY, MAY 26, 1967 CONVENTION SESSION II

The second Convention session of the 14th National Convention of Slovenian Women's Union convened at 8:30 a.m. on Friday 26, 1967 at the Crystal Ballroom of the Hilton Hotel, Washington, D. C.

The Convention was opened by the president, Antonia Turek and prayer was led by Spiritual Advisor, Rev. Okorn. The greetings received by the Convention were read.

The President called for the Supreme Officers reports which were not given on Thursday. All reports were given and approved.

Upon conclusion of the reports a standing ovation was proposed by State Pres. Rose Scoff for the Conventon "arrangers" Irene Planinsek and Corinne Leskovar. Miss Planinsek responded with a very warm welcome to the delegates and officers stating her compliments to them for the work done in the past 40 years to make SWU what it is today. "Woman power you have shown is fantastic," was among her comments. She expressed much appreciation to all for coming to Washington and being such nice guests. She also announced that the handwork was being accepted by the committee.

The President then called for reports from the Convention Committees. First to be called was the By-Law Committee, Marie Prisland, chairman.

AMENDMENT

to the

ARTICLES OF INCORPORATION

of the

SLOVENIAN WOMEN'S UNION OF AMERICA

ARTICLE II

The Objectives for which the Slovenian Women's Union of America is formed, are:

The primary purpose of this Union is to unite women of Slovenian origin and their families, living in the United States of America, who are in good health, of good moral character, of Catholic faith and not over 50 years of age. Catholic women and their families of other ethnic groups are to be invited to join this Union.

CONSTITUTION, BY-LAWS and REGULATIONS

of

THE SLOVENIAN WOMEN'S UNION OF AMERICA

NEW AMENDMENTS

The Objectives of the Organization

4. The objectives of this organization are as follows: a) To unite women and their families of Slovenian or other descent, living in the United States of America, being in good health, of good moral character, and of Catholic faith.

NATIONAL CONVENTION

14. To the Convention Committees appointed by the Supreme President, shall be added—Committee on Promotions and Publications.

The second last sentence shall read::

The Election Committee shall present two candidates for every Supreme Office — and two candidates for Alternates to the Supreme Auditors.

DELEGATES

17. The consolidated branches have at least 200 members to be entitled to one delegate.

THE SUPREME BOARD

29. The Supreme Board, of which seven members are the Directors, shall consist of:

The Founder as Honorary President; Supreme President; Supreme Vice-President; Supreme Secretary; Supreme Treasurer; Three Auditors; Editor Official Organ; Director of Women's and Sports Activities; Director of Youth Activities and seven State Presidents.

DIRECTORS

43. The Board of Directors shall meet annually during the last week of February at the Home Office, to audit all the financial accounts, investments and records of the Union and to set plans for future progress of the organization. Any Supreme Board member may attend these meetings on invitation of the Supreme President.

FINANCE COMMITTEE

50. The Supreme President, Supreme Secretary and the Supreme Treasurer shall comprise the Finance Committee. The Supreme President shall transact the business of investing the Union's Funds according to the Insurance Laws of the State of Illinois. She shall report all financial transaction to the Board of Directors and to the National Convention. She shall allocate accumulated gains to the organization's Classified Funds. Founder shall be the advisor of the Finance Committee.

SCHOLARSHIP COMMITTEE

- 52. The Union shall maintain a Scholarship Fund, separate from the central treasury. The Fund is managed by the Secretary of the Scholarship Committee. She accepts all contributions to the Fund and applications for Scholarship grants and distributes the awards to the winning applicants in conformity with the Scholarship Committee, composed of three Directors: The Founder, the Supreme President, and the Supreme Secretary.
- 53. The Scholarship Secretary prepares a report of income and disbursements of the Scholarship Fund, to be presented to every meeting of the Board of Directors in writing and personally to the National Convention. She publishes in the Official Organ the names and qualifications of students receiving scholarship grant.

STATE PRESIDENTS

62. To be added to the end of article . . . To the National Convention she presents a report of recommendations submitted by the branches in her state or in her group of states.

66. . . to be deleted.

SUPREME SECRETARY

69. The first sentence shall read: She shall balance her books and accounts pertaing to the Union's administration and submit them annually for audit.

SUPREME TREASURER

77. To be added to the last sentence: She shall submit her books and accounts to the Auditors for an annual audit.

AUDITORS

- 79. Candidates and Alternates for Auditors shall be those who have business ability . . .
 - b) change from semi-yearly to annually.

EDITOR

83. The third sentence shall read: She shall submit her accounts to the Auditors annually.

SURETY BONDS

90. The Editor-Manager shall be deleted and the Manager of Scholarship Fund shall be included.

OFFICIAL ORGAN

104. The subscription price of the official Organ shall be twenty cents monthly for social members, and \$3.00 yearly for non-members.

MEMBERSHIP

105. All women and their families of Slovenian descent and women and their families of other ethnic groups being in good health, of good moral character and of Catholic faith, shall be accepted into the organization. Members of the Adult Department in Class A shall be at least '16 years of age and not over 50 years old. Class B member's age shall be from 16 to 60 years.

106. Every subordinate branch may accept its own social members of any age, if it so desires. Such members shall subscribe to the Official Organ ZARJA for which they shall pay 20 cents monthly. This amount shall be forwarded each month to the Home Office with the regular assessment of the Branch. The social members shall not be entitled to any benefits from the Union but shall receive such benefits as are offered them by their Local Branch.

ASSESSMENTS

115. To meet the liabilities of the Union, a monthly assessment shall be levied on each member. The regular monthly assessment shall be:

Forty-five cents (45c) for members in Class A; Seventy cents (70c) for members in Class B

This assessment is payable until the member reaches its 75th year. Then the assessment is 20 cents monthly for members in Class A and 35 cents monthly for members in Class B, this to cover the managing expenses. Junior Assessment shall be 10 cents monthly.

All assessments shall be payable in advance on the first day of each Calendar month.

INCOME AND DISBURSEMENTS

117. The monthly income from assessments and other sources shall support all and any financial obligations the Union might have. The following shall be the source of income:

All monthly assessments and other fees from the regular and social members; all the interest and dividends earned by investments; all the money received from the sale of any publication the Union may sponsor; all the rent from Real Estate. From this General Fund shall be paid all the death benefits, salaries, managing expenses, printing of the Official Organ, National Convention expenditures, per diems, and traveling of Officers in promoting educational and recreational activities.

DEATH BENEFIT

118. To be added . . . \$100.00 for all who enrolled between the age of 57 and up to 60 years.

JUNIOR DEPARTMENT

121. Children ranging from birth to 25 years of age, who are in good health, shall be accepted into the Junior Department. Their assessment shall be ten cents monthly. In the event of death, and after two years of Junior membership, the Union shall pay to the beneficiaries \$100.00 death benefit.

122. The Junior member certificate expires at the age of 25 years. When the Junior member attains the age of 16 years, she or he may be transferred into the Adult Department. At such time a Rider of \$50.00 is attached

to her or his certificate for the normal amount, to be payable at death, providing such a Junior member was enrolled before its first birthday. If a Junior was a member over ten years at the time of transfer to the Adult Department she or he shall receive one year free assessment in Adult Class.

125. Junior members may attend the meetings of the Subordinate branch, but shall not have a voice at the elections. Their voting right begins after the transfer into the Adult Class.

OFFICERS AND COMMITTEES OF SUBORDINATE BRANCHES

146. The officers of the branch shall be elected at the annual meeting in December. The new slate of officers shall be presented by the Nominating Committee.

PRESIDENT

155. The president shall appoint all special committees including the Nominating Committee which shall be appointed one month before the election of officers.

157. She shall be empowered to call special meeting of the branch when majority of members so demand.

MEETINGS OF THE BRANCHES

187. Monthly is deleted since many branches do not hold meetings in summer.

190. A majority of votes cast at a meeting shall decide all transactions of a Subordinate branch and of elections of officers and delegates. If a vote is tied, another ballot shall be cast until the majority is attained.

196. The Ritual in tribute to a deceased member shall be performed at the Funeral Home and not at the grave.

GENERAL DECISIONS

197. The By-Laws accepted and approved at the 14th regular National Convention held May 24-28, 1967 at the city of Washington, D. C. shall become effective July 1, 1967.

The following are some of the comments and additions discussed on the proposals.

On proposal to paragraph 43: Supreme President will make one official visit to the Home Office per year to meet with the Executive Committee in addition to the single Board of Directors meeting held yearly.

On proposal 50: Motion by delegate E. Planinsek (20), seconded by delegate Frances Nemeth (89): The Honorary President and Founder shall be advisor to the Finance Committee. It is also recommended that she attend all business meetings of the Executive Committee as she is able.

On proposal 62: Motion by Supreme Treas. Josephine Zeleznikar seconded by State Pres. Mildred James: Every State President must take the responsibility of holding State Conventions yearly and that branches should take greater interest in the state conventions. Also, it was the recommendation of the convention that in the year of a National Convention all State Conventions be held, and at a time following that of the National Convention so to enable the officers and delegates to present the convention decisions before their branches.

On proposal 121: discussion centered on the question of the age of transfer proposed. By a show of hands, a vote was taken resulting in the majority for the proposal as presented.

The changes and recommendations of the By-Law Committee were accepted unanimously, moved by Supreme Officer Eliz. Zefran, seconded by State Pres. M. James.

The Convention adjourned for luncheon at 12:15 p. m.

FRIDAY, MAY 26, 1967 - CONVENTION SESSION III

The Supreme Presdent reconvened the Convention at 2:00 p. m. Greetings were read.

The Report of the Resolutions Committee followed. It was given by the chairman, Marie Floryan.

Resolution on the Establishment of American Consulate in Ljubljana, Slovenia was passed.

Resolution on America Beautiful Program was passed. Resolution on Re-establishment of former Voice of America Broadcasts to Slovenia was passed.

Resolution on a Commemorative Stamp in Observance of the 1200th Anniversary of the Christianization of Slovenians, passed.

Resolution on the proposed Slovenian Shrine at the National Shrine of Immaculate Conception was read and the committee decision passed as follows: To support and give moral sanction to the recommendation for a Slovenian Shrine and to join a combined effort by Slovenian clergy, Slovenian parishes throughout the United States and all major Slovenian Catholic organizations to seek funds for this cause. This decision was passed.

Resolution on American Youth Week was passed.

A general Thank You to the following:

Rev. Francis Blatnik for his mass offering, special intentions for delegates and welfare of S. W. U.

Rev. Claude Okorn for his daily mass offering, opening and closing of convention, and his interesting articles in Zarja-The Dawn.

Miss Irene Planinsek, General Chairman, for the convention committees, for their excellent planning and devoted energy for the convention.

Br. No. 103, Washington, D. C. for their hospitality in making the convention such an enjoyable and educational one.

Mrs. Marie Prisland, Founder, for having the foresight in organizing the SWU, and making it the wonderful organization it is today.

Washington Hilton Hotel for their courtesies.

Ray A. Marolt, for his services as altar boy.

Thanks to the delegation for their various gifts and cash donations towards the scholarship fund.

Thanks to the members for their gifts to the delegates (ie. candy, seeds, pens, etc.)

Thanks to Editor, C. Leskovar and members of Br. No. 50 (also honor guards) in national Slovenian costume, for the ceremony in memory of deceased members.

Thanks to the Supreme Board Officers for their fine leadership in the past years.

The Report of this committee was accepted.

The Report of the Salaries and Per Diem Committee was given by chairman, Ann Kompare, (95) as follows: Salaries and compensations of officers are as the committee decided hereby given:

Spiritual Advisor, \$150.00 annual award; Finance Committee Secretary, \$75.00 monthly salary plus \$25.00 administration expenses; Supreme President \$100.00 monthly salary plus \$25.00 admin. compensation; Supreme Vice-President., \$50.00 annual award; Supreme Secretary. \$450.00 monthly salary with taxes paid by the Union; Supreme Treasurer, \$300.00 annual award; Supreme Auditors, \$50.00 annual award plus per diem for the time of Board of Directors' Meetings; Editor, \$350.00 monthly salary plus \$50.00 traveling expenses to printing shop; Director of Women's Activities, \$100.00 annual award plus \$50.00 for promotional fund; Director of Juvenile Activities, \$50.00 annual award plus \$50.00 for promotional activities - this compensation to be made according to the amount of work undertaken; State Presidents, \$50.00 annual award plus \$25.00 (one per diem) if State Convention is held; Part-time Home Office helper, \$125.00 monthly.

The Convention Awards are proposed by this Committee as follows:

President of Convention: \$100.00; Secretary of Convention 1 month salary; Chairman of By-Laws Committee, \$200.00; Editor, 1 month salary; two Recording Secretaries, \$50.00 each; Irene Planinsek for her duties as hostess to this Convention, \$250.00.

The Committee also recommends that per diem be \$25.00.

All proposals made by this Committee were passed.
Report of the Appeals Committee was given by chairman, Frances Plesko (12). One appeal was presented for the Junior Rider proposal which was already discussed and passed by Convention on By-Law 121.

Scholarship Committee Report was given by chair-man, Hermine Dicke, as follows.

It was unanimously agreed by all the members of this committee who co-operated on this report that the following qualifications be asked for Scholarship Grants given by the SWU.

1. Only High School graduating students are to be considered for Scholarships.

2. At least one year should intervene between the awarding of scholarships to the same branch. No branch shall, in the future, receive two scholarships in succession.

3. Only one scholarship should ever be awarded to one family.

Branches are requested to sponsor money making projects each year for this cause. Suggestions are: to "pass the hat" at one of the larger meetings of the year; to hold a bake sale or other project (such as the one begun last night through the combined efforts of Mrs. Zeleznikar, Rose Kraemer, Marion Marolt, Betty Bayus, and others and Olga Saye who played her accordian at the social and to get the delegates and visitors in a good mood. A nice amount was raised), or through out-right donations.

Finally, if the fund is increased appreciably, a third scholarship could be recommended at the next convention. Report accepted.

Report on the Women's Activities Committee was given by chairman Eliz. Zefran, as follows:

Very successful Bowling Tournaments are being held in the Midwest and East. A tournament in Virginia, Minn. was held which proves that it can be done. This year juvenile bowlers are begining to show interest and enthusiasm and juvenile leagues should be formed at branches where possible. Mixed leagues for bowling are also advised.

The tours to Canada's shrines are very successful. This year a tour will be held in July with 60 people. (Trip was outlined). The Canadian shrine pilgrimage will be the third for SWU — first being in 1962.

Candy sales help lagging branch treasuries. Raising funds this way is very profitable, also selling other items such as vanilla and pepper. Information is available if you contact Mrs. Zefran. The branches wishing to learn of other fund raising methods should write to her. A discussion followed by the delegates on ways they use to gain funds. The Report was accepted.

A proposal was made by delegate of Br. 20, Josephine Erjavec to institute a Pilgrimage to the Shrine of Our Lady of Snows, Belleville, Ill.

Youth Committee Report was given by Louise Eply, Youth Director, as follows:

It is very important that every branch find a leader who is interested, enthusiastic and able to inspire youth. Money-making schemes such as Rummage Sales, White Elephant Sales, selling candy etc., should be employed by branches to increase their youth fund. Youth circles should participate in this. Activities such as bowling and baton twirling are required to activate a youth group. A National Writing Contest should be held with essays,

hobbies with prizes given. Grade groups and levels would be necessary for the awarding of prizes. This would encourage the youth to contribute to the Junior Page in Zarja. Teen age groups should be formed with activities such as glee clubs, cooking schools as well as sewing and knitting lessons. More emphasis should be placed on national awareness — a group must wish to seek recognition for their work, for their nationality by carrying on programs that show nationality traditions, such as St. Nick's observance at Christmas.

This Report was accepted.

The delegates from Br. 20 advised that 100 uniforms from the Joliet Cadets are available for sale — reasonably priced.

The President gave her report on the sale of Cookbooks. The report included a branch resumé of sales to date.

The delegation offered warm applause to the President and thanks for her good work in the distribution of cookbooks and also appreciate the help of Mr. Frank Turek, her husband.

Total

The amount of 25,000 cookbooks (Woman's Glory—the Kitchen) have been sold to date.

An explanation was requested by delegate Jennie Pugely (47) as to why, if the cookbook proft is so substantial, the delegates would not be getting their full expenses paid for the Convention. The Supreme Secretary, Albina Novak stated that in anticipation of the great expenses of this Convention, the Board of Directors acted at their last Semi-annual meeting and set up the Convention expense project in order to 1.) help branches to defray the delegates' expenses; 2.) offer branches with small treasuries, the chance to increase their funds. The Board's decision to offer a \$500 amount for cash prizes was made to give the branches no expenses with prizes only profit from sales - to be used at their discretion, whatever they deemed necessary, giving first to the delegates expenses, secondly to other convention or branch expenses. Bringing new money into circulation would also revive lagging treasuries.

The delegates from the following branches spoke on this subject: Br. 89, Br. 13, Br. 50, Br. 7, Br. 84, Br. 24, Br. 54, Br. 15, Supreme Officers Zefran and Bostian. The delegates voice appreciation for the fund-raising project and complimented the officers (Directors) for presenting it.

Delegate of Br. 50 Rose Zelodec asked that a 5 day grace period be given after the close of a campaign before new applications be tallied. Passed.

Delegate of Br. 15, Antonia Stokar asked that officers of branches should ask for confirmation of a new member's Catholic faith before admitted to membership.

The Chairman of By-Law Committee, Marie Prisland stated that this clause is in effect since the beginning of the organization.

Delegate of Br. 17, Marion Marolt thanked the Board of Directors for the Scholarship given their branch's member in 1966 and for the contribution given for their juniors' Christmas party.

Delegate from Br. 20, Emma Planinsek asked that the Home Office inform a juvenile member when reaching the age of transfer to adult.

Delegate from Br. 20, Josephine Erjavec asked why Zarja is so late in the month. Answer from the Editor explained that regulating the postal service is beyond

her power and that 2nd class matter is not given fast service — also, that when the deadline for Zarja is not observed by reporters, she must wait for copy and process is delayed. Deadline by reporters must be observed.

The Convention Committee chairman, Mary Bostian, reported that the committee proposes Euclid, Ohio as the next convention city. Delegate from Br. 20. J. Erjavec proposes San Francisco, Calif. in memory of Bara Kramer. Euclid, Ohio is approved as convention site for the third week in May, 1970.

The delegates expressed thanks for the Convention souenirs given to them by delegates Irene Planinsek, Rose Scoff and August Kollander Travel Bureau.

The Founder, Marie Prisland admonished the delegates not to forget the fact that all proposals for the future must be fortified by new members and that no one has offered as yet any suggestions as to that. The delegates were asked to respond in the morning.

Hostess and delegate of Br. 103, Irene Planinsek announced the needlework exhibit scheduled for Saturday started earlier than expected this afternoon and that it will continue tomorrow (Saturday) with still many nice things to buy for the Scholarship Fund proceeds.

The session adjourned for the day at 6:30 p. m.

SATURDAY, MAY 27, 1967 — CONVENTION SESSION IV

The fourth Convention session of the 14th National Tri-ennial Convention of S. W.U. convened at 8:30 a.m. at the Crystal Ballroom of the Washington Hilton Hotel at Washington, D. C.

The Spiritual Advisor led prayer followed by roll call and reading of greetings. The president called for the Report of the Zarja Committee. It was given by Editor, Corinne Leskovar as follows.

The policies regulating Zarja are still to be followed as they have been in the past. Zarja should be retained in its present form as a magazine in sizes of 16, 24 or 32 pages. Price of Zarja printing was estimated in a bid by the Benedictine Press printing shop and shows a stable price to be kept in accordance with current paper prices. The Benedictine Press is authorized to continue with the same service as in the past, printing, mailing and handling. Type of paper used should conform to economy and ease in handling.

Reporters should be encouraged to write as often as in the past, in both languages. Slovenian reporters are especially urged to keep up with their writing. We want to keep Slovenian language alive. Reporters should strictly observe one column length when writing and the Editor is asked to use her own discretion as to the translation of any branch articles when there is only one reporter. Reports of news items which would be of interest to members should be encouraged. All photos in black and white sent for publication should be accompanied by a \$2.00 donation for engraving charges.

Printed notice should be given once a year for changes of address to aid in keeping mailing list up to date, as requested by the Wisconsin delegates. The committee supports the increase in subscription rates for non-members, \$3.00 as stipulated in the proposed by-laws and 20 cents as monthly contribution from social members who wish to get Zarja.

Finally, the Editor is advised to regulate the size of Zarja each month according to the amount of material received.

The problem that still is to be faced is keeping close check on mailing address so that no deceased or non-members will be receiving Zarja. The committee suports the Editor's request that all members and officers give their fullest co-operation in sending in names and addresses of address changes and cancellations.

Zarja is our best means of promotion and members and branches should use it as much as possible. Advertising is also ecouraged for holiday issues and other observances. The Editor is given full authority to use her judgment in any and all problems or decisions as to be the editorial content and compilation of Zaria.

This Report was accepted.

Delegate of Br. 20, Emma Planinsek moved that the Union pay delegates for all traveling and per diem to the next national convention the same as for the Supreme Officers. Seconded by Antonia Stokar (15). Discussion followed with participants delegates from branches 25, 66, 84 and 95. Founder, Marie Prisland suggested that in order to build a convention fund substantial enough for such expenses, more new enrollments must be secured. Also, special projects were suggested to build the next convention fund. Majority voted against the motion in preference to the motion of M. Otonicar (25) that the next convention decide if future gain in funds will allow the expenses of per diem payments to all delegates. It was seconded by Marie Floryan and passed

The President called for the Report of the Nominating Committee. Chairman, Mary Otonicar, moved for a vote of confidence to the Supreme Board for ther work of the past three years. It was given unanimously. Delegate Irene Planinsek (103) questioned the method of voting asking that the By-Laws be clarified on this point. She stated that two names must be nominated for every office as specified in the by-laws. She also recommends that the nominating committee report be given one day before elections at the next convention to give delegates time to consider the nominees and that all voting be done by secret ballot. Discussion follows with participants on the rostrum and delegates from branches 40 and 89. The Secretary explains that if the nominating committee proposes only one nominee for any office, nominations are open from the floor.

Chairman, M. Otonicar stated that Founder, Marie Prisland was elected at the last convention as Honorary President for life.

The Nominating Committee proposed Rev. Claude Okorn as Spiritual Advisor. There were no other nominations. The President directed the Secretary to cast one unanimous ballot for Rev. Okorn as Spiritual Advisor of S.W.U. Rev. Okorn thanked the assembly warmly and offered his continued cooperation.

The Committee nominated Antonia Turek as Supreme President. There were no other nominations. The Vice-President, M. Floryan, directed the Secretary to cast a unanimous ballot for Mrs. Novak as Supreme Secretary. The delegation gave their applause and she responded by thanking all the officers and members for all their past help. She also expressed her happiness in the success of the last three years. The Founder and Secretary spoke of the gratitude of the Union in having such an outstanding President. Mrs. Turek accepted the position graciously.

The Committee nominated Marie Floryan as Supreme Vice-President. There were no other nominations. Mrs. Fyoryan accepted the nomination. The President directed the Secretary to cast a unanimous ballot for Mrs. Floryan as Supreme Vice-President. She thanked the delegation for its confidence and support.

The Committee nominated Albina Novak as Supreme Secretary. There were no nominations from the floor; the President then asked the Recording Secretary to cast a unanimous ballot for Mrs. Novak as Supreme Secretary. In accepting, Mrs. Novak offered her sincere thanks to all.

The Committee nominated Josephine Zeleznikar as Supreme Treasurer. No other nominations were offered from the floor, Mrs. Zeleznikar accepted the nomination and the President directed the Secretary to cast a unanimous ballot for Mrs. Zeleznikar as Supreme Treasurer. For President of the Auditing Board, the Committee nominate Ann Podgorsek. No other nominations were offered from the floor. Mrs. Podgorsek accepted the nomination and the President directed the Secretary to cast a unanimous ballot for Mrs. Podgorsek as President of the Supreme

Auditing Board. For Second Supreme Auditor, the Nominating Committee had no candidate. The President opened nominations from the floor. The Secretary nominated Mary Otonicar (25); Anna Rebolj (41) nominated Mary Bostian. Mrs. Bostian declined. Upon receiving her acceptance, the President directed the Secretary to cast a unanimous ballot for Mary Otonicar as Second Supreme Auditor. The Committee nominated Ann Kompare (95) for Third Supreme Auditor. Also nominated from the floor were Irene Planinsek (103) and Josephine Erjavec (20.) Both declined. Upon receiving the acceptance of Mrs. Kompare, the President directed the Secretary to cast a unanimous ballot for Ann Kompare as Third Supreme Auditor.

For the position as First Alternate Auditor, the Committee nominated Theresa Skur (14) and without further nominations, the Secretary was directed to cast a unanimous ballot for Mrs. Skur as First Alternate Auditor. Second Alternate Auditor nomination was made from the floor by M. Polden (2) for Frances Gaspich (20.) After closing nominations the President directed the Secretary to cast a unanimous ballot for Miss Gaspich as Second Alternate Auditor.

For the position of Director of Women's Activities, the Committee nominated Elizabeth Zefran who was given unanimous approval by the delegates. Director of Youth Activities nominations were opened from the floor with the following nominated: Louise Epley, Irene Planinsek and Mary Bostian. Miss Planinsek declined offering instead to assist the Youth Director who will be elected. Mrs. Epley declined in favor of Mrs. Bostian and the Secretary was directed to cast a unanimous ballot for Mrs. Bostian as Youth Director. Question from the floor on the subject of one Supreme Officer holding two selective psitions was raised and moved by Angela Kozjan (40) that a Supreme Officer may hold two offices. Carried.

The Committee nominated Corinne Leskovar for Editor of Zarja and with no nominations from the floor, the Secretary was directed to cast a unanimous ballot for Mrs. Leskovar as Editor of Zarja-The Dawn.

For the seven State Presidents, the Nominating Committee made the following nominations:

Colorado-Kansas-Missouri, Anna Pachak. Her acceptance was given and the Secretary cast a unanimous ballot for Mrs. Pachak as State President.

Wisconsin, Rose Kraemer was nominated. She accepted and the Secretary was directed to cast a unanimous ballot for Mrs. Kraemer as State President.

Pennsylvania-New York, Mary Tomsic. Nominations from the floor were for Anna Trontel, Lucille Smith and Mary Oblak, all declining in favor of Mrs. Tomsic. The Secretary then cast a unanimous ballot for Mrs. Tomsic as State President.

Ohio-Michigan, Mary Bostian. There were no nominations from the floor and the Secretary was requsted to cast a unanimous ballot for Mrs. Bostian as State President.

California-Washington-Oregon, Rose Scoff. No nomnations were made from the floor and the Secretary cast a unanimous ballot for Mrs. Scoff as State President.

Illinois-Indiana, Mildred James. Mrs. James declined. Nominations from the floor were for Sophie Petrovic (2), Mary Polden (2), Josephine Erjavec (20) and Emma Planisek (20) all declining and Elizabeth Zefran. Mrs. Zefran accepted the nomination and the Secretary was directed to cast a unanimous ballot for Mrs. Zefran as State President.

Minnesota, Barbara Rosandich. She accepted and the Secretary cast a unanimous ballot for Mrs. Rosandich as State President.

Scholarship Committee: Marie Prisland, Antonia Turek, Albina Novak; Hermine Dicke, Secretary. Accepted unanimously.

The President called for the reading of the Minutes of the previous day's sessions. They were read by Recording Secretary C. Leskovar and accepted.

A discussion on new member enrollments was introduced by Founder, Marie Prisland. Delegates participated in the discussions, bringing out points such as:

New member prospects must be asked — so many potential members are waiting to be approached.

The meetings of branches shall be made interesting.

Drill teams should be revitalized among the young members to encourage more young ladies to join; compliments were offered to the Euclid-Cleveland officers for supporting the Junior Cadets and Baton Twirlers which were organized in 1966.

The delegation concluded that campaigns for new members must be given primary importance in the future, and therefore, a new campaign should be declared.

The Supreme Secretary reported on the good promotion being given the Union through the excursion trips to Europe. She has secured some 25 new members since January 1st among people interested in going to Europe.

The Tours, sponsored by S.W.U. in co-operation with the August Kollander Travel Agency of Cleveland, Ohio are of great service to the Union as more and more people are making the trips each year.

Founder, Marie Prisland gave in itemized report on the money received at this Convention for the Scholarship Fund. \$213.75 was collected at the Needlework Exhibit so far. Cash donations are also being made. She is donating her first month's raise in salary to this Fund. She thanked all the members who contributed to the Needlework project and those who made purchaes. She expressed her pleasure at the proceedings of the Convention and wished everyone a fond good-bye.

The Supreme President and Honorary President were requested to review the last day's Convention Minutes. The Recording Secretary read the greetings received Saturday.

Concluding comments were given by Rev. Okorn who suggested in his last remarks that in order to get and keep young members, they be considered for offices in the branches and subsequently will be trained to take hold of the reins of the Union. He asked that every member continue to sacrifice herself for the things that she believes in as success only comes through sacrifice.

The President asked him to perform the Ritual of Installing the new officers which was duly accomplished according to the regulations of the Union. The President, in accepting her gavel, pledged the work and efforts of all the Officers elected to the new term.

The Convention assembly was led in prayer and singing of "Češčena si Marija" and "Zvezina hymna" by Supreme Treasurer, Josephine Zeleznikar. The Convention was adjourned at 12:30 p. m. by the President who extended all delegates and officers her best hopes for continued success in working for the S. W. U.

U. S. NAVAL VESSEL NAMED FOR SLOVENIAN HERO

News of our Slovenian-American lads who fight and die heroes in the struggle for freedom never cease to thrill and astound us! At our recent National Convention, we heard of the bravery of a U.S. Naval officer, Milton Pavlic killed in action during World War II and of the honor accorded him by his country. Our Barberton, Ohio, Br. 6 Delegate, Mrs. Jeanette Killoran, gave us this information taken from a newspaper clipping and we proudly reprint it in its entirety. From this we learn that a U.S. naval vessel is sailing the seas carrying the name of a brave American who was the descendent of Slovenian parents:

> Lt. Cmdr. Milton Pavlic died a hero's death on November 15, 1942 aboard the battleship South Dakota during the fighting for Guadalcanal. A graduate of High School, he Rittman had taught at Annapolis before the war. He died in the ship's sky control tower, fighting off Japanese planes. The South Dakota shot down 32 planes and sank three Japanese ships during the battle. "Do not for a moment think his death was in vain," a fellow officer wrote to his parents. He was buried at sea the same day. In December of 1943 a destroyer escort was launched and his widow christened it the U.S.S. Pavlic.

WHEREAS, It is now known that the Federal Government of Yugoslavia has decided to open a Yugoslav Consulate in the city of Cleveland, Ohio, as reported in the daily newspaper DELO of Ljubljana, March 31, 1967; and,

WHEREAS, Such a decision is justified not only on the basis of the important principal of Reciprocity in International Relations, but also as there is now no American presence in Slovenia; and,

WHEREAS, Recent devolopments have reaffirmed Slovenia's leading role in the process of economic and political evolution in Yugoslavia; and,

WHEREAS, It is through Slovenia that Yugoslavia is now open to masses of Western Tourists, including an increasing number of Americans: and.

WHEREAS, There are some 600,000 Americans of Slovenian descent, the largest of the Yugoslav nationalities, living in America and many of them visit Slovenia yearly; and,

WHEREAS, It is important that American and other foreign visitors have immediate access to an American Consulate in Slovenia itself; now, therefore,

Be it known, that the members of Slovenian Women's Union of America, representing Americans of Slovenian descent, urge the Government of the United States to take serious consideration of the question of establishing an American Consulate in Ljubljana, Slovenia.

RESOLUTION

WHEREAS, The Republic of Slovenia, in the northwestern part of Yugoslavia, is the only cultural and progressive nation of 2 million persons without the direct services of a United States Consulate or Information Service post; and,

WHEREAS, Members of the Slovenian Women's Union of America continue to receive complaints from their relatives and friends in Slovenia, concerning the time of broadcast and lack of medium wave lengths for the Slovenian broadcasts over the Voice of America; and,

WHEREAS, Two evening programs in Slovenian were replaced a year ago by two early morning programs of only 15 minutes duration; and,

WHEREAS, For many listeners who have indicated their desire to listen to the broadcasts, this time, is very inconvenient; and,

WHEREAS, The two early morning programs are not transmitted on medium length waves; and,

WHEREAS, Since the Voice of America program is the only direct American contact with the people of the Yugoslav Republic of Slovenia; now, therefore,

Be it known, that the Delegates convened at the 14th National Convention of the Slovenian Women's Union of America make this appeal to the Director of the United States Information Agency to re-establish the Voice of America programs in Slovenian language to the former, traditional broadcast time and to be transmitted over medium wave engths.

REPLIES ON RESOLUTIONS

The above Resolutions as indeed, all the Resolutions passed by the 14th National Convention of S.W.U. were sent to the addressees and acknowledged by same. They have all stated further attention will be given as a result of the interest of the Slovenian Women's Union and numerous government officials in the Senate and House of Representatives.

In response to the Resolution requesting the establishment of a U. S. Consulate in the city of Ljubljana, Slovenia, our distingushed Senator from Ohio, Frank J. Lausche, a member of the U. S. Senate Foreign Relations Committee, undertook to write personally to President Johnson in support of the Resolution and received a reply from his office stating the matter is receiving attention with hopes to have further response from the President in the future.

Other officials who have sent letters acknowledging their interest in this matter are the following:

Illinois Congressman Frank Annunzio letter to State Dept.; Ohio Congressman Michael A. Feighan, letter to Sec. of State; Ohio Congresswoman Frances P. Bolton, Wisconsin Congressman Henry C. Schadeberg, Senator from Indiana Vance Hartke, Senator from Michigan Robert P. Griffin and Wisconsin Congressman, member of Committee on Foreign Affairs, Clement J. Zablocki.

All the above named also re-stated their interest in the Resolution on Voice of America broadcasts and support of the recommendation that broadcast time be re-evaluted. The "Voice" resolution also received the support of Congresman John A. Blatnik of Minnesota and Congresman Roman A. Pucinski of Illinois, both of whom have pleged their attention in this matter. Congressman Annunzio has written a further inquiry requesting a complete report from the U. S. Information Agency.

RESOLUTION

THE SLOVENIAN WOMEN'S UNION OF AMERICA, an educational and benefit organization representing 12,000 Catholic women throughout the United States, convening in Washington, D. C., for their 14th National Triennial Convention; and

Inasmuch as the American Slovenians, as well as their compatriots in Europe, are currently celebrating the 1,200th anniversary of their Christianization, first begun by the Irish Bishop St. Modestus —

NOW, THEREFORE, BE IT RESOLVED, that formal appeal be made to the Postmaster General of the United States to have the privilege of the occasion being marked by the issuance of a special commemorative stamp because:

- a) The Slovenians were the first Slavic nation to be Christianized;
- b) They in turn played a considerable role in the conversion of and work with the American Indians—having sent many missionaries to America, among them five bishops, one of whom is currently the only American missionary nominee for the altar (Bishop Frederick Baraga);
- c) Well over a half million Slovenians have contributed of their culture, minds, hearts and bodies to the wondrous nation we now are;
- d) In this way the United States would not only give recognition to Americans of Slovenian descent but would also bolster the morale of other Slav peoples behind the Iron curtain;

BE IT FURTHER RESOLVED, that the Executive Committee supplement this action with parallel contacts with members of the Congress in the various states and districts, and to Bishops and Archbishops of Catholic Dioceses.

BE IT THEREFORE RESOLVED by this 14th National Convention of the Slovenian Women's Union of America that this organization take the initiative and assume the leadership for a nation-wide campaign to collect the necessary amount of \$50,000 as the donation for the erection in the National Shrine of Immaculate Conception of a chapel dedicated to Our Lady of Brezje;

BE IT FURTHER RESOVED that for the purpose of the broadest possible participation in this great cause the Supreme Board of the Slovenian Women's Union of America invite other Slovenian organizations and institutions as well as to distinguished American-Slovenian personalities to take part in this national campaign by joining its steering and local campaign committees;

AND BE IT ALSO RESOLVED that in anticipation of such broad participation the Supreme Board of the Slovenian Women's Union of America instruct individual local Branches of the organization to set up their own local campaign committees to begin the collection campaign without further delay.

MORE REPLIES . . .

The Resolutions on the Commemorative Stamp to be issued in the anniversary year of the 1200 jubilee of Christianity in Slovenia and proposed proclamation for American Youth Week have been receiving wide attention. Senator Lausche has indicated his complete support of each. He has informed us of his appeal for the Commemorative Stamp initiated some time ago, but which as yet has not been successful. ARLINGTON POKOPALIŠČE

Na tem mirodvoru sniva večno spanje pokojni predsednik John F. Kennedy. O pokopališču sem slišala zgodbico, o kateri pa nisem mogla dobiti zgodovinskega potrdila.

General E. Lee, voditelj Juga v civilni vojni, je zunaj mesta Washingtona lastoval 2000 akrov zemlje, kjer se zdaj nahaja Arlington pokopališče in spomenik Nepoznanega vojaka.

General Lee je na zemljišču vrh prijaznega hribčka, ki nudi krasen razgled na vso mesto Washington, postavil lepo palačo, ki je v civilni vojni služila za bolnišnico.

Predsednik Abraham Lincoln je neki dan to bolnišnico obiskal ter videl več mrtvih trupel, zavitih v platno, ki so čakala pogreba. Straže niso znale kam jih naj odpeljejo, predsednik Lincoln je pa ukazal, da jih pokopljejo kar tam. Tako je nastalo Arlington pokopališče, pod katerega zeleno rušo počiva nad 100,000 vojnih veteranov.

Po smrti generala Lee se njegovi sorodniki niso brigali, da bi od zemljišča redno davke plačevali. Končno je vlada zemljišče zaplenila za neplačane davke v znesku \$92.16. Sorodniki so pozneje vlado tožili za \$150,000.00 odškodnine a so tožbo izgubili. Tako je vlada dobila vseh 2000 akrov zemlje za ceno \$92.16. Nekaj te zemlje je bilo pozneje prodane za naselje, ostalo pa tvori Arlington pokopališče.

Na pokopališče vsak dan prihajajo trume ljudi, ki ali obiščejo grobove svojih dragih, se poklonijo spominu predsednika Kennedyja in drugih predsednikov, ki so tu pokopani, ali pa obiščejo spomenik Nepoznanega vojaka.

Pred tem spomenikom hodi vojaška straža noč in dan. Stražnik napravi 20 korakov sem, se obrne in spet napravi 20 korakov v nasprotno smer. Straža se menja vsako uro. Stražniki so posebej izbrani izmed vojakov, ki se odlikujejo po ravni držbi, strpnosti in odpornosti.

BANKET

Naj se pomudim še pri banketu, ki je bil sijajen zaključek naše konvencije. Po končanem programu se gosti niso razšli, temveč ob spremljevanju naše Olge s harmoniko, (delegatke sheboyganske podružnice) navdušeno prepevali slovenske pesmi do dveh zjutraj.

Glavne odbornice, delegatke, obiskovalke in članice domače podružnice — v krasnih oblekah in veselo razpoložene — ter navzoči vzvišeni gosti, so vtisnili nepozaben spomin na ta večer. Naša Zveza ni še nobenkrat bila v bolj odlični družbi. Odličen je bil tudi program.

Ganljiv je bil govor priljubljenega slovenskega senatorja g. Franka Lauscheta, ki si je s plemenitostjo srca in bistrim razumom pridobil — za predsednikom vlade — najvišje politično mesto v deželi. Iskreno je povdarjal pomembnost slovenske narodnosti, ki jo razvidno srčno ljubi in spoštuje. Kako sem želela, da bi ga slišala vsa naša mladina, ki bi dobila nov vpogled v veličino slovenske narodnosti. — Smo sicer mali, a kljub temu važen narod.

Kongresnik g. John Blatnik iz Minnesote nas je zabaval z anekdotami o svojih starših. Povedal je, da ga je pred več leti obiskala njegova ljuba mamica in mu prinesla lepo zavito orehovo potico in veliko steklenico naribanega domačega hrena, ki ga on zelo rad ima. Mojo hčerko Hermino je hren tako zanimal, da je prihodnji dan na plovbi po reki Potomac ves čas nabirala navodila za hren, ki ste jih lahko brale v zadnji izdaji ZARJE v koloni POTS and PANS.

Gospod Blatnik je pripovedoval, kako je hotel očeta pregovorti, da bi ga prišel obiskati v Washington. Oče je dejal, da ga muči revmatizem in ni za dolgo potovanje. 



Don Camillo had a thorn in the flesh, one that had annoyed him intensely for a very long time. Once a year it was particularly painful, and that was during the procession in honor of the Assumption. For three hundred and sixty-four days the dim shadowy chapel afforded concealment, but under the pityless sun of August fifteenth the true state of affairs was visible to everybody. She was known as the "Ugly Madonna", a phrase which smacked of collective blashemy. But actually no disrespect toward the Mother of God was intended; this was merely an accurate description of the state which was the cause of Don Camillo's pain.

Once removed from the kindly shadows of the chapel and exposed to the sun light, the face stood out all too clearly. It was not only an ugly face but an evil one as well; the features were heavy and vulgar, and the eyes expressionless rather than ecstatic. And the Infant Jesus in the Madonna's arms was just a bundle of rags with an empty doll's head sticking out of them.
