

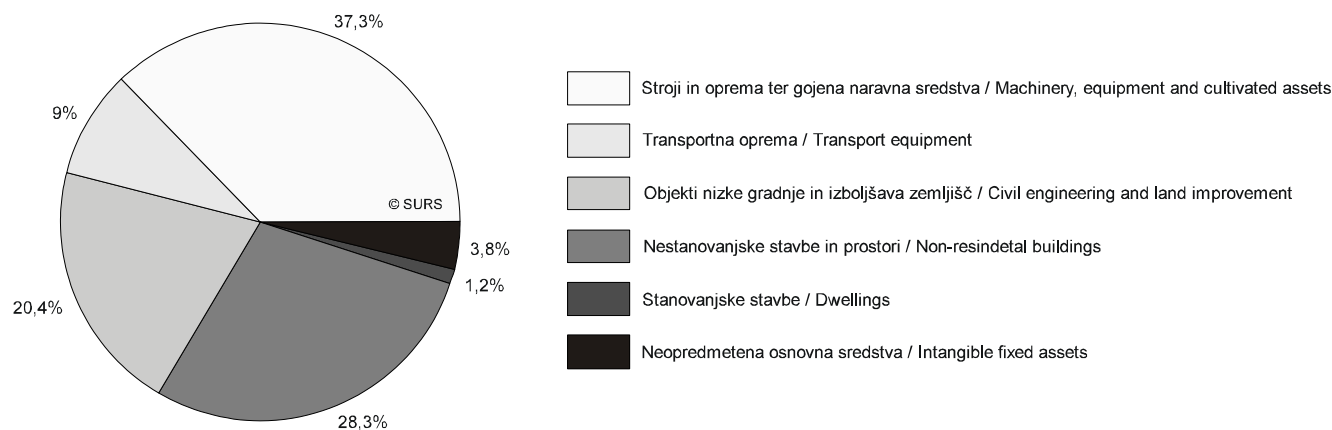


BRUTO INVESTICIJE V OSNOVNA SREDSTVA, SLOVENIJA, 2004  
GROSS FIXED CAPITAL FORMATION, SLOVENIA, 2004

- ▶ V letu 2004 so podjetja, družbe in organizacije ustvarili za 1096,7 milijarde investicij v nova in rabljena osnovna sredstva.
- ▶ In 2004, enterprises, companies and organisations paid SIT 1096.7 billion for gross fixed capital formation (new and existing assets).
- ▶ V celotni strukturi investicij so največji delež obsegale investicije v nove in rabljene gradbene objekte, in sicer 49,9 %.
- ▶ The greatest share of total gross fixed capital formation was paid for new and existing buildings and structures, i.e. 49.9%.
- ▶ Največ vseh investicij v nova in rabljena osnovna sredstva, to je 81 %, so ustvarile dejavnosti, ki so v SKD uvrščene v področja C, D, E, F, L, G, in I.
- ▶ The greatest share of gross fixed capital formation - new and existing assets (81%) was created by sections C, D, E, F, L, G and I of the Standard Classification of Activities.
- ▶ V občini Ljubljana je med vsemi občinami bil ustvarjen največji delež vseh bruto investicij – 32,2 %.
- ▶ Among municipalities, the greatest share of total gross fixed capital formation was created in Ljubljana (32.2%).
- ▶ Več kot polovico vseh investicij v Sloveniji v letu 2004 so ustvarili v občinah Ljubljana, Koper, Maribor, Celje in Novo mesto.
- ▶ Almost a half of total gross fixed capital formation in Slovenia was created in municipalities Ljubljana, Koper, Maribor, Celje and Novo mesto.

**METODOLOŠKA POJASNILA****Namen statističnega raziskovanja**

Na podlagi statističnega raziskovanja o investicijah v osnovna sredstva zbiramo podatke o dejanskih bruto investicijah v osnovna sredstva in o njihovih virih pri neposrednih investitorjih, to je družbah, podjetjih in organizacijah. Ocena bruto investicij (bruto investicije v osnovna sredstva, spremembe zalog in vrednostni predmeti) je ena od postavk (poleg končne potrošnje in saldo menjave s tujino) za izračun bruto domačega proizvoda po izdatkovni metodi.

**Enote opazovanja**

Enote statističnega opazovanja so družbe, podjetja in organizacije, ki so registrirani za opravljanje dejavnosti na ozemlju Republike Slovenije in ki zaposlujejo vsaj 20 oseb.

**Vir**

Vir podatkov o bruto investicijah je bilo Letno statistično raziskovanje o investicijah v osnovna sredstva (vprašalnik - INV-1).

**Zajetje**

**Podatke o investicijah v osnovna sredstva za leto 2004** smo zbirali pri vseh tistih poročevalskih enotah, ki so imele najmanj 20 zaposlenih. Njihova odzivnost je bila 90-odstotna, za neodgovore pa smo izvedli preračun na celotno populacijo z razmernostno cenilko, in sicer tako, da smo uporabili podatkovno bazo o davku na dodano vrednost Davčne uprave Republike Slovenije oz. število zaposlenih.

**Način zbiranja podatkov**

Podatke o investicijah zbiramo z vprašalnikom INV-1 pri družbah, podjetjih in organizacijah, ki so nam po Zakonu o državni statistiki (Uradni list RS, št. 45/95 in 9/01) dolžni sporočati zahtevane podatke (in sicer vpišejo v vprašalnik podatke, ki se nanašajo na preteklo leto).

**Prikaz podatkov**

V tabeli 1 prikazujemo investicije po posameznih skupinah osnovnih sredstev po metodologiji Evropski sistem računov, 1995 (ESR 1995), in sicer nakupe novih in rabljenih osnovnih sredstev ter njihove prodaje. Poročevalske enote, ki nam poročajo o investicijah, lahko svoja obstoječa osnovna sredstva (npr. avtomobil) prodajajo ne samo drugi pravni osebi, ampak tudi gospodinjstvom kot trajno dobrino (ta s tem izgubi funkcijo osnovnega sredstva). Tako so v določenih postavkah prodaje večje od nakupov rabljenih osnovnih sredstev, zato prikaz investicij na ta način po posameznih dejavnostih ni smiseln.

Podatki v tabelah 2, 3, 4, 5 in 6 so urejeni po dveh načelih:

- po organizacijskem načelu: podatki so razvrščeni po pretežni dejavnosti investitorja (ta je določena z vpisom v Statistični poslovni register, ki ga vodi Statistični urad Republike Slovenije) in teritorialno - po sedežu investitorja;
- po načelu čistih dejavnosti: podatki so urejeni po dejavnostih enot v sestavi v okviru organizacij, ki so jim investicije namenjene,

**METHODOLOGICAL EXPLANATIONS****Purpose of the statistical survey**

With the statistical survey on gross fixed capital formation we collect data on actual gross fixed capital formation and payment for it from direct investors, i.e. companies, enterprises and organisations. The estimate of gross capital formation (gross fixed capital formation, changes in stocks and valuables) is one of the items (beside final consumption and external trade balance) for the calculation of the gross domestic product according to the expenditure approach.

**Observation units**

Observation units are companies, enterprises and organisations registered for performing their activities in the Republic of Slovenia and employing 20 or more employees.

**Source**

The source of data on gross fixed capital formation is the Annual Statistical Survey on Gross Fixed Capital Formation (INV-1 questionnaire).

**Coverage**

**Data on gross fixed capital formation for 2004** were collected from all reporting units with 20 or more employees. Their response rate was 90%. For non-response, we performed recalculation to the total population with the ratio estimator, using the value added tax database of the Tax Authority or the number of employees.

**Method of data collection**

Data on gross fixed capital formation are collected with the INV-1 questionnaire, which has to be completed by companies, enterprises and organisations with data for the previous year on the basis of the National Statistics Act (OJ RS, No. 45/95 and 9/01).

**Data presentation**

Table 1 shows capital formation by individual groups of fixed assets according to European System of Accounts 1995 (ESA95) methodology, i.e. purchase and sale of new and existing assets. Units reporting on capital formation can sell their fixed assets not only to other legal persons but also to households as durable goods, e.g. cars, which thus lose the function of a fixed asset. Thus in individual items sale exceeds purchase of existing fixed assets, so it is not reasonable to present capital formation in this way by individual activities.

Data in Tables 2, 3, 4, 5 and 6 are shown according to two principles:

- organisational principle: data are classified by the predominant activity of the investor, which is defined with registration into the Statistical Business Register kept by the Statistical Office of the Republic of Slovenia, and territorially by the location of the investor,
- kind of activity principle: data are classified by activities of constituent units of organisations for which capital formation is in fact intended

### Definicije in pojasnila

**Vrednost investicij v osnovna sredstva** obsega:

- nakupe osnovnih sredstev v tekočem oz. poročevalskem letu;
- posodobitve, rekonstrukcije in prenove na že obstoječih osnovnih sredstvih;
- lastno izgradnjo in pridobitev (brez plačila) osnovnih sredstev ter
- nabavno vrednost osnovnih sredstev v finančnem najemu (lizing).

Osnovna sredstva (nova in rabljena) se vrednotijo po nabavni vrednosti; ta sestoji iz nakupne cene, povečane za morebitne davke (npr. DDV), stroškov prevzema in drugih neposrednih stroškov (npr. stroškov transporta, montaže ipd.).

### Osnovna sredstva

To so **proizvedena sredstva**, ki se uporabljajo v proizvodnem procesu več kot eno leto, in sicer ponavljajoče oz. nepretrgoma.

V skladu z ESR 1995 in slovenskimi računskimi standardi se osnovna sredstva delijo v dve veliki skupini – na opredmetena in neopredmetena osnovna sredstva:

- **opredmetena osnovna sredstva** so gradbeni objekti in izboljšava zemljišč, stroji, oprema in prometna sredstva ter gojena naravna sredstva oz. večletni nasadi in osnovna čreda;
- **neopredmetena osnovna sredstva** so študije, projekti in raziskovalna dela; programska oprema; sredstva za zabavo in izvirniki oz. originali na področju filma, glasbe ipd.

Nakupi zemljišč se od leta 1996 ne štejejo več za investicijo v osnovna sredstva.

V vrednosti *gradbenih del* upoštevamo tudi vrednost opreme, ki je vgrajena v gradbene objekte, v vrednost *opreme* pa so zajeti tudi stroški montaže, transporta in zavarovanja.

### Viri financiranja investicij

To so vsi viri oz. izdatki, ki so potrebni za financiranje investicij za nova in rabljena osnovna sredstva; ti so lahko iz lastnih sredstev (tudi realizacija v lastni režiji), iz združenih sredstev, iz finančnih sredstev (kreditni in finančni najem), iz sredstev posebnih namenskih skladov; osnovna sredstva so lahko pridobljena tudi brezplačno.

**Plačane bruto investicije** so tista opravljena dela na obstoječih osnovnih sredstvih in tiste nabave novih in rabljenih osnovnih sredstev, ki so jih poročevalske enote plačale v poročevalskem letu. Za plačana se štejejo tudi osnovna sredstva, ki so jih poročevalske enote pridobile brezplačno.

**Opravljen, toda ne plačane bruto investicije** so vse v poročevalskem letu neporavnane obveznosti do izvajalcev in dobaviteljev, kot npr. porabljeni komercialni krediti in neplačan kredit oz. lizing, sklenjeni v poročevalskem letu; avansi, ki so bili plačani v prejšnjih letih, vendar obračunani v poročevalskem letu.

**Vrednost ustvarjenih bruto investicij** (ustvarjenih v poročevalskem letu) obsega plačane in neplačane investicije v nova in rabljena osnovna sredstva, ki so v uporabi, in tudi tisti del nedokončanih investicij, ki je bil ustvarjen v poročevalskem letu.

**Bruto investicije v nove zmogljivosti** so vlaganja za ustanavljanje novih samostojnih podjetij, organizacij in obratov ter graditev prometnih poti, ki jih prej ni bilo ali pa so imele drugačen namen kot na novo zgrajene.

**Bruto investicije za razširitev, rekonstrukcijo in posodobitev** so vlaganja v obstoječe zmogljivosti zaradi povečanega obsega proizvodnje ali storitev ali zaradi spremembe tehnologije in tehnike proizvodnje;

and territorially by the location of the facility.

### Definitions and explanations

**Value of gross capital formation** is:

- purchase of fixed assets in the current or reporting year;
- modernisation, reconstruction and renovation of existing fixed assets;
- own formation of fixed assets and gratis fixed assets and
- purchase value of fixed assets in financial leasing.

Fixed assets (new and existing) are valued at purchase value, which is composed of purchase price plus eventual taxes (e.g. VAT), costs of delivery and other direct costs (e.g. transport, assembly, etc.).

### Fixed assets

are **produced assets** that are used continuously in the production process for more than a year.

In accordance with ESA-95 and Slovenian accounting standards, fixed assets are divided into two large groups – i.e. tangible and intangible fixed assets:

- **tangible fixed assets** include construction work, land improvement, machinery, transport and other equipment, orchard development and breeding stock, whereas
- **intangible fixed assets** include studies, projects and research work; software and entertainment and originals in the field of literature, film, music, etc.

Since 1996 purchase of land has not been part of fixed capital formation.

*Construction work* also includes the value of equipment built in the buildings. The value of *equipment* includes costs of assembly, transport and insurance.

### Sources of financing capital formation

These are all sources or expenditure necessary for financing fixed capital formation for new and existing fixed assets. They are divided into own financial assets, joint assets, financial credits, assets of funds and acquisition without compensation.

**Paid gross fixed capital formation** is work performed on existing fixed assets and purchase of new and existing fixed assets that were paid in the reporting year. Paid fixed assets are also those that the reporting units acquired free of charge.

**Created but unpaid fixed capital formation** is all unsettled liabilities towards contractors or suppliers in the reporting year, e.g. used commercial credits and outstanding credits (leasing) raised in the reporting year, and advance payment in previous years calculated in the reporting year.

**The value of fixed capital formation created** in the reporting year covers paid and unpaid capital formation for new and existing fixed assets used as well as that part of unfinished capital formation that was created in the reporting year.

**Gross fixed capital formation in new capacities** is investment in creating new enterprises, organisations and units, construction of roads, etc., which previously did not exist or had other purpose than the newly built.

**Gross fixed capital formation for enlargement, reconstruction and renovation** is investment in existing capacities because of increased volume of production or services, or because of the change of

**Teritorialna razvrstitev investicij:** podatki so razvrščeni v občine po kraju, kjer je bila investicija izvršena.

Opomba: Zaradi zaokroževanja na mio. SIT se vsota vrednosti v vrsticah oz. stolpcih ne ujema povsem s skupno vrednostjo.

## KOMENTAR

Enote opazovanja za leto 2004 so bila podjetja, družbe in organizacije, ki so imela najmanj 20 zaposlenih (vključno do leta 2003 najmanj 10) in so ustvarila za 1096,7 milijarde SIT investicij v nova in rabljena osnovna sredstva.

Čeprav je bila metoda vzorčenja spremenjena, je bilo v letu 2004 zajetih v opazovanje več kot 87 % vseh tistih enot, ki so bile zajete v opazovanje tudi v letu 2003. S temi enotami je zajetih več kot 95 % vseh bruto investicij v osnovna sredstva.

Nominalni porast bruto investicij (primerljivih v obeh letih) glede na leto 2003 znaša 3,8 %. To pomeni realno povečanje, saj je bila povprečna stopnja inflacije v letu 2004 3,6-odstotna.

Podjetja so sredstva za svoje investicije v največji meri črpala iz lastnih virov in iz združenih sredstev (58,7 %). Sledili so jim viri iz finančnih kreditov in lizinga (27,6 %). Financiranja namenskih skladov ter pridobitev osnovnih sredstev brez denarnih nadomestil je bilo za 13,7 % vseh sredstev za investicije v nova in rabljena osnovna sredstva.

V letu 2004 je bilo vseh plačanih bruto investicij 81,8 %, preostale so bile opravljene, niso pa bile plačane.

V celotni strukturi investicij v nova in rabljena osnovna sredstva v letu 2004 so največji delež obsegale investicije v gradbeni del, 49,9 %, investicije v stroje, opremo, prometna sredstva in gojena naravna sredstva so zavzemale 46,3 %, neopredmetenim osnovnim sredstvom pa je bilo namenjenih 3,8 % investicij.

Največji delež investicij v nova in rabljena osnovna sredstva sta ustvarila industrija in gradbeništvo (področja C, D, E in F), in sicer 37,3 %, sledila so področja javna uprava (L) z 22,0 %, trgovina; popravila motornih vozil (področje G) z 11,7 % in promet, skladiščenje, zveze (področje I) z 9,8 % vseh investicij.

Med občinami je bila po deležu vseh ustvarjenih investicij v nova osnovna sredstva na prvem mestu občina Ljubljana (32,2 %); sledile so ji občine Koper (5,4 %), Maribor (5,2 %), Celje (4,4 %) in Novo mesto (3,7 %). V omenjenih pet občin je bilo v letu 2004 ustvarjenih več kot polovico (51 %) vseh investicij v Sloveniji.

technology. It also covers reorganisation of existing buildings and equipment, and construction or purchase of new fixed assets within the scope of an existing organisationally independent unit.

**Gross fixed capital formation for maintenance of existing capacities at the same level** is investment due to replacement, intensification and rationalisation of production, but without expanding the existing capacities or fundamentally changing the present technology.

**Classification by territory:** investments by municipalities are classified by place of creation.

Note: In some tables the total in the rows and columns does not correspond to the total value due to rounding to million SIT.

## COMMENT

The observation units for 2004 are enterprises, companies and organisations having 20 or more persons in paid employment (until 2003 10 or more). They paid SIT 1096.7 billion for gross fixed capital formation (new and existing assets).

Although the sampling method was changed in 2004, there are still, in comparison with 2003, more than 87% of all unit observed. These units covered about 95% of total gross fixed capital formation.

The nominal increase of gross fixed capital formation (comparable in both years) over 2003 is 3.8%. This means real increase since the average annual inflation rate in 2004 was 3.6%.

The enterprises financed their gross fixed capital formation mostly by own financial assets and joint assets (58.7%), followed by financial credits and leasing (27.6%). Obtaining assets of funds and fixed assets without monetary compensation represented 13.7% of gross fixed capital formation in new and existing fixed assets.

In 2004, paid gross fixed capital formation represented 81.8% of the total capital formation.

In the total structure of gross fixed capital formation (new and existing assets) in 2004, the greatest share (49.9%) was that of capital formation for construction work, followed by capital formation for machinery transport, other equipment and cultivated assets with 46.3% and intangible fixed assets with 3.8%.

The greatest share of gross fixed capital formation was created by industry (sections C, D, E and F) with 37.3%, followed by public administration (section L) with 22.0%, trade; repair of motor vehicles (section G) with 11.7% and transport, storage and communication (section I) with 9.8% of total capital formation.

Among municipalities, the greatest share of gross fixed capital formation was created in Ljubljana (32.2%), followed by Koper (5.4%), Maribor (5.2%), Celje (4.4%) and Novo mesto (3.7%). In 2004, more than a half (51%) of total gross fixed capital formation was created in the mentioned five municipalities.
