LEGAL RECOGNITION OF ESTABLISHMENT OF THE PARISH „BEATA VERGINE DEL ROSARIO“ IN TRIESTE

WHEREAS Mons. Dott. Antonio SANTIN, Bishop of Trieste and Capodistria, has submitted an application for the legal recognition of his decree dated 1 March 1948 by which the new Parish „Beata Vergine del Rosario“ in Trieste was canonically established, and

O R D E R :

1. — The decree of the Bishop of Trieste and Capodistria, dated 1 March 1948, relating to the establishment of the Parish „Beata Vergine del Rosario“ in Trieste is herewith given temporary legal recognition.
