MINUTES OF THE 22ND NATIONAL CONVENTION May 19–21, 1995, San Francisco, CA

Minutes from the Twenty-Second National Convention of the Slovenian Women's Union of America. Convention held in San Francisco, California and headquartered at the Canterbury Hotel.

The convention was called to order by National President Tory Bobence at 8:00 o'clock a.m.

Report from the Credential Committee was called for and presented by the Chairman, Cirila Kermavner. Committee members were named as follows:

Pat Figurowski (No. 20) Ceta Zagar (No. 13) Diane Varney (No. 14) Charlotte Laurich (No. 38) Kathy Schroeder (No. 1)

Credentials for thirty-five (35) delegates had been received and reviewed and found to be in order. The voting delegation of forty-eight (48) included ten (10) members of the National Board of Directors and three (3) Regional Presidents.

A motion was called for to accept the report of the Credential Committee. Anka Kregar (No. 55) made the motion to accept. Motion was seconded and carried.

Opening ceremonies began with a greeting from Father Christian Gostečnik, OFM who expressed his delight and honor to be with us for our convention, thanking Branch No. 13 for their invitation. He recalled his knowledge of Founder Marie Prisland and extended an invitation to Ženska Zveza to visit Slovenia in 1996 which will mark our Seventieth Anniversary. The Invocation followed Father Christian's remarks, asking for guidance in all the major decisions that must be reached during the convention.

The National Anthem was sung by Frank Shepel of Ely, Minnesota, followed by our Pledge of Allegiance.

Roll Call of the National Board, Regional Presidents and delegates was heard and recorded by Olga Ancel, National Secretary.

Rules of Order were presented by Beverly Jackson. Questions were called for, none were presented and the meeting continued.

Barbara Chiodo, Convention Chairman, called on Adrienne Micklich, Soudan, Minnesota (No. 34) who in turn made a presentation to President Tory Bobence, acknowledging all the past dedication she has given to not only the National Board but also to their branch.

Director of the planned tours (Michelle) addressed the group regarding times, means of transportation, etc... Punctuality was stressed.

Branch No. 13 President, Josephine Aiuto, welcomed the group to San Francisco, expressed their appreciation for the response and thanked the committee who had handled so many details.

Chairman Chiodo clarified items regarding the agenda and tours. Meeting was then turned over to the president.

President Tory Bobence addressed the delegates and visitors and reminded those in attendance to abide by the convention rules. If problems arise and guests/visitors do

not conform to these rules, they will be asked to leave the assembly. A time limit on discussions will be placed at three minutes. Warnings will be given appropriately and anyone addressing particular issues are to honor those warnings. President also advised delegates that if necessary, unfinished business would be conducted at evening meetings after the conclusion of the planned tours.

The podium was given to Beverly Jackson and the introduction of the keynote speaker was next in order and Barbara Chiodo's credentials as a native of San Francisco, a Slovene member of Branch No. 13, having served in many public offices and a contender for the U.S. Congress in 1990 was introduced. Chiodo spoke on preserving our Slovene Heritage, and asked that we look at decisions that have to be made during these three days that will effect our future, pointing out that we (Ženska Zveza) is on a bumpy road and three things will help us survive: 1.) Leadership, 2.) Communication, 3.) Giving of one's self. She gave us food for thought when comparing the modern day women to our mothers. Her message was well received by all present.

A greeting was presented from San Francisco's Mayor, Frank Jordan, in the person of Martha Cohen. She welcomed us to the city on behalf of the Mayor, read in part a proclamation for the convention, declaring May 19th, 1995 Slovenian Women's Day in San Francisco.

The gavel used for our 1995 Convention was brought from the Heritage Museum. It had used in 1936 for the National Convention in San Francisco.

President Bobence outlined the topics of discussion that would be addressed during the convention, namely: increasing all dues, direct billing, term limits, ZARJA.

Report of the By-Laws Committee was called for and presented by Chairman, Corinne Leskovar. The committee was introduced as follows:

Leslie Telich (No. 25) Jean Korsman (No. 39) Charlene Kobe (No. 20) Marge Church (No. 42) Irene Odorizzi (No. 103)

Articles of Incorporation were reviewed with discussion on two possible changes. However, it was decided that the Articles would remain as compiled. The Preamble also remains the same. Proposals on the following Articles were read:

Regarding Article I - No Change

Regarding Article II – Paragraph a) change "--and of the Catholic faith" to read "be a Christian."

Regarding Article III - No Change

Regarding Article IV - No Change

Regarding Article V - No Change

Charter from the State of Illinois, Department of Insurance remains unchaged.

By-Laws as amended at this convention will read as follows:

Declaration of Principle: remains the same.

Article I, Name and Location: remains the same.

Article II, Formation, Purposes and Governing Laws: remains the same.

Article III, Membership: regarding Adult Class A will be deleted. New members as of the date of this convention will ALL be admitted as Class B members. Wording will be changed from "member" to read "member(s)", and from "she" to "their". (3.03, refer 9.02)

Monthly payments will be done away with and dues paid on a yearly basis will be requested.

3.12 To read: Members who fail to pay their assessment by the third month of every year will be cancelled and shall forfeit all benefits for any insurance claims submitted in the remaining portion of the year. Any member who has failed to pay her assessment by the third month of the year may be reinstated any time during that year upon payment of the full delinquent assessment and current assessment. A member who does not pay her full assessment nor is reinstated that year, may join as a new member at a later date if she meets age requirements.

Discussion followed on the need for Direct Billing and the advantages to the organization and to local branches. The matter was address by delegates from Branches 20, 55, 16, 47, and 25.

Article IV: National Convention: 4.05: The words "in a roll call vote" are deleted from the paragraph.

Article V: Directors: 5.02: Sentence shall read: It shall have administrative and executive authority to conduct the business of the association and to regulate the affairs of the branches in a manner "consistent" with the decisions of the National Convention, -----"

5.03: Members of the Board of Directors will be elected at the National Convention "by secret ballot" for terms of four years each.

Article VI: Committees, remains the same.

Article VII: National Officers. 7.01, Seven members of the Board of Directors,

Director of Women's Activities Director of Youth Activities Scholarship Fund Director

Cultural/Heritage Director

Members of the National Board of Directors may serve in their individual positions for a maximum of two (2) terms. The National Officers, namely the Directors of Women's Activities, Youth Activities, Scholarship Fund and Cultural/ Heritage Activities, are appointed by unanimous decision of the Board of Directors. Candidates for these offices must be members in good standing with the association, must meet the qualifications of the particular office for which they have been selected and have an appreciation of Slovenian Heritage.

7.03: The National President will be elected at each National Convention "for a term limit of two (2) terms of four (4) years each."

7.05: The National Vice President will have the same qualifications as the National President and will be elected at each National Convention "for a limit of two (2) terms of four (4) years each."

7.07: The National Secretary will be elected at each National Convention "for a limit of two (2) terms of four (4) years each."

7.12: The National Treasurer will be elected at each National Convention "for a limit of two (2) terms of four (4) years each."

7.13.b. At the end of the paragraph, add: "and Cultural and Heritage Committee Director."

7.16 The Editor of ZARJA will be "selected by the Board of Directors."

7.20:The Director of the Scholarship Committee is "appointed by the Board of Directors."

7.21: The Director of Women's Activities is "appointed by the Board of Directors."

7.22: The Director of Youth Activities is "appointed by the Board of Directors."

7.23: The Cultural and Heritage Director "appointed by the Board of Directors."

7.24: The Spiritual Advisor may be appointed by the Board of Directors.

Article VIII: Initiative and Referendum: Remains the same.

Article IX: Assessments, Investments, Income and Disbursements.

9.02: The yearly assessment is payable "one time per year in the months of January and February."

(Effective 1-1-96 no new Class A Members will be accepted.)

The regular "yearly" assessments as follows:

a) Adult, Class A: \$12.00 per year

b) Adult, Class B: \$15.00 per year

- c) Adult, Class A: \$8.00 per year (over 75 years of age)
- d) Adult, Class B: \$10.00 per year (over 75 years of age)
- e) Associate, Class A: \$12.00 per year
- f) Associate, Class B: \$15.00 per year
- g) Junior Dept .: \$4.00 per year
- h) Social Dept .: \$15.00 per year

9.05.a) All "yearly" and special assessments. Article X, Official Organ, remains the same. Article XI, Junior Department, remains the same. Article XII, Regional Convention, remains the same. Article XIII, Branch Meetings, remains the same. Article XIV, Branch Officers as follows:

In the event there is insufficient number of willing and adult department members to fill vacant branch offices, (ELIMINATE: the branch may apply for a dispensation from). The National Board of Directors may allow the election of Social Department members to any branch office, except that of president or secretary.

Article XV, remains the same.

Article XVI, remains the same.

After the proposals were read, and each delegate had time to review their printed copy, a vote was taken to accept the proposals. Majority vote was received. Discussion on changes was had and delegates expressed their opinions/concerns.

Regarding the yearly assessment, Jonita Ruth (No. 20) moved that the dues be raised to \$15.00 across the board. Motion was seconded. A lengthy but controlled discussion followed and branches questioned the effects on amount of insurance that members had, i.e., paying \$15.00 for a \$100 benefit, or \$15.00 for a \$300 benefit (Marge Church, No.

42). It was explained that such items would have to be investigated and a pro ratio would probably have to be established. The following delegates participated in the discussion:

Ceta Zagar, No. 13 Rosemary Mlakar, No. 100 Anne Orazem, No. 35 Angela Nico, No. 89 Steffie Segulin, No. 10 Charlotte Laurich, No. 38 Olga Dorchak, No. 47 Jonita Ruth, No. 20

Ceta Zagar called for the question regarding the dues being raised to \$15.00 across the board, including Social members. The proposal was read by Jonita Ruth (No. 20) and moved that the same be accepted. A vote was called for, delegates standing to be counted. Thirteen (13) voted in favor of the proposal. Proposal defeated.

Jean Korsman (No. 39) moved that the initial proposal presented by the Board of Directors, eliminating all Class A from new membership, be accepted. Motion seconded. A standing count was taken, with 27 delegates in favor. Passed.

The matter on Social Members being able to serve as officers was discussed. Social Members may be officers, except for the office of President or Treasurer. The National Board musdt approve the appointment/election. It was felt that this need arises because of our dwindling membership, aging of present members and reluctance of "active" members to take office.

A vote was taken to accept the changes and was passed by a majority.

After a short break, the meeting continued with correspondence read by Olga Ancel from the following:

Mary Marolt, Past National Treasurer Irene Jagodnik, Past National Auditor American Slovenian Catholic Union Branch No. 73 Branch No. 47

Flowers received at the convention from Father Paul at the Croatian Franciscan Press were acknowledged.

At this time it was noted that in the packet of reports that each delegate received, reports from Regional Presidents, namely Rosemary Mlakar and Evelyn Majercik, were not included for review.

The subject of Direct Billing was addressed. Initial discussion on the matter was presented by Evelyn Majercik (Regional Pres., Ohio-Mich.) with the need for the process to begin being stressed. Pat Figurowski (No. 20) inquired about the way the branches would receive their dues (if same is assessed) when dues would be paid directly to Home Office. She likewise questioned cost of starting the process, the purchase of a computer, etc. It was explained that branch dues would be forwarded to the treasurers to those branches who collect an assessment above the assigned dues. It was likewise explained that the increase in the dues would include the \$1.00 per member assessment as passed at the 1991 convention. Jean Zeleznikar (No. 2) questioned the process of change-over. It was explained that it would be a gradual process, perhaps a few branches at a time, and certainly would not be in effect before January 1, 1996.

Many problems of collecting dues were expressed, ranging from inability to contact members, to late payments, including elderly on fixed incomes/in nursing homes. It was the overall opinion that Direct Billing would be the solution to many problems.

Beverly Jackson (No. 13) called for a motion on Direct Billing. Move was seconded and on a vote taken, only two (2) negative votes were received.

ZARJA was the next matter on the agenda. Jonita Ruth (No. 20) questioned whether we should investigate the possibility of changing publishing companies. Corinne Leskovar addressed the issue and reported that she had already had bids from two other companies. One copy of ZARJA containing 32 pages with 4 cover pages and a mailing of 5,500 copies as printed by the Croatian Franciscan Press, our present publisher, costs \$4,820 including all phases (set-up, photo plates, ads, postage etc.). The second closest bid for the same standards was \$9,690. In additon to the printing costs, postage for 5,500 copies is \$750.00. A bimonthly publication would present restrictions. Corinne feels that the proposal by the Board of Directors for eight (8) issues is workable.

Suggestions were received on ways that ZARJA could be kept at its' present status. Jonita Ruth (No. 20) suggested each branch taking an ad to support the magazine. Because of a time limit on our meeting, this portion of the meeting was adjourned for the day, to reconvene at 8:00 a.m. Saturday.

Saturday, May 20, 1995. After the group photo was taken, our meeting was again called to order by President, Tory Bobence. Father Chris offered a prayer for the delegates asking for guidance in the task of election of new officers that would take place later in the meeting.

Barbara Chiodo advised delegates/visitors regarding afternoon activities, asking everyone to be prompt.

Nika Kovacic (No. 103) spoke for the Heritage Museum and the display in the meeting room, asking those present to support the effort being put forth. She also recalled the National Convention that was held in Washington, D.C. thirty years ago.

The matter of ZARJA and its publication was again the focus of the meeting. Several branches expressed desire to publish eight (8) issues per year, that six (6) issues would not be sufficient to cover events, etc. that members look for information on when their copies arrive. Another recently retired National Officer is Marion Marolt who began her duties at her mother's knee, too. Marie Floryan is remembered lovingly as the national leader of the Milwaukee-West Allis branches. Marion's daughter, Robin, was secretary of br. 17 until its recent merger.

President and Editor Albina Novak brought me, her daughter, into the editorship of ZARJA in 1952, where I have been ever since!

And, if we want to learn something about our retiring National Secretary, Olga Ancel, we need only to look into her Zveza beginnings. GENEALOGY

LOCATING A MISSING RELATIVE

In the United States, Social Security cards were issued to all citizens in 1940. To obtain a Social Security card, citizens had to provide a birth certificate and those who didn't have one on file had to go to their county clerk's office to have one registered. Check the 1940 Birth Indexes for those relatives you have been unable to find. People born as early as 1858 had to register their births in 1940.

EMIGRANTS/IMMIGRANTS

To migrate means to move from one place to another. The words emigrants and immigrant is derived from that root word. Emigrants leave their country to live in another place. Immigrants arrive from another country to settle into a new one. When researching genealogical records, a person would be considered an emigrant in their country of origin and an immigrant in the country where he or she settled.

MISLEADING "HERITAGE" OFFERS INVESTIGATED

Millions of people, both beginning genealogists and the unsuspecting public, are buying surname books expecting to learn about their own family. When the book arrives, they discover its primary feature is a list of individuals with their last name.

The National Genealogical Society appointed an Ethics Committee and invited the Federation of Genealogical Studies to participate. The committee studied brochures and books compiled by Halbert's, Inc., one of a number of companies offering products masquerading as genealogy. The 120-page report showed the Halbert's also known as the "Family Book Offer" and "History Book Offer" misrepresented its products.

It is against the law to use the U.S. mails to collect money for schemes or devices by means of false representation. If you buy a product represented as being about your family, but whose distinguishing feature is a list of people with your surname, you can return it for a refund. If you have not received a refund within six weeks, complain to the **Consumer Protection Division**, U.S. Postal Service, **475 L'Enfant Plaza**, SW, Washington, D.C. 20260-2100.

THE IMMIGRANT

PAULA FROM SPODNI KAŠELJ*

Part III

About this time, the Sešeks had an interesting visitor from Slovenia. Paula's younger brother, Albin, came for a month's visit. It was a pleasant experience especially for the three boys who were brought closer to contact with the old country, the Slovenian language and met a unique personality from the old country. Albin seemed to be a perfect Slovene representative and everyone took a liking to him. He could sing Slovenian songs beautifully, play the button box accordion and in general, the children felt that it was "good" to be Slovenian.

Albin had an interesting side purpose in visiting his thre sisters. He had recently married the daughter of a "gruntar" (landowner) much to the satisfaction of his mother, Mina, who was getting on in years. Now, the Rojshek homestead could be put safely into the hands of Albin. However, signatures were needed from his three sisters, Johanna, Roza and Paula, waiving their rights to the homestead about to be transferred to Albin. He readily received these signatures and returned to Kašelj pleased with what he had accomplished in America.

Albin's visit seemed to bring unhappiness to Paula and Johan. They began to quarrel a great deal and very harshly. Inuendos were cast by Johan regarding Paula's past. It was no longer a pleasant household and the Christmas and Easter celebrations with big family dinners faded away. Each member of the family made his or her own meal whenever needed. The boys, now more mature, began to drift away.

John, having obtained a chemistry degree at a small college in Michigan, moved to South Cleveland taking a small room in a house near McGean Chemical Company on Harvard Avenue where he worked as a chemical engineer. John's degree made no impression on his father for the two men hardly communicated on anything for some time. Johan couldn't understand what a man did with a chemistry degree. He knew of college boys who were running elevators in downtown stores during the depression.

Eddie and Frank understood about John's degree, especially Eddie, who was so handy around the house and played the accordion well. He was always in demand for Saturday night playing jobs. Johan was proud of Eddie and Frank but he couldn't relate to John, who had moved to Seymour, Connecticut and eventually received a master's degree and then a doctorate. John was deferred during WW II because

of his work as a research metallurgist in New York for the International Nickel Company.

During John's yearly Christmas visits, he noticed that the coolness between Paula and Johan had continued. Paula expressed her independence by getting a factory job and a peculiar arrangement existed between husband and wife. Paula paid for the groceries, the upkeep of the kitchen, which included the gas, electric and telephone bills. Johan took care of the home, taxes and repairs. Each kept his or her own bank account; Paula saved her money and Johan saved his.

Then in 1947, a major medical event occurred. Johan sustained a stroke and his left arm was paralyzed permanently. His paper-hanging days were over. He was 59 and thought he wouldn't survive the winter even though he wished for one more spring. The Lord blessed him with 19 more springs although he was, thereafter, an invalid.

Johan's insurance policy paid him \$50 per month for the remainder of his life. With so much spare time on his hands, he considered starting a business selling plants and showing people how to raise them. However, he was advised that should he earn even five cents with this work, he would no longer be considered disabled and would lose his annuity. This clinched his disability and he didn't touch work again, not even minor repairs around the house.

Johan became completely retired with leisure on his hands. He read considerably, wrote numerous letters and spent an occasional afternoon at a tavern with a glass of beer. Every week he went downtown by street car, as he could not longer drive, to get a massage and a steambath.

Now, John completely reversed himself concerning his wife, whom he had been treating shabbily for some time. He began to appreciate her for her dedication to the family over the many hard years since arriving in America. She was dutiful and he now could see that she had been a marvelous wife and mother. His treatment of her became far different now and sometimes he would tease her and try to amuse her. Paula accepted this all at arms length. It was too late. She had kept her wifely responsibility, cooking for him and caring for his bedroom and clothes. But, at least there was no more tension in the house. They visited people together, socially, and whenever the grandchildren visited , there was considerable joy in the house. But they were never close again.

Frankie and Eddie had nice families and were doing reasonably well. Johnny was married and had a Ph.D., whatever that meant. Paula never understood. What impressed her was that Johnny had now "made it." He was a teacher. This fact she shared with her neighbors who also had children working as teachers in grammar school.

John said, "when I tried to explain that I was a professor in a university and department chairman with 35 members in the department, it was all lost on her. I was now 'a teacher' and that was good enough for her."

By now, Paula was completely in charge in her home and Johan was completely dependent on her. The house was paid for and there was money in the bank. She foolishly consented to loan \$29,000 to a distant relative who knew how to approach her. Paula's sons were furious with her; because of that, she managed to get the money back and the individual then borrowed money from the bank. Eddie was remarkably handy around the house on Shawnee with plumbing, papering, painting, fixing the garage etc. The two-car garage was rented as was the upstairs apartment. Taxes were modest and monthly social security checks all contributed to a comfortable life.

Since Paula no longer worked at a job, she used up her energy at gardening in a rather serious way. The empty lot next door became her garden. She just loved to work in that garden and did fairly heavy work, spading, watering, fertilizing etc. Her flower garden was remarkable with exotic flowers, the seeds of which came from Europe. The vegetable garden was no less a wonder and yielded lettuce, tomatoes and other vegetables by the bushels. She was generous to anyone who came along and praised her garden and they always walked off with a good bundle of lettuce, a half dozen tomatoes, maybe a cucumber of two and some radishes thrown in for good measure! Now she was never happier.

Gardening kept up Paula's stamina and her health. She ate well and received visitors regularly, which pleased her. She had developed an interest in baseball and could intelligently watch a good game; if there was a sports fan, within earshot, Paula could analyze the game, criticize the replacement of a pitcher she thought could still make it or criticize any other of the manager's tactics!

Johan was all praises for Paula and he too enjoyed the grandchildren. In the fall of 1965, at the age of 76, be became seriously ill and then stayed bedridden. Paula administered to him with all the care of a full time, professional nurse. After two to three months, he succumbed. It was a proper funeral and the entire family gathered. The stormy relationship they had had ended with the calm and solidness of a strong family.

Relatives came to the funeral and paid due respects. There was no gossip about the Sešek's – how they lived misunderstanding each other for theirs was a typical Slovenian marriage with its ups and downs brought about by extremely hard working conditions, insecurity and a strong determination to prove themselves in the new culture. Here were their children, educated and doing well, involved in business or a profession. For Paula it was the achievement of her goal, to have a financially secure future, never mind that she had a less than ideal marriage.

Paula was nearing eighty, older than any Rojshek she remembered and the last of her generation. She settled down to enjoy her last few years with a life that could not be sweeter. She became a frequent churchgoer for daily mass.

Early one morning, on a bitter cold day, she was struck down by a car, but survived, eventually returning to her garden but working at a much slower pace. In the winter of 1972-73, she began to falter and apprently knew something was going to happen. She revised her will and began to sort out certain papers, documents and precious letters which had been kept over the years, as far back as 1909. She began to tackle the huge accumulation of her magpie collections, instinctively trying to leave a tidy house.

One night Paula experienced heavy breathing problems and the next day she was taken to Euclid Hospital. Her heartbeat was erratic and the doctor diagnosed the need for a pace-maker which was scheduled for Wednesday. Using her acquired American phrases, she told Edward, her son, "If I can make it tonight, I'll be alright."

Felix Sesek was presumably the father of Paula's first child, Frank, even though she married his brother. When Frank reached adulthood his photograph was compared to Felix and a resemblance was noticed. Hence, the Sesek family believes that Felix and not John was Frank's natural father.

That night as Paula was lying in her bed, breathing heavily, she began to envision the memory of her wedding banquet in 1913. She discerned a faint singing of "Slovensko dekle," and followed the words: "Venček na glavi se, bliska iz kitice, rožic zelenih, Slovensko dekle." (Translation: Slovenian maiden, the wreath glistens from her braids – all flowers and greens, Slovenian maiden...) She could see many people gathered around her, all singing. There they were, everyone who had come to America and even those she had left behind in Slovenia. In front was her husband, smiling and singing to her. The harmonious melody filled the room and the corridors of the hospital. She was not sure if she was even in the hospital.

Paula sensed that a race was on. Would the song be

completed before she succumbed? She clutched her blanket as hard as she could. It helped; it sustained her breathing. "Dokler slovenski rod, biva po zemlji hod', bode slovelo, Slovensko dekle!" (As long as the Slovenian nation exists on this earth, the Slovenian maiden will be renowned...) The singing stopped. The song ended.

Paula's vision conveyed a message: She had made it! She had fulfilled the pledge made on her wedding night -that she would be a good Slovenian mother and wife. Keeping her pledge turned out to be difficult but she kept it. She knew it and they all knew it, otherwise why would all these friends have returned now, at the end—

In reality, Paula had made more of herself than being a good mother and wife. Her mother and sister, Johanna, had sold her short. They had made her life harder than necessary. Then of course, her husband, before he was stricken, had failed her, charging her with tricking him into marriage. They did not think she could make it but she did, and today, was her day of glory.

At her last moment, she envisioned two arms reaching down to her and and she raised her arms to meet them. She had been given the gift of life and enjoyed it to the fullest and at this moment she could not complain. There was just enough energy for one final sigh.

The nurse hurried to Paula, felt her pulse, and looked for other vital signs. There were none. She summoned the doctor on duty.

After Paula had succumbed, her son, John said, "Whatever God there may be, serving all of humanity, He never clutched to His bosom a more worthy soul."

Paula could look with pride on her family of three sons and grandchildren. There were more than 14 college degrees conferred of one kind or another. Each of the grandchildren received at least one college degree from some of the most prestigious educational institutions in the country. A gathering of the family took on an international flavor with possibly five or six languages being spoken. There is one Ph.D. and one Doctor Juris. Paula's maiden name of Plevnik was listed in **Who's Who in the World (1981-82)** not as one of the 20,000 entries herself but as the mother of a son who was listed, and gave her name.

Not bad for an immigrant woman, arriving in America penniless except for her fare to Cleveland and with no other familiar object but a paper with the address of her sister clutched in her fist.

THE END

John Nielsen, the second son of Paula, is shown at his old homestead at Kashelj enjoying a surprise reception by relatives and friends. On one trip to Slovenia he presented a play about the family's genealogy. There were over a hundred members of the clan in attendance for the great family picnic which he planned in its entirety and underwrote. They came from all over the U.S. and Slovenia to participate.

John P. Neilsen, Ph.D. allowed me the opportunity to edit the remembrances of his dear mother and publish them as an Immigrant article. We spoke on the phone many times, prior to his demise.

Dr. John Nielsen was born on Nov. 11, 1911, in Cleveland, attended Collinwood High School and earned his degree in Metallugry from Yale University in 1942 and his Ph.D. degree in 1947.

Dr. Nielsen published many articles, pamphlets, books etc. on metallurgical education, Soviet metallurgy, consulting and foreign travel. He holds three patents pertaining to dental work and is well known as the co-author of a paper on the nature of the bond between porcelain and gold alloys and the Shell-Nielsen test which is the most used test for the shear strength of such bonds.

John Nielsen passed away at the Slovene Home for the Aged in Cleveland in 1989. He was professor emeritus at the New York Polytechnic Institute and a precious metals researcher who helped develop several alloys for fillings, caps and other dental aids.

Dr. Nielsen is a sterling example of American-Slovene talent and the Slovenian characteristic of determination to succeed and bring honor to his family and his nationality.

CONCERN EXPRESSED BY FORMER NATIONAL SECRETARY

I am concerned about our membership and since I did not get an opportunity to read any of my report nor did most of you read it, I will give you a few statistics, so we can measure your accomplishments in the next four years.

Membership as of December 31, 1994 was 5,565, the lowest since 1934 (our 8th year of existence). What is even more alarming is that only 15% (850) of our membership is in the age group 25 years and younger, while 1/3 (1850) are 75 years and older. (One-half of the membership is 68 years and older.) Since reaching our peak of 13,300 members in 1955, we have lost 7,735 members.

Let's look at our statistics for the last four years. Our total loss in membership was 560 or an average of 140 per year. Our average loss due to death was 139 per year and considering our enrollment of new members averaging 162, we lost an additional 163 members from cancellations/suspensions. So all we have been doing is getting only one new member for each member being cancelled. What are we doing to replace the members lost by death? Can you imagine what this will be in four years, considering that 1/3 of our total membership is currently over 75 years of age?

I hope the current trend in 1995 will not continue. Thus far in the first four months of 1995, we have 76 deaths reported. This projected for the year would equal 228 deaths compared with the previous four-year average of 139 per year.

What can be done to reverse this trend? First, we must reduce the number of cancellations/suspensions. We already have these members, so how do we keep them? Secondly, we must recruit more aggressively.

Br. 20, Joliet is one of the few branches that maintains its status of membership. I wish to mention the top three campaigners of the last four years -- all come from branch 20 in Joliet:

Delegate, Jonita Ruth with 66 members!

I sincerely hope that Zveza can continue to have dedicated officers and members, to work for a brighter tomorrow!

HISTORY OF S.W.U. BRANCHES

Looking Back

to the Future BR. #103, WASHINGTON, D.C. MARYLAND, VIRGINIA

Part I

"The Early Years"

"You are cordially invited to attend a tea at the home of Irene M. Planinsek, 12 S. Van Dorn St., Alexandria, Virginia on September 12, 1965."

This invitation was issued by Miss Planinsek to women of Slovenian ancestry living in the metropolitan Washington D.C. area for the purpose of forming a branch of the Slovenian Women's Union.

Irene, a member of Branch 20, Joliet, Illinois, had traveled to Washington to pursue courses at Catholic University on a masters program in theater. While working on her master's thesis, devoted to Ivan Cankar, she became acquainted with three local Slovenes: Mr. and Mrs. Eric (Nika) Kovacic and Stane Sustersic. They in turn introduced her to other Slovenes in the area, namely, M/M Mirko Javornik, M/M Conrad Mejac, M/M Cyril Mejac, M/M Cyril Zebot, Miro Pregelj and others.

For many years, Irene had been active in the SWU #20 youth groups, starting out in folk dancing, as a drill team mascot, a member of the Junior Cadets and finally the Senior Cadets. Forming a branch of the SWU seemed the logical thing to do since interest in her Slovenian heritage could be continued. There was sufficient number of ladies in the area, however a unifying group did not exist. Irene shared her idea of organizing a branch of the SWU with Nika Kovacic who rendered valuable encouragement. The ladies who accepted the invitation and attended the tea on September 12, 1965, were Elaine Fleming, Florence Gregoric, Helen Horwath, Nika Kovacic, Mary "Mimi" Mejac and Ica Zebot. Christine Slapnikar attended as a guest from Illinois. Nika Kovacic recorded the proceedings of that first event and it was stated in the minutes of that first meeting "everyone came on time."

When the idea of forming Branch #103 of the Slovenian Women's Union was introduced by Miss Planinsek the ladies responded that it was a good idea and they could be counted on to join the fledgling group which would include not only Washington, D.C. but the states of Maryland and Virginia. Mrs. Fleming, Ms. Horwath and Mrs. Planinsek were already members of Branch #20 but consented to transfer their membership to the new branch.

Highlighting the event with an exceptionally beautiful and informative slide show was Dr. Stane Sustersic, who had photographed many beautiful scenes on his trips to Slovenia. Miss Florence Gregoric, who had also visited Slovenia, shared her photographs with the group as well.

Refreshments, consisting of delicate tea sandwiches, sweets and beverages, completed the meeting which concluded at 6 p.m. that evening with plans that the next meeting would be held on October 10, 1965 at Miss Planinsek's home.

For weeks afterwards Irene, assisted by Nika, searched in the metropolitan telephone directory for "Slovenian names," so that these individuals could be contacted about the next meeting. She typed up a letter and mailed it to over 100 individuals at her expense. A few Slovenes responded to the letter and some eventually became members.

THE SECOND MEETING

At the second meeting, the ladies discussed the site of future monthly meetings since traveling to Alexandria, VA was considered too distant for the majority of members. It was decided that for the first few months the meetings would be held in the members' homes starting with November at Mimi Mejac's residence in Washington, D.C. and in December at Nika Kovacic's home in Silver Spring, Maryland.

Three new members were welcomed at the second meeting: Minka Zalar and Matilda Podborsek of Washington, D.C. and Ivanka Antolin of Emmittsburgh, MD.

The very first project of the newly organized group, an art exhibit, entitled, "Contemporary Slovenian Art Abroad," was scheduled for the Washington Hilton Hotel, Oct. 17-30, 1965. Preliminary planning for the exhibit had preceeded the regular business meeting by members of the Slovene community so the project came to the branch in fairly definite form. Florence Gregoric assumed chairmanship of the refreshment committee and Ica Zebot, arrangements.

The Slovenian artists, Franc Gorse, Joseph Vodlan and Miro Zupancic, formerly of Slovenia but living in New York City, exhibited their paintings and Mr. Gorse his sculpted pieces. A letter from Sen. Lausche of Ohio, was read stating that he and Mrs. Lausche would attend the exhibit on Sun. Oct. 17. The exhibit proved to be a very classy event and all three artists sold many of their paintings and sculptures.

Along with the business meeting, a demonstration of hair styling was given by Mr. Anderson of the North Virginia Institute of Cosmetology. Refreshments followed and the meeting was finally concluded with everyone optimistic about the coming art exhibit.

FOURTH MEETING

Plans were made for the first Slovenian vernacular Mass to be said in the Crypt Church of the Shrine of the Immaculate Conception in Washington, D.C. by Rev. Francis Blatnik SDB of Patterson, NJ who was later requested to act as spiritual advisor to the branch.

The afternoon was highlighted by a demonstration of decorative floral arrangements for Christmas by Doris Parmalee, an interior and floral designer. Following the meeting and interesting demonstration, Nika Kovacic, hostess for the December meeting, entertained the ladies with delicious refreshments from a beautifully arranged table covered with a table cloth of Christmas design and accented with red net and fresh holly. The door prize was won by Ica Zebot.

FIFTH MEETING AND SLOVENIAN VERNACULAR MASS

Rev. Francis Blatnik of Patterson, New Jersey, celebrated the first Slovenian vernacular Mass in the Crypt Church of the Shrine of the Immaculate Conception with many in attendance. Key figures in the event were men of the Slovene community, some of whom were husbands of members: Eric Kovacic and Cyril Zebot served as lector and commentator. Conrad Mejac arranged for distribution of the hymns which were led by Stane Sustersic and Miro Pregelj. Ushers were Mirko Javornik and William Jagodnik.

Following Mass, the meeting was held at the home of

Agna Javornik and her daughter, Alenka (Pfeifer). The elaborate and delicious menu of homemade delicacies brought forth many compliments from the members. Rev. Blatnik presented a 45 minutes pictorial tour of Rome, the Vatican Churches and the highlights of the Ecumenical Council.

New members present were: Dorica Voyatzis (Vetrih), Helena Spacapan, Ivana Trost, Celeste Spehar, Antonia Urbancic, and the new junior member, Mariane Zebot.

SUBSEQUENT MEETINGS

On September 11, 1966, the new meeting season was initiated at St. Columba's Episcopal Church Hall in Washington, D.C., the location selected after research and by suggestion of Secretary, Mimi Mejac. The meetings continue to be held at St. Columba's Church Hall to the present.

Meetings have been scheduled for the months of September through April. Installation of officers is usually held in January with the spiritual advisor installing the newly elected officers. There have been three spiritual advisors thus far: Rev. Francis Blatnik, SDB of Patterson, NJ, Rev. Charles Ceglar and Rev. Raymond Wadas.

Being an unpredictable month, because of inclement weather, February was eliminated from the eight month meeting agenda, and the month of May was dedicated to the Mother's Day celebration rather than business.

Each meeting culminated with tasty refreshments prepared by two or three volunteers assigned a specific month. Culinary treats from apple strudel, cookies and cakes to

- 1967 -- Mr. Milan Kravanja presented color slides of his trip to Russia, mainly regarding fishing on the high seas.
- 1968 -- Mr. Eric Kovacic discussed Bishop Baraga's life and works among the Indians in Upper Michigan.
- 1968 -- Dr. Charles Zalar showed slides and discussed his travels around the world.
 - A discussion was given regarding people, customs and experiences in San Miguel, Philippines
- 1969 -- A guest speaker from Georgetown Hospital gave a discourse on things to do in an emergency.
- 1969 -- Dr. Mario Mollari lectured and showed movies of the people in the Central Congo.
- Dec. Demonstration by a professional from "Frame World,"
- 1976 -- Bethesda, MD on picture framing.
- Mar. Antonia Cigale demonstrated the art of making apple 1978 -- strudel.
- Nov. Walter O'Brian of Guardian Alarm Sales, Inc., Bethesda, 1978 -- MD, showed a movie on "Danger on Your Doorstep."

- Mar Mr. William J. Husic, Federal Aviation Agency retiree

The highlight of the convention was the Grand Banquet held in the International Ballroom, one of the loveliest in Washington. The Grand Banquet was formal with the majority of ladies wearing long evening dresses. It was perhaps the most elegant of all conventions ever held.

Guest speaker for the Banquet was a prominent American-Slovene, the Honorable Frank J. Lausche of Ohio, a Senator in the U.S. Government. Also in attendance were: The Honorable John A. Blatnik, U.S. Representative from Minnesota, along with his aide, Mr. James Oberstar, who is currently the U.S. Representative from Minnesota; the Honorable Frank Annunzio, U.S. Representative from Illinois; Honorable Ludwig J. The first of our guests is Rosemary Mlakar, of Irvine, CA. She was Regional President of the Western States before her recent move from Fontana. Rosemary found the cake recipe among her mother's things after she died – and noted her mother's remark: "very good!" written on it.

Thanks also to Irene Odorizzi who encouraged Rosemary to submit these three recipes at the Nat'l Convention in San Francisco.

REFRIGERATED DOUGH RECIPE CORRECTION

Please note the fifth line of the final paragraph and add: Sprinkle filling evenly with the rum-soaked raisins and then the remaining 1/2 cup sugar. On longer side start rolling up dough...

WATERGATE CAKE Beat: Box instant pistachio pudding package Duncan Hines white cake mix cup Wesson veg. oil 1 cup ginger ale 3 eggs 1 Add last, 1 cup chopped nuts (optional) Grease and flour 2 or 3 round cake pans or a Bundt pan. Bake at 350° until cake springs back when touched and springs back. Cool and frost. Frosting Whip until smooth - 1 box instant pistachio pudding with 11/4 cups milk, fold in 1 container (medium size) of cool whip If desired sprinkle with nuts and red cherries sliced in half. CREAM CHEESE STRUDEL Mix: 2 8 oz. cream cheese (room temp.) cups sugar 2 egg yolks beaten well bread crumbs 4 Beat 4 egg whites until stiff and add to first three ingredients. Whip 1 pint , whipping cream and add to first mixture. Add 1 tsp. vanilla. Strudel Dough: 1 tsp. salt 3 cups flour 1/_ 1 egg-add water to make one cup cup oil Mix all together and knead very well. Let rest in warm place for at least an hour. After stretching the dough spread the filling all over, sprinkle with some bread crumbs. (1/2 to 1 cup). Roll like strudel and brush with egg-water wash: one egg beaten with 1 tablespoon water. Bake 350° for 1 hour. Here's another filling for your strudel: LEMON STRUDEL FILLING Mix: eggs separated (beat egg yolks) 4 lemons and rind 3/4 cup bread crumbs 2 sticks margarine 3 cup sugar Beat egg whites with 1 cup sugar. Whip 1 pint whipping cream and fold in first mixture along with egg whites. Bake 350° for 45 minutes. This filling is a strong lemon flavor. Dust with powdered sugar and serve in

small pieces.

Quick impressions of Slovenia: Exchange rate was about 110 tolars for \$1; beer in village Gostilna \$1 and in Ljubljana \$1.50 while in Frankfurt it was \$4 a glass; there's a light beer made by Union Pivo called Uni Lite; 1 dip of Hagen Daas yogurt in Frankfurt \$1.50; Mount Vogel restaurant \$4.50 for sausage and kraut with a slab of their wonderful crusty bread; more casinos in Bled as well as several other cities; grafitti beginning to appear on city walls; fewer people are smoking; young folks, especially, are ecologically minded; Slovenians driving more expensive cars; about half the cars on the road drive with lights on during daylight hours also; more toys and colorful selection of children's clothing available in stores with price about the same as here; an ice machine is available for guests in Union Hotel's 4th floor; more excellent Alpine style ensambels than ever; lots of road construction especially in Ljubljana, but thankfully no orange barrels; Ljubljana's Mestni Trg (market place) also undergoing renovation; village ladies selling bouquets of fragrant lily of the valley along Tromostov bridge for 60 tolars (55c); housewives buying out a new product in the supermarket. Hit-Mix which makes super krofe (donuts) or potica with just a few extra ingredients; not only do supermarkets sell instant polenta (corn meal mush) they now have Instant Ajdove Zganci!; mass on Sundays have good-sized crowds with many young couples with their children; more and larger trucks on their highways; women are fashionably dressed and it's still a rarity to see a woman

It could be a chance to go back and recapture your heritage. Slovenia is the most beautiful country. If you have the opportunity to visit, either independently or on an organized tour, it is worth it. But, don't forget to see the small villages and countryside as well as the major attractions like Ljubljana, Lake Bled, Piran, Portorož, Koper and Postojna."



Mourning a Dear Member

Mary (Kovacevich) Aunan, 84, died Dec. 15, 1994, in Zumbrota, Minn. She was a member of Branch 33, Duluth, MN, for 46 years. She was born in Eveleth, a long time Duluth resident, moved to Edina in 1978 and to Zumbrota in June 1994. She was a member of Good Shepherd Church, Duluth, for 40 years. Survived by a daughter, two sons, two sisters, a brother, and eight grandchildren.

The following tribute was given at her funeral Mass by her daughter Karen Miley:

Our mother, grandmother and sister, Mary Helen Kovacevich Aunan, was born Dec. 12, 1910 in Eveleth, MN. She moved with her family to Gary (Duluth) as a young child and attended St. Elizabeth's church. When her mother, Eva and stepfather, Joseph Blazevich, sisters, Frances, Catherine and Marie and brother Paul moved to Illinois she stayed behind to be with her grandmother. After graduating from Morgan Park High School she worked for Dr. Anthony Bianco.

Sometime in 1938 she met our father, Norman Aunan, when he worked with his father as a carpenter in Gary. Mom walked past their work place every day on her way to work and according to her, dad would whistle at her. They seemed like a most unlikely pair at that time for he was from a Norwegian Methodist family in West Duluth. But unlikely as their union might have been, they were married in Sept. 1938, and made their home a 1 North 64th Avenue West, the only home that my brothers Frank, John and I knew as children and the home that mom so loved.

I recall how difficult it was for her in 1979, three years after dad's death; she sold her home and moved to Minneapolis to be near her grandchildren. How she loved that big old house with its memories of my father who was always in the midst of a remodeling project and of us kids who treated the house like our private playground. How many moms would allow the children to roller skate in the hall, have slumber parties for 30 of their friends, or be genuinely happy when when my brother's friends would regularly stop in for meals, use the laundry or sleep-in for a few days? My cousins remember that if they spent the night with us, they, too, had to swallow the nightly spoonful of cold liver oil.

There was always such a contradiction about mom in raising us kids, she was strict and yet she could not bear to punish or scold us. She truly could see no wrong in her children on her grandchildren.

Even after being away for 17 years her heart was always here in this community. The first thing that anyone in Minneapolis learned from her was that she was from Duluth. Occasionally, I would meet people in our neighborhood or at the super market who immediately knew her as that nice woman from Duluth. They also seemed to know a lot about Karen, Frank and John!

Shortly before my father died in 1976, he asked that we take good care of Mother. For some reason he and, I suppose, we thought she did not have the stamina to last long after him. She had seemed so dependent upon him. How wrong we were!! Her last years in Minneapolis were lonely without dad but she took on a whole new mission in helping to raise the youngest grandchildren and in making certain that we, her children and our spouses David, Barb and Sandy, did right by her grandchildren: Mary, Eric, Andy, Darcy, Tony, Anna, Matthew and Joey. I think we did just that!! And now Dave and Lisa have joined the family and soon mom and dad will have a great grandchild.

These last few weeks when her passing was near, she received numerous cards from family and friends. It seems only appropriate that my remarks this morning include the

greetings that she received. For not only did these please her and comfort her, they also helped to ease our pain and brought back many wonderful memories. The Slovenian Women's Union, sent their prayers - their prayers which reminded us of their magazine, a name we three could not pronounce, which mom read for years. She saved every issue. A neighbor from 64th Avenue wrote that her home was being taken care of, a neighbor from her apartment in Minneapolis missed mom's smile on "the street where they lived," and from her nephew's wife we received a note that says it all: "We will remember you as a good wife and mother and a good friend. Thanks for writing to us at Christmas for all these years. We love you." A niece wrote and thanked her for being the best "auntie" and for all the birthday cards. Her nephew wrote that he wished he could be there to give her a squeeze and thank her for being his special aunt for she had always been so good to him. A high school classmate recalled the fun times when they worked together at Fairmount Grand School when mom was president of the PTA and they collected coupons for silverware. Mom always said that she collected the most coupons. Another friend wrote about the many years they worked at the Arrowhead Clinic in West Duluth for Dr. Bell and of their lunch hour excursions ending with ice cream cones at Bridgeman's. A grandson wrote on her birthday card that "I always tell my friends that I have the best grandma and that's the truth grandma!"

We will all miss her unselfish ways, the telephone conversations where we only listened, the famous birthday cards and her genuine love of the Christmas holiday. Grandma will not be there this year to present her cards to each of you.

And so it seems most appropriate that after many years of being away from her favorite home and from this neighborhood in West Duluth, we should be here today at Good Shepherd Church to say our final farewell. This is the church where she faithfully took us to Mass every Sunday and where on rainy or snowy days my Father would drive us, where we were all baptized and confirmed, where Frank and John served as altar boys, where two of us were married and where mom required that every Saturday afternon we come for confession after attending the matince at the Doric theater.

It gives us great comfort to know that she will rest high on the hill amidst the white birch trees overlooking her favorite city, her neighborhood and her home, beside our father and his parents, Ingeborg and Andrew Aunan.







VIII. BARAGA APOSTOLSKI VIKAR V SAULTU SAINTE MARIE

DRUGIČ V DOMOVINI (1853 – 1854)

Baraga v domovini ni dosti govoril o svojem delu v misijonih. Pa mu tudi bi bilo treba, ker je bilo ljudstvu dobro znano. Pridigal je o temeljnih verskih resnicah.

Zadnjega januarja se je peljal v Trebnje. Dekan Rozman mu je šel z duhovščino in ljudstvom naproti. Zvonovi in streli iz možnarjev so ga pozdravili. Dekan ga je nastanil pri sebi v župnišču.

Šel je v grad pozdravit sestro Amalijo, ki je kot vdova, stara 60 let, živela tam s svojimi otroki in vnukii. Pač je moralo biti prisrčno tudi to njuno snidenje. Pred 23-imi leti se ji je krčilo srce, ko je kot preganjan kaplan odhajal v daljno, mrzlo tujino. Potem je zanj molila, mu pošiljala pisma in nabirala podporo. Zdaj je kot škof stopil prednjo in ji dal blagoslov. Oba so zalivale solze. Zbudili so se jima spomini na davno mladost, a tudi iz poznejšega življenja ju je vezalo premnogo dogodkov.

Na svečnico je imel Baraga v župni cerkvi blagoslov sveč inb slovesno škofovsko mašo, potem pa pridigo. Govoril je o ljubezni do uboštva. O tem mu pač ni bilo težko pridigati, saj je grad, ki je bil nekoč njegov, onstran Temenice še vedno trdno stal, a ni nosil njegovega imena. Ljudstva je toliko prišlo, da ga je bilo polno tudi pokopališče ob cerkvi in so morali orožniki skrbeti za red. Pevci so mu s kora zapeli pozdravno pesem, ki jo je bil nalašč za to slvoesnost zložil Emanuel Tomšič in ki jo je potem priobčila Zgodnja Danica. Po maši je imel Baraga še nemško pridigo o darovih Svetega Duha in je birmal sedemletnega Jožefa Friderika Gressla, vnuka Amalije, ki je bil pozneje častnik pri kranjskem 17-em regimentu v Celovcu.

Dekan Rozman je pripravil slavnostno kosilo za visokega gosta, za duhovščino in za uradništvo. Baraga se je opravičil, da ni vajen takih gostij. Zajel si je na krožnik nekaj krompirja in sočivja, pojedel, se prijazno poslovil in se umaknil v svojo sobo.

Samo še en dan se je potem ustavil v Trebnjem.

 februarja je obiskal svojo rodno Malo vas in svojo krstno župnijo Dobrnič. Tudi zdaj je skoraj pol ure molil pri krstnem kamnu in jokal, da so se vsem navzočim rosile oči. Potem je šel naravnost k oltarju in dolgo govoril o krstu in o posvečujoči milosti.

Preko Novega mesta se je čez Gorjance peljal v Metliko, kjer je bil v gorju in bridkostih dozorel za indijanske misijone. V nedeljo 5. februarja je prihitela vsa okolica, da ga vidi in sliši. Imel je slovesno škofovsko mašo. Pridigal je o molitvi, o misli na božjo pričujočnost in o štirih poslednjih rečeh. Nazaj grede je še enkrat obiskal Dobrnič in Malo vas. V graščini Mala vas se je eno uro pogovarjal s tedanjim lastnikom Julijem Treom, vnukom Santa Treo, ki je bil kupil Malo vas od njegovega očeta. Tako se je raznežil, da je jokal. Tudi na trebanjskem gradu se je – zadnjič v življenju – pri svojcih še malo ustavil. Amalija je bila opazila, kako siromašno je oblečen. Hitro mu je dala napraviti več kosovo perila. On je pa sprejel samo nekaj malega, vse drugo je podaril siromakom. Ko mu je sestra rekla, da je perilo dala narediti zanj, je odgovoril: "Zame je dovolj, če imam toliko da se lahko preoblečem."

Ko se je peljal proti Ljubljani, je v Višnji gori obiskal tudi upokojenega kaplana Antona Sadavina, s katerim sta skupaj službovala v Metliki. Sivolasi 80-letni starček se je z obiskom čutil silno počeščenega. Na obe koleni je pokleknil pred Barago in ga prosil odpuščenja za svoje nekdanje neljubeznivosti do njega, zlasti ker ga je bil takrat s škornjem oplazil po glavi. Rekel je, da ga je tisti dogodek vsa leta pekel v duši. Zajokal je. Tudi Baraga je bil ves ganjen; hitro ga je dvignil, prisrčno objel in poljubil. Potem sta se pogovarjala kakor prijatelja iz davnih dni.

Tudi svoje prvo kaplansko mesto, Šmartno pri Kranju, je hotel še enkrat videti. Spremljal ga je njegov prijatelj in podpiratelj njegovega misijona, kanonik Novak. Duhovščina ina ljudstvo sta ga svečano in prisrčno sprejela. V soboto je v Šmartnem maševal. Popoldne je šel v Kranj, obiskal dekana in okrajnega glavarja in sprejel odposlanstvo meščank, ki so mu izročile lep misijonski dar. Zvečer je šel v Šmartno. Tam je obiskal več družin, na katere je imel lepe spomine iz svojih kaplanskih let. "V nedeljo je pa bila v Šmartnem velika slovesnost, h kateri je privrelo veliko ljudstva iz vseh krajev," je pisala Zgodnja Danica. "V pridigi so blagrovali zbrane vernike, da so v pravi veri vzrejeni. Ko so pa rekli, da jih zdaj ne bodo več videli, je bila žalost velika. Po sv. maui, kakor tudi prej ta dan, so jih njih nekdanje ovčice obilno obiskovale ter jim z mnogoterimi znaki in darovi izkazovale svojo ljubezen." Popoldne je imel še kratek poslovilni govor.

Proti večeru se je vrnil v LJubljano in obiskal Alojzijevišče. ŠDtudentje, med katerimi je bil tudi poznejši pesnik Josip Stritar, so kapelo slavnostno okrasili in razsvetlili. Imel je blagoslov, potem je šel gojence pozdravit po učilnicah.

13. februarja se je s sestro Amalijo odpeljal proti Rimu. V Postojni ga je v imenu zbrane duhovščine pozdravil dekan, ki mu je Baraga kot metliški kaplan pridigal pri novi maši. "Duhovniki so se vsi srečne šteli, tako slovečega ameriškega škofa in slavnega rojaka videti, in se niso mogli prečuditi njegovi ponižnosti in priljudnosti." Tako je pisala Danica.

Od Trsta do Ankóne sta se z Amalijo vozila z ladjo.

Papež Pij IX. je Barago dvakrat zelo ljubeznivo sprejel, 27. februarja in 5. marca. Enkrat je bila z njim pri sprejemu tudi sestra Amalija. Antonije pa ni bilo zraven. Baraga je papežu poklonil en izvod očipvejskega slovarja in en izvod slovnice. Papež mu je podaril dragocen mašni kelih.

Pri sprejemu 5. marca je Baraga izročil papežu latinsko prošnjo, da bi povzdignil njegov apostolski vikariat v redno škofijo, ki naj bi se po svojem središču Sault Ste. Marie imenovala "Marianopolitana". Pa mu zaenkrat še niso ugodili.

O svojem apostolskem vikariatu je obširno poročal kardinalu Franzóniju, predsedniku Kongregacije za širjenje vere, in njegovemu tajniku Alojziju Barnabó. Amalija je brata zto spremila v Rim, da sta obiskala sestro Antonijo, ki je imela tam dekliški vzgojni zavod. Rimsko podnebje ji je mnogo bolje delo kakor ameriško. – Tri leta nato, leta 1857, jo je Amalija spet obiskala z eno izmed hčera in je več mesecev ostala pri njej. Takrat se je Antonija – tako so govorili – spet privadila slovenskega materinega jezika, ki se ga je bila v dolgih letih tujine že nekoliko odvadila.

V Rimu je Baraga maševal v cerkvi sv. Petra in v druvih slavnih cerkvah. Enkrat je nemško pridigal.

Vračal se je s sestro preko Florence in se je 16. marca spet pripeljal v Ljubljano.

Kot šmártinski kaplan je imel dušnopastirske zveze tudi s Staro in Škofjo Loko. Ko je prišel na obisk v Šmartno, so ga Ločani prosili, da naj pride tudi k njim. Res se je zvečer pred praznikom sv. Jožefa pripeljal v Škofjo Loko. Zvonovi in možnarji so oznanili njegov prihod. Drugi dan, na praznik, je pridigal o krepostih sv. Jožefa. Pri škofovski maši mu je streglo 11 duhovnikov. Zgodnja Danica je poročala: "Silno velika množica se je zbrala. Prav prijazno in ljubeznivo so se pogovarjali in povedali marsikaj mikavnega o svojih Indijancih, kako dobri kristjani so, potem ko se k sv. veri spreobrnejo." Obiskal je tudi uršulinski in kapucinski samostan. Proti večeru je šel v Staro Loko, kjer je imel rožni venec in litanije. Ko se je med veselim pritrkavanjem zvonov peljal od njih, so v oknih gorele luči. Starši so opominjali otroke, da si naj ta veseli dan dobro vtisnejo v spomin, ker kaj takega gotovo ne bodo več doživeli.

Res še dandanes stari ljudje v Sloveniji vedo, kar so bili slišali od svojih staršev: kako so ljudje hiteli skupaj, da vidijo Barago in slišijo njegovo pridigo.

Na praznik Marijinega oznanjenja, 25. marca, je imel slovesno opravilo pri ljubljanskih frančiškanih, ki imajo na ta dan cerkveno proščenje. V pridigi je razlagal, kako lepa je molitev angelovega češčenja. Drugi dan je bila nedelja. Pri sv. Petru je pridigal o Jezusovi krotkosti, ponižnosti, potrpežljivosti in ljubezni do nebeškega Očeta.

V ljubljani je obiskal tudi bogoslovje, gimnazijo in druge šole. Mladini je posebno naročal, naj se varuje greha. Študentje višje gimnazije so mu zložili 42. goldinarjev.

Tudi drugod so mu ljudje prinašali za misijone. Neka siromašna ženica mu je darovala vse svoje imetje: en krajcar. Ta "dar uboge vdove" ga je tako razveselil, da ga je posebej spravil; naj bi pričal Indijancem, da bi Slvoenci radi še bolj pomagali misijonarjem, če bi bili bogati. V Ljubljani je rekel v neki pridigi: "Ne želim biti bogat; pa bi vendarle imel rad mnogo denarja, da bi z njim lahko mnogo dobrega storil."

Razume se, da tudi na tem obisku domovine ni pokusil opojne pijače. Večkrat je nehote pokazal, da je bil o razmerah v domovini dovolj dobro poučen.
