General Order No. 108 (72 B)

ENGAGEMENT, DISMISSAL AND REGISTRATION OF WORKERS

WHEREAS it is considered necessary to amend General Order No. 72 of the Allied Military Government relating to engagement, dismissal and registration of workers in that part of Venezia Giulia administered by the Allied Forces

NOW, THEREFORE, I, ALFRED C. BOWMAN, Colonel, J.A.G.D., Senior Civil Affairs Officer

ORDER:

ARTICLE I

Article VII - Control of Unemployed - Section 1 - shall be amended to read as follows :

„Unemployed workers shall report every month at the Labor Office where, upon their continued unemployment being ascertained, their Registration Cards shall be stamped and signed“.

ARTICLE II

Article X Section 1 shall be amended by adding to the final sentence after the word „engagement“,

„and the authority shall be for such period or periods as the Labor Office may determine“.

ARTICLE III

EFFECTIVE DATE

This Order shall become effective on the date that it is signed by me.

General Order No. 109 (92 A)

PROVISIONS RELATING TO DIRECT TAXES

WHEREAS it is deemed necessary to amend the Article V of General Order No. 92 (25 D) in those parts of Venezia Giulia administered by the Allied Forces (hereinafter referred to as the „Territory“),

NOW, THEREFORE, I, ALFRED C. BOWMAN, Colonel, J.A.G.D., Senior Civil Affairs Officer,

ORDER:

ARTICLE I

Article V of General Order No. 92 (25 D) dated February 21, 1947, is hereby amended to read as follows:

„With effect from *1 January 1947*, taxable income from „terreni“ and „reddito agrario“ liable to taxation under R. D. L. 4 April 1939, No. 589, converted into Law No. 976 of 29 June 1939, shall be increased 12 times“.

ARTICLE II

For the years 1947 and 1948 the rates of State tax on „terreni“ and „reddito agrario“ shall be reduced to 5% for firms, private individuals and bodies entered in the rolls for an income on „terreni“ and „reddito agrario“ not exceeding Lire 2.000 and Lire 700 respectively, after the general revision of the valuation of land-holdings as provided for by the above mentioned R. D. L.

This Order shall come into effect on the date it is signed by me.

ARTICLE I

No. 208/1 field and of part cat. No. 208/2 meadow of the tax-district of Tomadio, entered as property of the Roman-Catholic Parish-Church of St. Peter and Paul at Tomadio,

for the property constituting the single land-registry body Part. tav. No. 28 of Tomadio, Part. cat. No. 1433, vineyard of the tax-district of Tomadio, entered as property of RAVBAR GIUSEPPE, son of the late Giovanni at Tomadio No. 26/80.

STATE ALLOWANCES („ASSEGNI DI CONGRUA“) IN FAVOUR OF CLERGY

WHEREAS it is considered necessary to provide for economic betterments in favour of the Clergy enjoying State allowances („Assegni di Congrua“) within that part of Venezia Giulia administered by the Allied Forces (hereinafter referred to as the „Territory).

NOW, THEREFORE, I, ALFRED C. BOWMAN, Colonel, J.A.G.D., Senior Civil Affairs Officer hereby

ORDER :

ARTICLE I

INCREASE OF „LIMITI DI CONGRUA“

With effect from 1 September 1946 the „Limiti di Congrua“, the „Spese di Culto“ and the other fixed allowances due at present to the Clergy in accordance with the provisions contained in R.D. 29 February 1931, No. 22, and in Order No. 61, dated 15 January 1946, are hereby temporarily increased by 200%.

Order No. 392 (103 C)

ALLOWANCES FOR UNEMPLOYMENT INDEMNITY AND FOR CERTAIN UNEMPLOYED WORKERS

WHEREAS it is deemed advisable and necessary to discontinue the special unemployment indemnity provided by Order No. 82 of 5 March 1946; and

WHEREAS it is considered advisable to grant in lieu of the special unemployment indemnity, and increase of the supplementary allowance to the normal unemployment indemnity granted by Order No. 103, dated 5 April 1946, as already increased by Order No. 103 B, dated 16 August 1946, as well as to grant an extraordinary allowance to unemployed workers who are not entitled to such indemnity, in that part of Venezia Giulia administered by the Allied Forces (hereinafter referred to as the „Territory“),

NOW, THEREFORE, I, ALFRED C. BOWMAN, Colonel, J.A.G.D., Senior Civil Affairs Officer,

ORDER:

ARTICLE I

CESSATION OF SPECIAL UNEMPLOYMENT INDEMNITY

The special unemployment indemnity provided for in Order No. 82, dated 5 March 1946 shall cease to be payable on 31 May, 1947.

ARTICLE II

INCREASE OF SUPPLEMENTARY ALLOWANCE TO UNEMPLOYMENT INDEMNITY

As from 1st June 1947 the supplementary unemployment allowance provided by Order No. 103 Article I - Section 1 (a) subsequently increased by Order No. 103 B Article I - Section 1 (a) shall be further increased from Lire 50 to Lire 80 daily.

ARTICLE III

GRANT OF AN EXTRAORDINARY ALLOWANCE

Section 1. — Those workers who are residents of the Territory and who are involuntarily unemployed having lost a regular employment in the Territory, and on whose behalf a contribution of compulsory insurance against unemployment has been paid or was due after 30 June 1939, or, if they were called to Arms, during the 12 months preceding the date on which they joined for service, shall be granted an extraordinary unemployment allowance, provided they are not eligible for the daily indemnity referred to in Article 19 of R. D. L. 14 April 1939, No. 636, or the term during which they were in receipt of the normal indemnity has expired.

Section 2. — The extraordinary allowance referred to in the foregoing Section shall be equal to the supplementary allowance provided for those entitled to the unemployment indemnity and shall be increased for each dependent child by the same amount as provided for the above mentioned allowance.

Section 3. — The extraordinary allowance shall be payable for a period of 180 days, as from the date of submission of the application by the person concerned.

ARTICLE IV

WORKERS NOT ELIGIBLE

The following workers are not eligible for the extraordinary allowance :

- (a) Those who are in receipt of subsidies, indemnities, salary supplementations and dismissal indemnities, as well as those in receipt of pensions and annuities paid or borne by the State, by local Bodies or Social Insurance and Welfare Institutions ;
- (b) those who do not answer the check call of their condition of unemployment ;
- (c) those who find new employment, or have refused employment offered to them ;
- (d) those who belong to categories whose work is occasional and irregular in normal times ;
- (e) those who are enrolled in the lists of agricultural workers as specified in Article 12 of R. D. 24 September 1940, No. 1949 ;
- (f) those who have refused or neglected to attend the compulsory courses of professional education or laboratory practice in terms of Article 67 of the regulation relating to compulsory insurance against involuntary unemployment, contained in R. D. 7 December 1924, No. 2270.

ARTICLE V

REGULATIONS TO BE COMPLIED WITH

The regulations of the compulsory insurance against involuntary unemployment governing :

- (a) The grant and payment of the daily indemnity ;
- (b) the maximum period subject to indemnification ;
- (c) the suspension and cessation of the right to the benefit of the said indemnity ;
- (d) appeals against the rejection of the applications ;
- (e) the paying agencies and supervision, shall also apply to the payment of the extraordinary unemployment allowance.

ARTICLE VI

PAYING AGENCY

Istituto Nazionale della Previdenza Sociale shall provide for the payment of the extraordinary unemployment allowance, keeping separate accounts therefor under the administration of „Fondo d'integrazione per le assicurazioni sociali". The said allowance shall be a charge on the said fund.

ARTICLE VII

TRANSITIONAL PROVISION

Those who up to 31 May 1947 were in receipt of the post-war unemployment indemnity („indennità di disoccupazione dopoguerra") provided for by Order No. 13 dated 1 September 1945, and/or of the special unemployment indemnity provided for by Order No. 82 dated 5 March 1946, shall be eligible for the benefits of the extraordinary unemployment allowance, provided their cases meet with the requirements set forth in Article III, Section 1, of the present Order, subject to the following limitations :

- (a) if they were in receipt of the aforesaid special unemployment indemnities for a number of days equal to or exceeding 360, their eligibility for the extraordinary unemployment allowance shall be made subject to the existence of a new state of unemployment ;
- (b) if they were in receipt of the aforesaid special unemployment indemnities for a number of days exceeding 180 but not exceeding 360 and if their state of unemployment was not interrupted by a period of employment, they may be granted the extraordinary unemployment allowance for a number of days equal to the difference between the number of days already indemnified and a maximum of 360 days ;
- (c) if they were in receipt of the aforesaid special unemployment indemnities for a number of days not exceeding 180, they may be granted the extraordinary unemployment allowance for the entire duration as laid down in Article III, Section 3, of the present Order, even if their state of unemployment was not interrupted by a period of employment.

EFFECTIVE DATE

This Order shall become effective upon the date it is signed by me.

Order No. 396

PROVISIONS RELATING TO TEMPORARY PERSONNEL SERVING WITH PUBLIC ADMINISTRATIONS

WHEREAS it is deemed advisable and necessary in that part of Venezia Giulia administered by the Allied Forces (hereinafter referred to as the „Territory“) to establish certain provisions concerning the juridical and economic treatment of the temporary civilian personnel serving with public administrations,

NOW, THEREFORE, I, ALFRED C. BOWMAN, Colonel, J.A.G.D., Senior Civil Affairs Officer,

ORDER:

ARTICLE I

PROVISIONS CONCERNING THE TREATMENT OF TEMPORARY PERSONNEL SERVING WITH PUBLIC ADMINISTRATIONS

Section 1. — Except as and with the modifications established by the following Sections of this Article, the provisions of D.L.C.P.S. 4 April 1947 No. 207, issued by the Italian Government, (hereinafter referred to as the „said decree“) and regarding the „Juridical and economic treatment of temporary civilian personnel serving with public administrations“ are extended pursuant to this Order, in so far as applicable, to the Territory.

Section 2. — The first paragraph of Article 10 of „said decree“ is hereby cancelled and the following substituted in lieu thereof :

„With the exception of Article 5, the temporary personnel who happen to be excess in respect of the service requirements, may be transferred, when required, to other offices of the same ore another State administration, which are actually in want of personnel“.

Section 3. — The third paragraph of Article 10 of „said decree“ is hereby cancelled and the following substituted in lieu thereof :

„As a consequence of the transfers ordered in conformity with the first paragraph hereof, it will be arranged, with the authority of the Allied Military Government, for the variation of the number of the temporary personnel assigned to the interested administrations. The transfer is not subordinated to a preexisting faculty of the administration to employ temporary personnel.“

Section 4. — The penultimate paragraph of Article 10 of „said decree“ is hereby cancelled and the following substituted in lieu thereof :

„Each administration shall give notice to the Allied Military Government of the eventual surplus or deficiency of temporary personnel, stating the category and the service they belong to.“

Section 5. — Point 1. of the second paragraph of Article 12 of „said decree“ is hereby cancelled and the following substituted in lieu thereof :

„1. — For the employment and re-employment provided for by Order No. 235 dated November 23, 1946, and No. 324 dated March 5, 1947“.

Section 6. — Point 4. of the second paragraph of Article 12 is hereby cancelled.

Section 7. — The last paragraph of Article 12 is hereby cancelled.

Section 8. — Articles 13, 14 and 15 of „said decree“ are hereby cancelled.

Section 9. — The second paragraph of Article 19 of „said decree“ is hereby cancelled.

ARTICLE II

FINAL PROVISIONS

Section 1. — All references to the Italian State or to other bodies, Ministers, or Officials acting under its authority, contained in the D.L.C.P.S. 4 April 1947, No. 207, shall be considered as not existing and shall be substituted by the words : Allied Military Government and Officials or Bodies operating in the Territory under the control of Allied Military Government ; and nothing which is contained in such decree may vest any authority on the Italian State, person or Body operating under its authority, either with regard to persons, or to properties or matters existing in the Territory.

Section 2. — A copy of the D.L.C.P.S. 4 april 1947 No. 207, has been deposited in the offices of the Finance Intendencies and Area Presidencies and may be freely examined by all interested parties.

ARTICLE III

EFFECTIVE DATE

This Order shall become effective in the Territory on the day that it is signed by me, and the provisions referred to in Article I hereof are operative as from 1 May 1947.
