80 Years of Publishing Zarja

1780

Lemont, Illinois 20 June 2009

I am deeply appreciative of what Slovenian organizations have meant in my life and the life of my family.

I would like to add a couple of personal thoughts to today's celebration. As a child I had a favorite place to read in my parent's home. I used to lay on the dining room floor between the table and the radiator. It was warm, there was a window on each side of the radiator that provided a lot of light. Each month Zarja was delivered to our home and I would open it up and read it. It was written in both Slovenian and English in those days and I enjoyed reading all the articles from people in far away places. I never realized until I was much older how much of an impact Zarja and organizations like SWUA had on my mother and other women like her. When my parents moved from their home on the east side of Cleveland, I was already living in Chicago. I went home to clean out my childhood closet. In the back of my closet was an old box and it had some letters in them. I opened them up and found these beautiful letters from my grandmother to my mother. Both my parents were immigrants and my mother like many other women were here in America without their mothers, grandmothers, aunts and older sisters to mentor them about being a Christian mother. I could read my grandmother's pain in between the lines of text. She could not be there to see her oldest daughter married.

Over the last 80 years, SWUA and Zarja have tried to fill that role. They tried to help these women be Christian wives and mothers. For those of you who will go to mass tomorrow morning, you will hear these words from Paul's letter to the Corinthians:

Če je torej kdo v Kristusu, je nova stvaritev. Staro je minilo. Glejte, nastalo je novo.

Which translates to:

So whomever is in Christ is a new creation. The old things have passed away; behold, new things have come.

I think that is true for SWUA today. The old has passed away and a new era is now upon us. As the organization

National Board of Directors Annual Board Meeting April 02-05, 2009

Held at: Slovenian Women's Union of America National Heritage Museum, 431 N. Chicago, Joliet, IL.

Prior to the initiation of the Board of Director's Meeting, President Bonnie Prokup provided board members with a tour of the recently renovated apartment that is upstairs and over the museum.

04/02/09: Call to Order at 3:10 p.m. by President Bonnie Prokup. Roll call conducted and those present included: President; Bonnie Prokup, Vice President of Outreach; Debbie Pohar, Vice President of Marketing and Fund Raising; Bernadette Kovacic Fitzsimmons, Vice President of Culture and Heritage; Mary Lou Voelk, Treasurer; Denise Bartlett, Vice President of Home Office; Carol Ryba, Correspondence and Recording Secretary; Karen Taylor. Absent: No board members were absent.

Guest: Betty Ann Kolasari and Jonita Ruth

Minutes to the Meeting

- Opening prayer, Our Father, led by Bernadette Kovacic Fitzsimmons in Slovenian and then repeated in English.
- Welcome and overview of the board meeting agenda and activities provided by President Bonnie Prokup. Changes to the agenda were made as needed.
 - o Lodging plans were confirmed, and with the availability of the upstairs apartment for both meeting space and overnight accommodation for four board members, an estimation of more than \$2,000 was saved in expenses. In addition, another board member was successful in getting some of the additional hotel rooms needed for this meeting provided free of charge. President Prokup continued to stress the need for the board to remain fiscally responsible whenever we meet or work and thanked this board for the high degree of volunteerism and willingness to donate both time and money in order to best serve the SWUA.

o President Prokup reminds the board of their professional obligation to continue to work together to ensure the best interest of the all aspects of the SWUA and to that endeavor, to work closely and productively with the newly formed Museum and Heritage Board.

o Official acknowledgement of Mary Lou Voelk as Vice President of Culture and Heritage following the resignation of George Plautz Jr. in December of 2007. This is Mary Lou's first attendance at a board meeting.

President Bonnie Prokup's report included the following updates:

- The third Camp Heritage was held last summer and another is being planned.
- Remodeled upstairs is near completion.
- Received the highest amount of donations to Zarja in years- over \$13,000 was donated in the past year.
- Additional funding needed to meet our operating demands.
- · Membership has continued to decrease.
- Encourages the board to remain focused on our vision and mission.

Vice President of Outreach, Debbie Pohar topics covered included:

- · Goals for Zarja
- · New Features
- · Printing plans and improvements
- · Communication Strategies
- Results of 2008 Slovenia Trip:
- · Budget:
 - o 2008 budget was \$71,400
 - o Actual costs were \$66,988.35
 - o Projected budget for 2009 \$73,866

Jonita Ruth requested to speak to the NBOD regarding the following items:

- The protocol to observe at death of a SWUA member.
- Museum sales are down and she suggests that we need to advertise items for sale in the Zarja.
- Each branch should be responsible for coming up with at least one business who will take out an advertisement in the Zarja in order to generate more income to the Zarja.
- · New membership campaign needed.

President Bonnie Prokup called the meeting to adjournment at 5:15 p.m. for a dinner hour.

Recall of the board meeting by President Prokup at 6:15 p.m.

Membership and Marketing Report from Bernadette Kovacic Fitzsimmons; Vice President of Marketing and Fund Raising: Written report from January 08 - March 09 is available in the March/April Zarja. Her report provides information on the status of SWUA membership and ideas to increase membership. Other issues include:

- Reports that more Juniors are being added to the overall SWUA membership.
- · Fees related to membership.
- Reported on her recently initiated survey
 Our costs for the service are as follows:
 - \$153/YEAR-need to pay by 4/17 to continue at discounted rate.
 - o \$130 for non-profit.

Denise Bartlett makes a motion that the SWUA continue to contract with Constant Contact at their discounted yearly rate in order to continue to survey our membership regarding the strength and needs of the organization and the individual services it provides to those members.

Debbie Pohar seconds the motion. Vote: unanimous

Call for the close of business by President; Bonnie Prokup at 8:26 p.m.

April 03, 2009 - Friday

President Bonnie: Call to Order at 9 a.m. All Board members present.

Vice President of Home Office: Carol Ryba's Report:

We anticipate that we will have a shortage of \$26,000 in 2009 and will again have to withdraw from our investments. Costs that we have budgeted for in 2009 are as follows:

- \$7,600 building renovations.
- \$4,130 building repairs and maintenance.

Expenses were discussed and Carol has determined ways to cut costs and save us additional monies whenever possible.

- Utilities.
- Phone service reduced our phone service expenditures by \$400 a year.
- · Postage.

Denise Bartlett introduced a roundtable discussion regarding the Heritage Fund.

Carol Ryba reports that Investment losses over the last year are the biggest we have experienced, a \$17,447 loss in investments. Membership: Membership numbers are now fairly accurate at 3,963. Membership has decreased and continues to decline each year. We are losing more than we gain each quarter and we need to work on this. We have over \$13,000 in unpaid adult membership dues. 2,125 members are insured and 110 juniors are insured.

- Denise Bartlett indicated that bylaw 3.09 states those members who fail to pay by the 3rd month of the year are to be cancelled but can be reinstated if they pay their dues in full within the same calendar year. If they fail to do so they can rejoin without getting their insurance.
- President Bonnie Prokup recommends that it would be good to have Bernadette have Access in order to gather information for membership campaigns.
- Bernadette Kovacic Fitzsimmons indicates that many of our young adult (18 - college aged) or junior members don't really have a way to be involved in SWUA and suggest one way to keep them more interested in membership would be to find a way to connect them to be social members at a reduced rate such as a \$10 yearly membership fee.

Carol reports that the Home Office is in need of new filing cabinets to safely store all of the death records.

It is determined that a motion to approve the budget will be delayed until after we hear the report from Ronald J. Erjavec of the First Midwest Bank; Trust Division.

Fund Raising: ideas for fund raising was discussed.

Vice President of Home Office: Carol and Treasurer Denise Report on Burial Insurance:

- We have 2,235 current policy holders.
- We have 1,700 members without policies.
- Options regarding the maintenance of the policies were discussed.

Report by Bernadette Kovacic Fitzsimmons:

Regarding the recent donation of a book for our collection: Anton Peterlin 1908-1993 Zivljenje in delo: His Life and Work. Anton Peterlin is a world known scientist. The book has been donated by his daughter, Dr. Tonja Peterlin Neumier. A thank you card was signed and sent to Tonja and a picture of the presentation of the book donation to be printed in the Zaria.

President Prokup called the meeting for a recess for lunch from 12-1 p.m.

President Prokup called the meeting to resume for business at 1:00 p.m.

Report by Denise Bartlett regarding 2011 Convention:

- Betty Ann Kolasari and Denise are currently working to find site and hotel accommodations in Milwaukee.
 - o The current budget is about \$12,000-\$14,000 plus the proceeds of any additional cookbook sales.
 - o Registration fees may be needed.
 - Camp Heritage may not be held at this year's convention.

President Bonnie Prokup requested that Denise Bartlett should research possible sites and determine which is the most appropriate.

Report from Ron Erjavec and Joy Gruber from First Midwest Bank-Trust Division

Ron reports that in the last year all stocks have declined and as a result we like almost all of Americans, have experienced a loss.

- While we only have 20% of our investments in stocks we still have lost money overall due to a declines across all of our investments.
- 78% of our account is in fixed income and it is doing well.
- He is recommending that SWUA get rid of a particular fund that continues to lose money. It is only about 3% of our investment but he intends to sell it.
- He has also sold most of the Goldman Sachs fund and intends to sell the rest of it as well.
- The total market value of our investment is now at \$614,828.
- Our expenses over the last year have been significantly over our income.
 - o Income-\$23,750.34
 - Total loss -\$41.545.78, this is in part due to costs related to the repairs required to the building this year.
- He believes that the coming year is looking like we may begin to see a turn upward in the market.

Jan King joined the National SWUA Board of Director's meeting at 4:15 p.m.

Mary Lou Voelk and Jan King provide a report on the Museum's 501c3 status:

- The newly formed organization incorporation is now complete.
- They will need a registered agent from Illinois in order to be approved Dept. of Corporation.
- o They will need to be a complete a charitable registration, establish a budget, finalize their bylaws and establish their own board in order to be approved for 501c3 status.
- o Board members have been selected
- Copies of the draft bylaws were provided for review and recommendation are as follows:
- It needs to be clear that this board is under the SWUA board.
- It was the consensus of the entire SWUA NBODs that we would like to see our Vice President of Culture & Heritage be the Chair of the Slovenian Heritage Museum.
- Separation of funds was discussed.

Mary Lou Voelk provided a report on the on-going Preservation Projects

- Ivana Project records scanning for preservation.
- Preservation of information and stories related to World Conflicts.
- o Zarja Project.
- Our third Camp heritage was held this summer. We started in 2003 and then held them again in 2007 and 2008. We will plan to do another one.
- Recommends an audio version of the Forget-me-not books.
- Documenting our collection of Slovenian books so we have an account and are able to determine their value.

President Prokup called the meeting to adjourn for dinner at 5p.m. President Prokup called for the close of business at 7:40 p.m.

April 04, 2009 - Saturday

President Bonnie Prokup called the board to order at 9 a.m.

All Board members present.

New attendees from the Heritage Board included; Joe Scala, Mary Carmody, John Vidmar, Robert Kuehl and Tony Izzi.

Report provided by Jan King and Tony Palumbo regarding the newsletter and website.

IMPORTANT – PLEASE READ Financial Review for 2008

I know that reading about finances is not very interesting for most us, but it is very important that members are apprised of our financial condition. I am sure everyone is tired of hearing about the economy, but unfortunately we too have lost money on our investments. To make matters worse, our 100-year-old building is still in need of major repairs. We have recently discovered that if we do not repair the outside brick walls, the building is at risk because there are many voids in the mortar. If the walls get out of plumb, the price to repair triples. Therefore, we have no choice but to withdraw more money from our investments this year.

In addition to the Profit and Loss Statement and a Balance Sheet, I am also including two charts because I think it is easier to understand pictures! The pie chart shows our operating costs for 2008. It does not include our monthly withdrawals, renovation/building repair costs or the fees we are charged by the bank for managing the investments. The reason I made up this pie chart is to show that we are not taking in enough money to operate. Our operating costs exceed the amount we collect. In 2008 we collected a total of \$90,530.00 in dues, donations, miscellaneous and we disbursed \$130,471.00. For the past seven years, the only way we were able to just pay our normal operating costs was to withdraw \$3,000.00 a month from our Trust Fund. Another purpose for this chart is to alert you that at the next convention, we will have to vote to increase our annual dues. A dues increase is absolutely necessary if we are to survive. I also ask that you review the Excess Distribution over Earnings chart. In this chart you will see how we have withdrawn more than we have earned on the investments since 2003. Another problem which we have is that in accordance with the State of Illinois, we must have enough assets to cover our insurance obligation. We still have over 2,000 members who have small insurance policies. Therefore, we must be careful with our investment portfolio.

I apologize for this bleak report, but it is my belief that the membership must be aware of our financial situation. We need to possibly think about some type of fund raising activity, i.e., a raffle. Any other suggestions from the membership are welcome.





SLOVENIAN EDUCATORS in the NEWS

Dr. Ed Gobetz, Professor Emeritus of Sociology and Anthropology, Kent State has recently submitted a series of biographies on notable American Slovenes in recent editions of "Slovenian American Times". Dr. Gobetz has spent his life recording Slovenian immigrant histories, creating easy to follow American Slovenian language manuals, among many other publications. "Slovenian Heritage I, II, and III" and his beautifully written book of early Slovenian immigrants entitled "Anthology of Slovenian American literature" are a MUST READ! Contact your local library to order these through interlibrary loan.

During late June, Upper Michigan was delighted to welcome a busload of 50 students, parents and teachers of St. Mary's School, Collinwood, Ohio. At Traunik, Michigan, a small Slovenian early American settlement, they were hosted by Frank Bartol and had a great time trying out their accordions at the SNPJ Hall. Later that day they visited St. Peters Cathedral in Marquette visiting the crypts of the first three Slovenian Bishops of Upper Michigan. I was just thrilled to meet them at the local restaurant, after a long bus trip, such beautiful people! Slovenians all have a special manner that I can't describe. They visited the Baraga statue at L'Anse as well as a restored Baraga Mission Church on Keweenaw Bay. Their final destination was Calumet, a city of 100,000 people during the turn of the century when immigrant miners filled Calumet, many from Slovenia. They saw vividly hued stained glass windows glow in the old Slovenian Church of Calumet.

Father Vendalin Spendov OFM, born 1921 Slovenia, died on 1 July 2009 at Lemont, after decades spent teaching Slovenian liturgical music and sharing his talent at many Baraga Days Masses. He wrote a valuable history of Slovenian music and Slovenian organ music, published by the Ave Maria printers. Father traveled as a bus pilgrim even in his later years. Remembered well were the Baraga Day Masses held at old churches in Upper Michigan. Father Vendalin, playing those old pipe organs with gusto, dusting off keys that had not been touched in years. His music reflected the joy he felt as a devoted worker for our Lord and in honor of his hero, Frederic Baraga.

Featuring the Music, Language, Food and Dance of Slovenia. June 19-20, 2009


"Remember, only he is worthy of his Ancestors whose customs he honors".

This quote was found on the UWM (University of Wisconsin, Madison) Slovenian Arts Council web site.

It is certainly factual to say there was much "honor in the air" on June 19-20 at the Slovenian Heritage Museum and the Slovenian Catholic Center in Lemont. *Celebrate Zarja/Let's Feel Slovenia* became a 2 (dve) day engagement in heritage and tradition featuring the music, language, food and dance of Slovenia.

It began at St. Joseph Church with the magic flute of Margaret Koncar and the voices of Sonia Avuguštin and Andreja Vidmar of Slovenia performing a Slovenian hymn. Throughout the Mass, the musical trio answered to the call of Fr.

A God's Corner in a Slovenian home. Typical kiddy corner designed so that the elongated corpus leans into the room; an "altar cloth" with embroidered carnation design, the bouquet of carnations and the statues of Mary and Joseph.

Following the Mass, sessions were held at the Slovenian Heritage Museum. The opening session was by Yours Truly, a PPT on the tradition of God's Corner in Slovenian homes. Intrigued by this custom in Slovenia, I had been photographing this

unique custom on each trip to Slovenia. Today our homes are havens from the toils of the outside world, so all the more to name a place in our homes a "reflective corner". Jane Paley concluded this session with dialogue on her hobby that also has also become a time of private prayer and meditation. Jane constructs unique rosaries, using jewels of every size and color, and personalizes as to your desires!

Enter the sounds of the raglje, a wooden noisemaker, well known throughout Slovenia! Historically, church bells were silenced on the Feast of Corpus Christi and raglje from the church towers announced the beginning of Friday's fast. Today raglje have become popular at sport's events, especially ski jumping. Slovenians make as loud a noise as possible in support of their home country skiers! During the Celebrate Zarja, this same raglje was used as a call to order. When it was heard, there was silence!

Sonia and Andreja delighted the audience during the bee front and beekeeping session. "Today beekeeping is part of the fabric of Slovenian culture because it is one of the oldest and most traditional rural activities. In the days of no refined sugar, there was nary a farm in Slovenia that did not keep bees". In the 18th Century a unique folk art surfaced in Slovenia. Little wooden houses with colonies of Carniolan bees stacked under one roof became outdoor art galleries. The smooth fronts were ideal for creating

colorful scenes of historical events, Bible stories and village life. These colorful fronts became the guide that led bees back to their hives. As the beekeepers were mainly men,

the interpretation of the beehive paintings brought many a smile! Did you know that the goat was once considered the lowest of animals? Along with churches on hilltops and the hay racks, the bee fronts have also become one of Slovenia's cultural icons.

On Friday evening, the museum was transferred into a gostilna-like atmosphere. Author Jacqueline Widmar Stewart was present to sign her new publication: Finding Slovenia: A Guide to Old Europe's New Country.






Memories of Zarja Celebration

Zarjafest Gave Me the Opportunity to See Slovenian Community and Culture at its Best

My Slovenian grandparents met in a refugee camp shortly after World War II. My grandfather was forced to leave because the communists were threatening to kill him because of certain involvements he had at that time. They eventually settled in a small Slovenian community about 45 minutes north of Chicago in a city that was actually called North Chicago. My mother was born shortly thereafter, followed by two brothers and a sister. Because of the circumstances described above, both of my grandparents were the only members of their family to migrate to the United States. This meant that despite the fact that they settled in a small Slovenian community, the family (especially my mom and her siblings) was limited in its exposure to Slovenian culture because they did not have any grandparents, aunts or uncles, or cousins in this country. Then as typically happens when immigrants arrive to the U.S., whether it's changing last names, attempting to conceal accents and language, or exchanging old customs and traditions for new American customs and traditions, the pressure and desire to assimilate is very strong.

For me, being another generation removed from Slovenia, meant even less exposure and familiarity with Slovenian culture. Other than some broken Slovenian language






(mostly words associated with food) that my grandmother would mix in when speaking English, and some Slovenian foods (potica, blood sausage, cucumber salads) there was very little familiarity with Slovenian culture. Unfortunately, once the ethnicity and culture is scrubbed from the family or the community, it is often difficult if not impossible to re-acquire or re-saturate back into the family or community. But attending the 80th Anniversary Zarjafest gave me the opportunity to see Slovenian community and culture at its best. I loved hearing the accents and the words of the Slovenian language. Although not always recognizable or understood, if I closed my eyes and listened I could see the faces of my deceased grandparents as if they were the ones actually speaking.

I also loved the distant familiarity of the smells and tastes of Zarjafest. Many of the delicious foods served were ones that I had not smelled or tasted since childhood when we would wait for my grandfather to arrive from Chicago with sausages or when I would watch my grandmother cook in the kitchen.

But most of all I enjoyed the warmth and sense of community that was on display by people of all generations. Children and teenagers were in attendance (and having fun) not because their parents made them come, but because they enjoyed being there. Great-grandparents were there dancing and reminiscing with fellow Slovenians about friendships that spanned many, many decades. And people of all ages celebrated the proud history and heritage of a beautiful country and culture.



Our Secrets of Slovenia By Joan Kaczmarek

Hearing the stories of the beauty of Slovenia from my grandmother, Magdalen Persa, I always dreamed of visiting there some day. When I read the *Zarja* magazine was celebrating its 80th anniversary with a tour of Slovenia, I mentioned it to my brother Wayne Krempach and he said "Let's go!"

We began making our travel arrangements. Coincidently, a cousin Frank Vouri, contacted me with names and addresses of relatives he met on an earlier visit to Slovenia. I took a chance, wrote a letter, and sent it to our cousin Ivan Krampac in Slovenia, not knowing if the letter would reach him. If it did would he be able to answer my letter in enough time.

After meeting our tour director Manja Lilek in Slovenia, we gave her all the information that we gathered about our family. Manja made calls on our behalf. One of the names on the list was Marta Cvetko. Manja spoke to Marta's son Josef. He told Manja that the Krampac house had been sold, the family moved, and other relatives were deceased. Josef also mentioned that his mother was on a trip. Needless to say Wayne and I were disappointed. We thought this was the end of our search.

On Thursday, May 14, 2009, we made several tour stops. At one of the stops Manja said she saw a touring bus from Prekmurje. She said that it was unusual for people from the Prekmurje area to travel this far. We spoke to the bus driver, giving him several family names and asked if any of them could be on the bus. The answer was no.

Manja mentioned that we will be having lunch at a restaurant that was not on the tour schedule, but she thought we would really enjoy it. After a few stops we arrived at our lunch destination. What a coincidence, we saw the same bus we had seen earlier. Manja had a feeling that she should talk to the tour bus driver again. She recalled that Jozef said his mother was on a trip. We asked the bus driver if Marta Cvetko was a tourist on the bus. He said yes that she was in the restaurant. He went in and told Marta that cousins from the U.S.A. were outside. Marta came out followed

by some fellow travelers asking if cousins of theirs might be on our bus. We met, we cried, we hugged, and we kissed. Manja cried too. Manja interpreted Marta's conversation for us saying Marta thought she could find some of our relatives. We would meet the next day in Jerusalem. Our trip Friday was exciting. Waiting for us at the meeting place was our cousin Marta, her son Jozef, Ivan Krampac and his wife Ana. I immediately understood every word they said. They spoke in a Prekmurje dialect. Everyone spoke at the same time and there were a lot of hugs and kisses. Manja interpreted for us again because we could not speak the language. Wayne and I were so thrilled. One of our objectives was to make contact with our family. With the help of Manja we were able to fulfill a dream. We shared a whole life time in a two hour visit. Our dream trip came true.



Jenka's Taste of Slovenia

For as long as I can remember growing up, from the time I was big enough to see out the window of our family sedan, my mother and father would take my younger brother, Mark, and I out on drives through the country each spring in search of the prized tender young asparagus that grew along the roadside. It was such a huge part of my childhood that I eventually found it to be an activity that I actually wanted to do rather than one that I was forced to do by parental requirement. Asparagus hunting was a skill that I honed over many of my young years by keeping my "eyes peeled" as my dad used to say. Being able to spot the shoots among the tall spring grasses brought both praise and pride from my mom and dad as the acquisition of the ever growing bundle of the beautiful green spears brought about their great delight. It was also a great source of competition between my brother and I as we raced to see who could find the most and the nicest of the spears. I got so good at it that I could spot it growing while we traveled down the road at 60 miles an hour. I can't tell you how many times I made my dad back up down the road because I was sure that I had spotted asparagus that was worthy of our stopping. I was rarely, if ever, wrong. (This is something, which years later, amazed my husband, Tym, who thinks I have a great hidden talent and wanted to learn how to "hunt" himself.) Over time I actually even grew to like to eat the fresh green vegetable that my mother hurriedly prepared for dinner the minute we got home. I now make a mean roasted asparagus myself that we eat throughout the spring, as long as I can still find the time and places to hunt. Like many things that have changed with time, it is harder to find the wild stalks as country roads give way to paved highways and farmers move their fields out to the outer edges of their easements or, even sadder yet, the farms disappear altogether. Soon there will be no further places to search and I will have lost a time honored family tradition. One that gives me great peace of mind as I walk the quiet old country roads alone on a bright June morning looking for the lush green spring vegetable that will provide nourishment for my body and spirit. If I'm lucky on my hunt, I may even call my mom and dad to boast about my find-bringing a smile to each of us as we remember the joy of success and times spent together as a family.

When I was a child, my grandmother (Slovenian, of course) used to go mushrooming in the woods around her home and I always found this to be a kind of a mystical activity that I also wanted to learn to do. The thought of walking through the quiet, damp, plush green woodlands

where fairies and deer might appear seemed both ancient and magical somehow. My parents, however, were not mushroomers so I was limited in these experiences as well as the scope of my vegetable hunting abilities. Like many skills, they are best taught at an early age and require time and experience to perfect. So I never was taught the skills necessary to find and pluck the beautifully camouflaged little nuggets from the floors of the forest. As an adult I was determined that I could



and would learn how and where to find mushrooms. But like asparagus hunters, mushroom hunters take the secrets of their stealthy practices and coveted "spots" to the graveso getting help is like trying to get blood from a turnip. (I'm sure the vegetable cliché is not lost on you here.) I tried going out on my own, but was rarely rewarded with a find and frequently shooed off some farmer's property. With the help of a proficient and tolerant friend I had some limited success but really had to be led to the precise spot since I somehow lacked the kind of trained "eye" needed to scan the ground and spot them from a distance. Asparagus skills simply didn't translate themselves to this kind of hunting and I didn't have that innate sixth sense needed to lead me to the treasure. I was so disappointed but resolute that I would not give up.

Luckily, I didn't have to. I was fortunate enough to travel to Slovenia last year, (as you well know by now) and, along with my fellow Zarja staffers, stayed with one of our author's (Jana Bauer's), mother, Marija Bauer. She lives in a very small village, Laze, which is nestled in the mountains that wind their way along the Croatian border. Laze is so small and tucked away that it only has four



people who continue to reside there throughout the year. In the summers its numbers swell to a bustling seven. Brown bear still clumber down the mountain to forage for food among the old homes that dot the countryside and we were visited by a bear on one quiet sunny morning after the rains gave way. He didn't bother anyone and was on his way as soon as the early morning gave way to the activities of Marija and her fellow Lazeans. Marija's life is simple and requires lots of hard work and age-old knowhow. She has a very large garden that she tends by herself, bees and fruit trees that she relies on for sweet treats and she supplements her pantry with the gifts bestowed upon her by the lands and woods that surround her home. One of our first evenings there was spent sitting around the outdoor table shelling different kinds of dried beans from the garden and cracking nuts that were gathered from the

nearby woods. On one of the following days we went to the large and well-tended garden to harvest vegetables that we would prepare later that day for supper. When a speedy, dare-devil of a driver, Jana hit one of the neighbors chicken out in the road that led to Marija's home, she purchased it for our evening meal and we all came down to watch the chicken being plucked and cleaned in the nearby stream. Much of the food that we ate while with Marija would be fresh, home grown or raised, foraged or found and hand prepared. This is something for which I have great respect and admiration and something we, in the United States are just beginning to embrace again in the "Slow Food Movement" that is becoming popular throughout the country. I love to cook and this way of life was one I enjoyed being a part of.

And then one day in Laze it happened!!! I finally got my chance...On a beautiful fall day Marija decided that we

would go and look for mushrooms along the rolling creek that wove through the land around us. She knew a couple of reliable spots and showed us what to look for and where to best find them. Unlike my previous teachers she was willing to share her knowledge and despite our limited ability to communicate (Marija doesn't speak English and I don't speak Slovenian- although she is much better at English than I am with Slovenian) she taught me more that morning than I had ever learned before. So together with Marija and my fellow Zarja sisters we set out to find ourselves enough mushrooms to feed us all. I think that long-ago competitiveness I had with my brother kicked in, and, along with my resolve to learn how to mushroom hunt, I was determined that I could find the ever elusive mushroom.

I separated from the group a bit and put all my new-found knowledge to work. After a few failed attempts I finally found the mother load of mushrooms. It was a large bunch-I'm not kidding- and so I excitedly called out to Marija, just like I used to yell out to my dad. When she finally came to confirm that they were indeed the kind we could eat I was beaming with pride. We took them home and had them for lunch with freshly scrambled eggs. Between what Marija found and my own batch, there were enough to feed all ten of us. Now, with a good score under my belt, I may not be able to call myself a competent mushroomer, but I still might be able to spend a day in the solitude of the woods and enjoy the peace and joy of finding enough to bring home for supper. If I do, I might even call home to mom and dad to tell them about it.

WILD MUSHROOMS AND EGGS

2 pounds wild mushrooms

3-4 tablespoons sunflower oil

3 cloves minced garlic

4 tablespoons chopped parsley

2 eggs

1/3 cup sweet cream

Salt

Pepper

Sauté the mushrooms in the oil. After a few minutes add the garlic and continue sautéing until they are cooked through. Beat the eggs and cream together. Add the parsley to the mushrooms and sauté for 1 minute more. Add the egg and cream mixture and salt and pepper to taste. Serve with parsley as a garnish.

Another option would be to sauté the wild mushrooms in butter and onions which can then be used to put over steak or on a hamburger.
