13 CITY OF CLEVELAND PROPOSED CHARTER AMENDMENT Section 21-1 LIMITATION ON RATE OF TAXATION
A majority affirmative vote is necessary for passage. VOTE BALLOT WITH AN "X"

Shall the Charter of the City of Cleveland be amended by amending Section 21-1 to read as herein set forth.
The amendment, if approved by a majority of the electors voting thereon at a special election to be held November 6, 1956, which is also the time of voting at the general election, shall take effect and be in force as of the date of the certification to the Secretary of State by the Board of Election as provided by law, for the purpose of fixing the tax rates upon the duplicate for the years 1956, 1957 and 1958 (the purpose of the Charter for the years 1956, 1957 and 1958) and for every year thereafter, and Section 21-1 of the present Charter shall thereby be repealed.

LIMITATION ON RATE OF TAXATION FOR CURRENT OPERATING EXPENSES
"Section 21-1. The rate of tax for current operating expenses and for the purpose of any other expense, including the purpose of police and fire services, which may lawfully be included within the general levy for the general fund of the city, levied for the purposes of the years 1956, 1957 and 1958 upon the 1956, 1957 and 1958 duplicate of property in the City of Cleveland shall not exceed for taxation according to value, shall not exceed twelve and fifty-one hundredths (12.51) mill per dollar of assessed valuation.
"Notwithstanding the power of Council without a vote of the people to levy taxes for the purpose of operating the present Charter, the rate of tax for current operating expenses and for the purpose of any other expense, including the purpose of police and fire services, which may lawfully be included within the general levy for the general fund of the city, shall not exceed eight and thirty-five hundredths (8.35) mill per dollar of assessed valuation.
"The limitation of the Charter upon the power of Council to levy taxes shall not operate as a limitation upon the power of Council to levy taxes upon such other subjects and for such other purposes as may be lawfully levied under the Constitution and laws of this State.
