STATISTIKA GRADBENIH DOVOLJENJ ZA STAVBE, SLOVENIJA, 3. ČETRLETJE 2004

STATISTICS OF BUILDING PERMITS, SLOVENIA, 3RD QUARTER 2004

- ▶ V tretjem četrletju letos je bilo v Sloveniji za gradnjo stavb izdanih 1 495 gradbenih dovoljenj, kar je le za 70 dovoljenj več kot v drugem četrletju.

V prvih devetih mesecih letos je bilo izdanih za 4 % manj gradbenih dovoljenj kot v enakem obdobju 2003, skupna površina vseh načrtovanih stavb pa je bila za 8 % večja.

- ▶ Večina gradbenih dovoljenj (95 %), izdanih v tretjem četrletju letos, se je nanašala na nove stavbe, med temi pa so prevladovala stanovanjske – bilo jih je 967 ali 68 % celotne nove gradnje. To razmerje je bilo podobno tudi v drugem četrletju.

- ▶ V tretjem četrletju letos je bila, z izdajo gradbenih dovoljenj predvidena gradnja 2 330 novih stanovanj ali za 75 % več kot v enakem obdobju lani. 63 % predvidenih novih stanovanj bo v večstanovanjskih stavbah.

- ▶ In the third quarter of 2004 there were 1,495 building permits issued in Slovenia, i.e. 70 building permits more than in the second quarter of 2004.

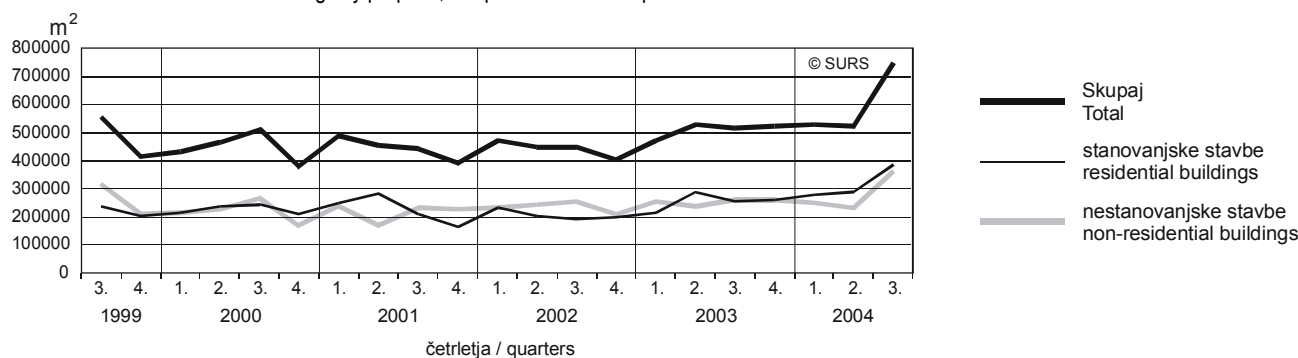
In comparison with the first nine months of 2003, 4% less building permits were issued than in 2004. The total floor area of planned buildings increased by 8%.

- ▶ In the third quarter of 2004, 95% of building permits were issued for new buildings, most of them for residential buildings (967 or 68% of all new buildings). The ratio between residential and non-residential buildings was similar in the second quarter of 2004.

- ▶ In the third quarter of 2004 construction of 2,330 new dwellings was planned, which is 75% more than in the third quarter of last year. 63% of dwellings are in multi-dwelling buildings.

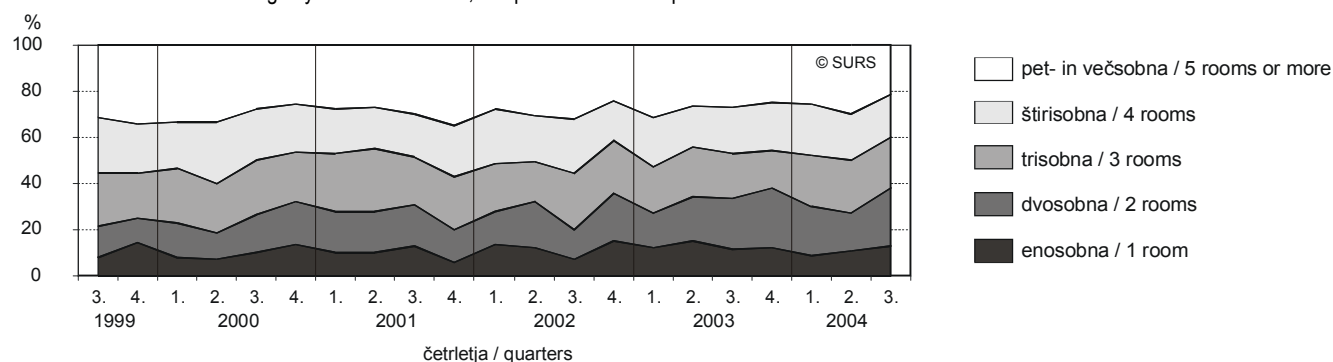
Slika 1: Površina novih stavb po namenu, 3. četrletje 1999 - 3. četrletje 2004¹⁾

METODOLOŠKA POJASNILA

Namen statističnega raziskovanja

je pridobitev statističnih podatkov o gradbeni dejavnosti za stavbe na osnovi gradbenih dovoljenj, ki jih je izdal upravni organ. Vsako izdano dovoljenje spremljamo posebej.

Podatki so pomembni za:

- statistično spremljanje kratkoročnega gibanja v gradbeni dejavnosti,
- pregled nad posegi v prostor,
- poslovno odločanje v gradbeni dejavnosti in z njo povezanih dejavnostih industrijske proizvodnje,
- mednarodne primerjave.

Enote opazovanja

so vse stavbe, za katere je upravna enota izdala gradbena dovoljenja. Razvrščanje gradbenih objektov na stavbe in gradbene inženirske objekte opredeljuje klasifikacija, ki je bila sprejeta z Uredbo o uvedbi in uporabi enotne klasifikacije vrst objektov in o določitvi objektov državnega pomena (Uradni list RS, št. 33/03). Enotna klasifikacija vrst objektov (CC-SI) temelji na klasifikaciji Classification of Types of Constructions (CC), ki se uporablja v Evropski uniji, in je izvedena iz nje.

Viri

Podatke pridobimo na osnovi mesečnega raziskovanja *Poročilo o dovoljenju za gradnjo stavbe (GRAD-PGD/M)*. Raziskovanje izvajamo od leta 1998. Vir podatkov je dokumentacija projekta za pridobitev gradbenega dovoljenja, s katero razpolaga oddelek za okolje in prostor v okviru upravnega organa.

Zajetje

V to statistično raziskovanje so zajete vse stanovanjske in nestanovanjske stavbe, za katere je v opazovanem obdobju upravna enota izdala gradbeno dovoljenje (za novogradnjo, povečavo ali spremembo namembnosti). Pri povečavah stanovanjskih stavb ne upoštevamo prizidave sobe ali pomožnega prostora.

Definicije in druga pojasnila

Gradbeno dovoljenje za stavbo je odločba, s katero pristojni upravni organ dovoli gradnjo in s katero predpiše konkretne pogoje, ki jih je treba pri gradnji upoštevati.

Stavba je objekt z enim ali več prostorov, v katere človek lahko vstopi in so namenjeni bivanju ali opravljanju dejavnosti.

Stanovanjska stavba je stavba, od katere se vsaj polovica uporabne površine uporablja za bivanje.

Nestanovanjska stavba je stavba, od katere se več kot polovica uporabne površine uporablja za opravljanje dejavnosti.

Novogradnja ali povečava je gradnja novega objekta ali dozidava (nadzidava) že obstoječega objekta, s katero se bistveno spremeni njegov zunanji izgled. Nadomestno gradnjo štejemo za novogradnjo.

Sprememba namembnosti je posledica izvedbe del, s katerimi se spremeni raba celega objekta ali dela objekta tako, da se z njo spremeni vpliv objekta na okolico, vendar pri tem ne gre za gradnjo.

Površina stavbe obsega vsoto površin vseh etaž stavbe, ki jo določa veljavni tehnični predpis.

METHODOLOGICAL EXPLANATIONS

The purpose of the statistical survey

is to obtain statistical data on construction activity for buildings on the basis of building permits issued by the administrative body. Each permit is followed separately.

Data are important for:

- statistical monitoring of short-term changes in the construction activity,
- review of interventions into living space,
- business decision-making in construction and related industrial production activities,
- international comparisons.

Observation units

are all buildings for which the administrative unit issued building permits. Classification of constructions into buildings and civil engineering works is determined by the classification adopted with the Decree on the Introduction and Application of the Classification of Types of Constructions and Determination of Constructions of National Importance (OJ RS No. 33/03). The Slovene Classification of Types of Constructions CC-SI is based on the Classification of Types of Constructions (CC) used in the European Union.

Sources

Data are obtained with monthly surveys *Report on Building Permits (GRAD-PGD/M)*. The survey has been carried out since 1998. The source of data is the project documentation for obtaining the building permit, which is available at the department for environment and spatial planning within the administrative body.

Coverage

This statistical survey covers all residential and non-residential buildings for which the administrative unit issued a building permit in the observed period (for new construction, extension and conversion-improvement). At extensions of dwellings we do not take into consideration extension of room or utility space.

Definitions and other explanations

Building permit is a decision with which the authorised administrative body allows construction and with which it prescribes concrete conditions that have to be taken into consideration.

Buildings are structures with one or more rooms into which a person can enter and are intended for residence or for performing an activity.

Residential buildings are buildings at least half of which is used for residential purpose.

Non-residential buildings are buildings more than half of which is not used for residential purpose.

New construction or extension is construction of a new building or extension of an already existing building with which its appearance is considerably altered. Replacement construction is new construction.

Conversion-improvement is execution of works that are not construction but the use of the entire building or a part of it is changed so that the impact of the building on the surrounding area is changed.

Floor area of buildings is the sum total of floor area of all storeys of the building defined by the valid technical regulation.



Prostornina stavbe obsega vsoto prostornin vseh etaž stavbe, ki jo določa veljaven tehnični predpis.

Stanovanje je vsaka gradbeno povezana celota, ki je namenjena za nastanitev in ima eno ali več sob z ustreznimi pomožnimi prostori (kuhinja, shrambo, kopalnico, straniščem) ali je brez njih ter ima vsaj en poseben vhod.

Rezultati o številu stanovanj so prikazani drugače kot v prejšnjih objavah, in sicer po metodologiji iz leta 2002, po kateri so upoštevana tudi tista stanovanja, ki se uporabljajo le občasno (počitniška stanovanja). Ne upoštevamo pa stanovanj v stavbah za posebne namene (kot so npr. domovi za ostarele, študente, delavce itd.).

V **površini stanovanja** je upoštevana uporabna površina sob, kuhinje in drugih pomožnih prostorov, površina zaprtih teras in verand ter površina pod vgrajenimi omarami. Površine kleti, podstrešij (neprimernih za stanovanje) ali skupnih prostorov v večstanovanjskih stavbah niso upoštevane.

Soba je prostor, ki je s stalnimi stenami ločen od drugih stanovanjskih prostorov, ima neposredno dnevno svetlobo in meri najmanj 6 m². Kuhinja ni všteta v število sob.

Pojasnilo

Začasne četrtnete podatke objavljamo po datumu prejema gradbenega dovoljenja. Pri končnih podatkih upoštevamo uradni datum izdaje dovoljenja.

Statistične informacije

Volume of buildings is the sum total of the volume of all storeys of the building defined by the valid technical regulation.

A **dwelling** is any structurally unified unit intended for residence, with one or more rooms, with or without appropriate utility spaces (kitchen, larder, hallway, bathroom, toilet) and with at least one separate entrance.

In contrast to previous issues, results are shown according to the 2002 methodology which takes into account dwellings used only occasionally (e.g. holiday homes). Dwellings in collective accommodation facilities (e.g. old people's homes, student residence, etc.) are not taken into consideration.

The **useful floor area of a dwelling** covers the usable area of the rooms, kitchen and other auxiliary interiors, the area of enclosed terraces and verandas, and the area enclosed by fitted cupboards. The areas of cellar, attic (unfit for a dwelling) and collective areas in apartment houses are not taken into consideration.

A **room** is an interior space separated from others by permanent walls, which receives direct daylight and has an area of at least six square metres. The kitchen is not counted as a room

Explanation

Provisional quarterly data are published by the date of the receipt of the building permit. In publishing the final data we take into consideration the official date of the issue of the building permit or safety permit.
