FEES DUE TO NOTARIES AND STOCK-BROKERS AUTHORIZED TO PERFORM PUBLIC DEBT OPERATIONS

WHEREAS it is deemed advisable to establish the amount of the fees due to notaries and stock-brokers authorized to perform public debt operations, in that part of the Free Territory of Trieste administered by the British-United States Forces,

NOW, THEREFORE, I, JOHN L. WHITELAW, Brigadier General U. S. Army, Director General, Civil Affairs,

ORDER:

ARTICLE I

For authentications of signatures on „declarations of consent“ received by the Public Debt Administration, and „Sovrintendenza di Finanza“, the notary or stock-broker making such authentication shall be entitled to a fee of Lire 5 on every Lire 1,000 of nominal capital of the „Rendita“ to which the consent refers.

The said fee shall not be less than Lire 50 nor more than Lire 1,000.

ARTICLE II

Article 206 of the General Regulations concerning the Public Debt, as approved by R.D. 19 February 1911, No. 298, is hereby repealed.

ARTICLE III

This Order shall become effective on the date of its publication in the Official Gazette and, pursuant to the administrative instructions already issued, shall be operative as from 8 February 1952.

AMENDMENT TO ORDER No. 137/1950 ROLL OF CONTRACTORS OF PUBLIC WORKS

WHEREAS it is deemed advisable to amend Article II of Order No. 137 dated 11 July 1950 concerning the Roll of contractors of public works in that part of the Free Territory of Trieste administered by the British-United States Forces,

NOW, THEREFORE, I, JOHN L. WHITELOW, Brigadier General U. S. Army,
Director General, Civil Affairs,

ORDER:

ARTICLE I

Section 1. — The second paragraph, of Article II of Order No. 137 dated 11 July 1950, is hereby cancelled and substituted by the following:

„The classification in respect of such financial and technical capacity is hereby established as follows:

„a) for an amount up to	5,000,000	Lire
„b) for an amount up to	15,000,000	„
„c) for an amount up to	25,000,000	„

Section 2. — The eleventh paragraph, of Article II of Order No. 137 dated 11 July 1950, is hereby cancelled and substituted by the following:

„The aforesaid inscriptions shall be subject to an annual Government concession tax „at the following rates:

„a) for inscription amount up to	5,000,000 L.	2,500 L. tax
„b) for inscription amount up to	15,000,000 „	5,500 „ „
„c) for inscription amount up to	25,000,000 „	8,500 „ „
„d) for inscription amount up to	40,000,000 „	12,000 „ „

SUBSTITUTION OF A MEMBER OF THE COMMISSION FOR THE GRANTING OF WAGES SUPPLEMENTATION TO WORKERS IN INDUSTRY

WHEREAS Eng. Giulio Fattorini, Chief, Labor Inspectorate, was by Administrative Order No. 12, dated 23 February 1951, appointed permanent member of the Commission, provided for in Article VIII, Section 1, of Order No. 67, dated 28 November 1947, with jurisdiction to decide on the granting of the supplementation of wages to workers in industry ;

WHEREAS Eng. Giulio Fattorini has reached the age limit and it is now necessary to relieve him from his functions and to appoint a new member of the Commission in his stead.

ESTABLISHMENT OF A TECHNICAL-MEDICAL SPECIAL COMMISSION FOR THE BUILDING UP OF THE ISTITUTO NAZIONALE DELLA PREVIDENZA SOCIALE ANTI- TUBERCULAR HOSPITAL

WHEREAS it is deemed advisable to appoint a Special Commission to examine and solve the technical-medical and administrative problems arising or which will arise in connection with the construction in Trieste of the new Istituto Nazionale della Previdenza Sociale Anti-tubercular Hospital,

NOW, THEREFORE I, VONNA F. BURGER, Colonel Arty, Executive Director to Director General, Civil Affairs,

ORDER:

1. — A technical-medical Special Commission is hereby established at the Istituto Nazionale della Previdenza Sociale in connection with the construction of the new Istituto Nazionale della Previdenza Sociale Anti-tubercular Hospital in Trieste.

2. — The Special Commission is hereby charged with the examination and solution of all technical-medical problems affecting the planning and examination of the project for the construction of the said Hospital, as well as all question of an administrative nature connected therewith.

3. — The following persons are hereby appointed as members of the Special Commission:

- dott. Luigi Farci, Inspector of Istituto Nazionale della Previdenza Sociale President ;
- dott. Valentino Graziadei, Provincial Physician, member ;
- dott. Renato Semizzi, medical Director of the „Consorzio Provinciale Antitubercolare“ member ;
- Eng. Massimo Levi, Chief Engineer of the Office of „Genio Civile“ . member ;
- dott. Albino Bocceai, representative of the Public Health Office of the Department of Interior, Allied Military Government member.

The President of the Special Commission is empowered to enlist the services of officials of the Technical Office of the Istituto Nazionale della Previdenza Sociale Inspectorate and/or other persons competent in the technical and medical field to aid them in solving any special problems.

An official of the said Inspectorate, designated by the President, shall act as secretary to the Special Commission.

4. — The Special Commission shall hold an ordinary meeting at least once every two months. The President may call extraordinary meetings when deemed necessary by him or when so requested by two members at least of the Commission.

The resolutions of the Special Commission, shall be valid provided that the President and two members at least are present, and the resolution has been passed by a majority of votes. In case of even vote, the President's vote shall prevail.

The minutes of the meetings shall be kept by the secretary who shall forward one copy to the Department of Social Assistance, Allied Military Government.

5. This Order shall become effective on the date it is signed by me.
